Assembly Bill 199: Revises provisions relating to fights between animals. (BDR 50-717)

The full Committee first considered the bill on Monday, March 2, 2009, and again on Wednesday, March 4, 2009. For the record, the Minority Leader, Assemblywoman Heidi S. Gansert, is present at this hearing.

Assemblywoman Heidi S. Gansert, Washoe County Assembly District No. 25: Did you want me to testify, or do you want me to answer questions?

Chair Ohrenschall:

I think we are all comfortable with the bill since you provided us the information in *Nevada Revised Statutes* (NRS) 202.500. Does this Subcommittee agree on that? [The Subcommittee members nodded in assent.]

Assemblywoman Heidi S. Gansert:

The bill's language is purposely and specifically focused on animals for fighting, and that is the purpose of this legislation. The NRS I provided for you covers dangerous and vicious dogs, so I do not think this bill's language will be conflicting or overreaching. If we were to change the language, I would be concerned about providing loopholes in the legislation.

Chair Ohrenschall:

If there are no concerns, I will entertain a motion.
