Chair Morse Arberry Jr. indicated that it was necessary to vote out several Senate bills. Mark Stevens, Assembly Fiscal Analyst, discussed the proposed amendment (No. 999) to Senate Bill 143 (R1) which provided a \$500,000 General Fund Appropriation to the Interim Finance Committee to pay costs relating to the implementation of legislation concerning state revenue enacted during the 75th Legislative Session.

Senate Bill 143 (1st Reprint): Creates the Legislative Committee for Federal Stimulus Oversight to oversee the use of money allocated to the State from the Federal Government to stimulate the economy. (BDR S-1034)

ASSEMBLYMAN CONKLIN MOVED TO AMEND AND DO PASS
S.B. 143 (R1).

ASSEMBLYMAN HOGAN SECONDED THE MOTION.

THE MOTION PASSED UNANIMOUSLY.

Senate Concurrent Resolution 37: Provides for the Interim Finance Committee to conduct a review of Nevada's revenue structure and to provide long-term stabilization of revenue. (BDR R-1334)

Mr. Stevens discussed the proposed amendment (No. 1006) to S.C.R. 37 with committee members which eliminated Interim Finance Committee access to the Contingency Fund to pay for a consultant to review the state's revenue structure.

ASSEMBLYWOMAN KOIVISTO MOVED TO AMEND AND ADOPT S.C.R. 37.

ASSEMBLYMAN CONKLIN SECONDED THE MOTION.


