A.B. 402	Requires a state agency to enter into or participate in a contract to allow it to accept credit cards, debit cards or electronic transfers of money to the agency unless it is impracticable for the agency to do so. (BDR 31-968)
<u>A.B. 403</u>	Requires the adoption of certain permanent regulations. (BDR S-974)
A.B. 404	Revises provisions regarding properties purchased or leased for use by the State. (BDR 27-381)
A.B. 430	Revises provisions governing aliens unlawfully present in the United States. (BDR 14-79)
