SUMMARY—Revises provisions relating to the hours of operation of state offices. (BDR 23-422)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to State Government; deleting the provisions that require the offices of all state officers, departments, boards, commissions and agencies to remain open during a certain period; requiring such offices to post their days and hours of operation; requiring advance notice of any change in days or hours of operation; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Under existing law, the offices of all state officers, departments, boards,
2 commissions and agencies are required to be open for business at least from 8 a.m.
3 to 12 p.m. and from 1 p.m. to 5 p.m. every day except Saturdays, Sundays and legal
4 holidays, unless otherwise required for the efficient transaction of business and the
5 convenience of the persons with whom business is transacted. Any of those offices
6 that are staffed by more than one person are also required to remain open during the
7 noon hour of each working day. (NRS 281.110) **Sections 1-6** of this bill delete the
8 requirement that those offices remain open during those hours. **Section 1** requires
9 additionally that the days and hours of operation of the office be posted at the
10 office. **Section 1** further provides that, if the days or hours of operation of the office
11 change, the new days and hours of operation must be, at least 30 days before the
12 change becomes effective: (1) posted at the office; (2) posted on the website of the
13 office, if any; or (3) otherwise noticed publicly.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 281.110 is hereby amended to read as follows:

10 2. Variable workweek scheduling may be required in those
11 agencies where coverage is needed on Saturdays, Sundays and legal
12 holidays or on other days or during other hours, as necessary.

13 3. The offices of all state officers, departments, boards,
14 commissions and agencies ~~[that are open on the days and during the~~
15 ~~hours set forth in paragraph (b) of subsection 1 must remain open~~
16 ~~during the noon hour of each working day if any such office has~~
17 ~~more than one person on its staff.]~~ *must physically post the days*
18 *and hours of operation at the office. If the days or hours of*
19 *operation for the office change, the new days and hours of*
20 *operation must be:*

- 21 (a) *Posted physically at the office;*
22 (b) *Posted on the website of the office, if any; or*
23 (c) *Otherwise noticed publicly,*
24 ↪ *at least 30 days before the change becomes effective.*

25 **Sec. 2.** NRS 321.030 is hereby amended to read as follows:

36 **Sec. 4.** NRS 532.070 is hereby amended to read as follows:

5 ~~business during the hours and on the days established pursuant to~~

7 **Sec. 6.** Section 2 of chapter 169, Statutes of Nevada 2009, at
8 page 617, is hereby amended to read as follows:
9 Sec. 2. This act becomes effective on July 1, 2009 . ~~[~~
10 ~~and expires by limitation on June 30, 2011.]~~
11 **Sec. 7.** 1. This section and section 6 of this act become
12 effective upon passage and approval.
13 2. Sections 1 to 5, inclusive, of this act become effective on
14 July 1, 2011.
