

ASSEMBLY BILL NO. 47—COMMITTEE ON TAXATION

(ON BEHALF OF THE CITY OF FERNLEY)

PREFILED DECEMBER 14, 2010

Referred to Committee on Taxation

SUMMARY—Requires a base adjustment in the formula for the allocation of certain consolidated tax revenue and an interim legislative study of the current allocation formula. (BDR S-315)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to taxation; increasing the base allocation from the Local Government Tax Distribution Account to the City of Fernley; directing the Legislative Commission to appoint a subcommittee to conduct an interim study of the formula for the allocation of money distributed from the Account; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the deposit of certain proceeds from liquor taxes,
2 cigarette taxes, real property transfer taxes, city-county relief taxes and
3 governmental services taxes into the Local Government Tax Distribution Account.
4 (NRS 369.173, 370.260, 375.070, 377.055, 377.057, 482.181) Under existing law,
5 the Executive Director of the Department of Taxation is required to allocate the
6 money in the Account to local governments, special districts and enterprise districts
7 in accordance with a mathematical formula. (NRS 360.680, 360.690)

8 **Section 1** of this bill increases the base annual allocation from the Local
9 Government Tax Distribution Account to the City of Fernley by \$5 million.

10 **Section 3** of this bill requires the Legislative Commission to appoint a
11 subcommittee to conduct an interim study to examine whether the current formula
12 for the allocation of money from the Local Government Tax Distribution Account
13 is equitable and, if not, to consider possible alternative methodologies to achieve a
14 more equitable allocation.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** For the fiscal year beginning on July 1, 2011, the
2 Executive Director of the Department of Taxation shall increase the
3 amount that would otherwise be allocated to the City of Fernley
4 pursuant to NRS 360.680 by \$5,000,000, and that amount must be
5 included in the calculation of all future allocations.

6 **Sec. 2.** The Legislature hereby finds and declares that the
7 provisions of section 1 of this act are necessary to correct certain
8 discrepancies in the formula for the distribution of certain revenues
9 set forth in section 35 of chapter 660, Statutes of Nevada 1997, as
10 that formula relates to the region of this State encompassed
11 generally by Lyon County and the unique patterns of growth that
12 exist in that region, and therefore a general law cannot be made
13 applicable.

14 **Sec. 3.** 1. The Legislative Commission shall appoint a
15 subcommittee, consisting of three members of the Senate and three
16 members of the Assembly, to conduct a study during the 2011-2013
17 interim concerning the formula for the allocation of money
18 distributed from the Local Government Tax Distribution Account.

19 2. The subcommittee appointed pursuant to subsection 1 shall,
20 without limitation:

21 (a) Review the structural components of the current formula
22 used for the allocation of money distributed from the Local
23 Government Tax Distribution Account to local governments, special
24 districts and enterprise districts; and

25 (b) Examine whether the current formula results in an equitable
26 allocation among those governmental entities and, if not, consider
27 possible alternative methodologies to achieve a more equitable
28 allocation among those governmental entities.

29 3. Any recommendations for legislation proposed by the
30 subcommittee must be approved by a majority of the members of
31 the Senate and a majority of the members of the Assembly
32 appointed to the subcommittee.

33 4. The Legislative Commission shall submit a copy of the final
34 written report of the study and any recommendations for legislation
35 to the Director of the Legislative Counsel Bureau for transmittal to
36 the 77th Session of the Nevada Legislature.

37 **Sec. 4.** This act becomes effective on July 1, 2011.
