

ASSEMBLY BILL NO. 498—COMMITTEE ON WAYS AND MEANS

(ON BEHALF OF THE DIVISION OF BUDGET AND PLANNING)

SUMMARY—Eliminates the requirement for the administration of norm-referenced examinations in public schools. (BDR 34-1174)

AN ACT relating to education; eliminating the requirement for the administration of norm-referenced examinations in public schools; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the board of trustees of each school district and the
2 governing body of each charter school to administer norm-referenced examinations
3 in grades 4, 7 and 10 which compare the results of pupils enrolled in those grades in
4 public schools in this State to a national reference group of pupils. (NRS 389.015)
5 Senate Bill No. 416 of the 2009 Legislative Session suspended temporarily the
6 administration of the norm-referenced examinations for the 2009-2011 biennium.
7 (Chapter 423, Statutes of Nevada 2009, p. 2340) This bill eliminates the statutory
8 requirement for the administration of norm-referenced examinations and revises
9 existing law to delete references to the norm-referenced examinations.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 385.34692 is hereby amended to read as
2 follows:
3 385.34692 1. The State Board shall prepare a summary of the

5 that includes, without limitation, a summary of the following

5 (1) Who are economically disadvantaged, as defined by the
6 State Board;

7 (2) Who are from major racial or ethnic groups, as defined
8 by the State Board;

9 (3) With disabilities;

10 (4) Who are limited English proficient; and

11 (5) Who are migratory children, as defined by the State
12 Board;

13 (b) The average daily attendance of pupils, reported separately
14 for the groups identified in paragraph (a);

15 (c) The transiency rate of pupils;

16 (d) The percentage of pupils who are habitual truants;

17 (e) The percentage of pupils who are deemed habitual
18 disciplinary problems pursuant to NRS 392.4655;

19 (f) The number of incidents resulting in suspension or expulsion
20 for:

21 (1) Violence to other pupils or to school personnel;

22 (2) Possession of a weapon;

23 (3) Distribution of a controlled substance;

24 (4) Possession or use of a controlled substance; and

25 (5) Possession or use of alcohol;

26 (g) For kindergarten through grade 8, the number and
27 percentage of pupils who are retained in the same grade;

28 (h) For grades 9 to 12, inclusive, the number and percentage of
29 pupils who are deficient in the number of credits required for
30 promotion to the next grade or graduation from high school;

31 (i) The pupil-teacher ratio for kindergarten and grades 1 to 8,
32 inclusive;

33 (j) The average class size for the subject area of mathematics,
34 English, science and social studies in schools where pupils rotate to
35 different teachers for different subjects;

36 (k) The number and percentage of pupils who graduated from
37 high school;

38 (l) The number and percentage of pupils who received a:

39 (1) Standard diploma;

40 (2) Adult diploma;

41 (3) Adjusted diploma; and

42 (4) Certificate of attendance;

43 (m) The number and percentage of pupils who graduated from
44 high school and enrolled in remedial courses at the Nevada System
45 of Higher Education;

- 19 2. The summary prepared pursuant to subsection 1 must:
 - 20 (a) Comply with 20 U.S.C. § 6311(h)(1) and the regulations
 - 21 adopted pursuant thereto;
 - 22 (b) Be prepared in a concise manner; and
 - 23 (c) Be presented in an understandable and uniform format and,
 - 24 to the extent practicable, provided in a language that parents will
 - 25 likely understand.
- 26 3. On or before September 7 of each year, the State Board
- 27 shall:
 - 28 (a) Provide for public dissemination of the summary prepared
 - 29 pursuant to subsection 1 by posting the summary on the Internet
 - 30 website maintained by the Department; and
 - 31 (b) Submit a copy of the summary in an electronic format to the:
 - 32 (1) Governor;
 - 33 (2) Committee;
 - 34 (3) Bureau;
 - 35 (4) Board of Regents of the University of Nevada;
 - 36 (5) Board of trustees of each school district; and
 - 37 (6) Governing body of each charter school.
- 38 4. The board of trustees of each school district and the
- 39 governing body of each charter school shall ensure that the parents
- 40 and guardians of pupils enrolled in the school district or charter
- 41 school, as applicable, have sufficient information concerning the
- 42 availability of the summary prepared by the State Board pursuant to
- 43 subsection 1, including, without limitation, information that
- 44 describes how to access the summary on the Internet website
- 45 maintained by the Department. Upon the request of a parent or



guardian of a pupil, the Department shall provide the parent or guardian with a written copy of the summary.

5. The Department shall, in consultation with the Bureau and the school districts, prescribe a form for the summary required by this section.

Sec. 2. NRS 385.389 is hereby amended to read as follows:

385.389 1. The Department shall adopt programs of remedial study for each subject tested on the examinations administered pursuant to NRS 389.015 ~~and~~ *and 389.550*, including, without limitation, programs that are designed for pupils who are limited English proficient. The programs adopted for pupils who are limited English proficient must be designed to:

(a) Improve the academic achievement of those pupils; or

(b) Assist those pupils with attaining proficiency in the English language.

➔ In adopting these programs of remedial study, the Department shall consider the recommendations submitted by the Committee pursuant to NRS 218E.615 and programs of remedial study that have proven to be successful in improving the academic achievement of pupils.

2. If a school fails to make adequate yearly progress ~~for if less than 60 percent of the pupils enrolled in a school who took the examinations administered pursuant to NRS 389.015 received an average score on those examinations that is at least equal to the 26th percentile of the national reference group of pupils to which the examinations were compared,~~ *based upon the results of the examinations administered pursuant to NRS 389.015 or 389.550*, the school shall adopt a program of remedial study that has been adopted by the Department pursuant to subsection 1 or a program, practice or strategy recommended by the Commission on Educational Excellence pursuant to NRS 385.3785, or any combination thereof, as applicable.

3. A school district that includes a school described in subsection 2 shall ensure that each of the pupils enrolled in the school who failed to demonstrate at least adequate achievement on the examinations administered pursuant to NRS 389.015 *or 389.550, as applicable*, completes ~~[, in accordance with the requirements set forth in subsection 4 of NRS 389.015,]~~ remedial study that is determined to be appropriate for the pupil.

Sec. 3. NRS 385.3891 is hereby amended to read as follows:

➤ If a pupil fails the high school proficiency examination, the school shall notify the pupil and the parents or legal guardian of the pupil of each subject area that the pupil failed as soon as practicable but not later than 15 working days after the school receives the results of the examination.

If a pupil fails to demonstrate at least adequate achievement on the examination administered before the completion of grade 4, 7 or 10, the pupil may be promoted to the next higher grade, but the results of the pupil's examination must be evaluated to determine what remedial study is appropriate. If such a pupil is enrolled at a school that has failed to make adequate yearly progress or in which less than 60 percent of the pupils enrolled in grade 4, 7 or 10 in the school who took the examinations administered pursuant to this section received an average score on those examinations that is at least equal to the 26th percentile of the national reference group of pupils to which the examinations were compared, the pupil must, in accordance with the requirements set forth in this subsection, complete remedial study that is determined to be appropriate for the pupil.~~

~~5.]~~ Except as otherwise provided in subsection ~~[6.]~~ 5, if a pupil fails to pass the high school proficiency examination, the pupil must not be graduated unless he or she:

(a) Is able, through remedial study, to pass the *high school* proficiency examination; or

(b) Passes the subject areas of mathematics and reading tested on the *high school* proficiency examination, has at least a 2.75 grade point average on a 4.0 grading scale and satisfies the alternative criteria prescribed by the State Board pursuant to NRS 389.805,

(a) The effect of each irregularity in testing administration, including, without limitation, whether the irregularity required the scores of pupils to be invalidated; and

(b) Whether sufficient time remains in the school year to provide for an additional administration of examinations.

~~[6.] 3.~~ If the Department determines pursuant to subsection ~~[5]~~ 2 that a school must provide for an additional administration of examinations, the Department may consider whether the most recent irregularity in testing administration affected the test scores of a limited number of pupils and require the school to provide an additional administration of examinations pursuant to this section only to those pupils whose test scores were affected by the most recent irregularity.

389.640 Establishment of statewide program for preparation of pupils to take examinations; compliance with program required of school districts and schools; use of additional materials and information.

1. The Department shall establish a statewide program for use by schools and school districts in their preparation for the examinations that are administered pursuant to NRS 389.015, excluding the high school proficiency examination. The program must:

(a) Be designed to ensure the consistency and uniformity of all materials and other information used in the preparation for the examinations; and

(b) Be designed to ensure that the actual examinations administered pursuant to NRS 389.015 are not included within the materials and other information used for preparation.

2. If a school, including, without limitation, a charter school, or a school district provides preparation for the examinations that are administered pursuant to NRS 389.015, excluding the high school proficiency examination, the school or school district shall comply with the program established pursuant to subsection 1. A school district may use and provide additional materials and information if the materials and information comply with the program established by the Department. A school, including, without limitation, a charter school, shall use only those materials and information that have been approved or provided by the Department or the school district.
