**SUMMARY**—Increases certain fees for residential and general appraisers to cover an increase in federal registry fees. (BDR 54-1199)

AN ACT relating to appraisers of real estate; revising certain fees for the issuance or renewal of a license or certificate; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

- 1       Under existing law, a fee of \$290 is charged for the issuance or biennial  
2       renewal of a license or certificate as a residential appraiser, and a fee of \$390 is  
3       charged for the issuance or biennial renewal of a certificate as a general appraiser.  
4       (NRS 645C.450) A portion of that fee, currently \$50, is retained by the Real Estate  
5       Division of the Department of Business and Industry for payment of the registry fee  
6       to the Federal Financial Institutions Examination Council. (NRS 645C.240) On  
7       July 21, 2010, the Dodd-Frank Wall Street Reform and Consumer Protection Act  
8       (Dodd-Frank Act) was signed into law. (Pub. L. No. 111-203, 124 Stat. 1376) The  
9       Dodd-Frank Act revised 12 U.S.C. § 3338 to increase the annual registry fee from  
10      \$25 to \$40.  
11      This bill increases the biennial fees charged for the issuance or renewal of a  
12      license or certificate as a residential appraiser and for the issuance or renewal of a  
13      certificate as a general appraiser by \$30 to cover the annual \$15 increase in the  
14      federal registry fee.

**Section 1.** NRS 645C.450 is hereby amended to read as follows:

27 to be charged and collected by the Division to pay the costs of:

(a) Any examination for a certificate or license, including any costs which are necessary for the administration of such an examination.
