SUMMARY—Revises provisions governing the requirements for licensure as a professional engineer or professional land surveyor. (BDR 54-767)

AN ACT relating to professional licenses; revising the requirements for licensure as a professional engineer or professional land surveyor for certain applicants; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Before July 1, 2010, state law authorized a person to obtain a license from the State
2 Board of Professional Engineers and Land Surveyors to practice as a professional engineer or
3 professional land surveyor in this State if the person passed the requisite examination for
4 licensure and: (1) met certain educational requirements by obtaining a 4-year degree; or (2)
5 had a record of 10 or more years of active experience in his or her respective field of work. In
6 1999, the Legislature enacted legislation that, effective July 1, 2010, deleted the provisions
7 which allowed an applicant for licensure to obtain a license in professional engineering or
8 professional land surveying based on 10 or more years of active work experience in addition
9 to passing the requisite examination. (Sections 5 and 7 of chapter 478, Statutes of Nevada
10 1999, pp. 2435, 2437) In 2005, the Legislature enacted legislation authorizing certain
11 applicants for a professional engineering license to sit for the principles and practices portion
12 of the examination for licensure after obtaining 6 years of active experience in engineering
13 work. Such applicants were eligible for licensure if they obtained an additional 4 years of
14 active work experience in engineering before July 1, 2010, in addition to meeting all other
15 requirements for licensure. (Sections 3 and 4 of chapter 75, Statutes of Nevada 2005, pp. 206,
16 208) After the enactment of the legislation in 2005, and until July 1, 2010, applicants for
17 licensure as a professional land surveyor were still required to obtain 10 years of active work
18 experience before they were eligible to sit for the principles and practices portion of their
19 respective examination.

20 **Section 2** of this bill authorizes certain applicants for licensure as a professional engineer
21 who received approval from the Board before July 1, 2010, to sit for the principles and
22 practices portion of the professional engineering examination for licensure to obtain a license
23 from the Board if the applicants, before August 1, 2014, pass the requisite examination for
24 licensure. Applicants for licensure as a professional engineer must also complete their
25 respective work experience requirement by obtaining a record of 10 or more years of active
26 work experience in engineering before August 1, 2014. **Section 3** of this bill authorizes the
27 Board to waive educational requirements for certain applicants for licensure as a professional
28 land surveyor who, before July 1, 2010, ~~met all the requirements for licensure other than~~
29 ~~passing~~ **received approval from the Board to take** the examination on the principles and
30 practices of land surveying and who pass the examination before August 1, 2014.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 625 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *The Board may waive any requirement for education that is*
4 *required for licensure as a professional engineer pursuant to subsection 3 of NRS*
5 *625.183 and may issue a license to practice professional engineering to a person*
6 *who:*

7 1. *Before July 1, 2010, received approval from the Board to take the*
8 *examination on the principles and practices of engineering pursuant to*
9 *paragraph (b) of subsection 1 of NRS 625.193; and*

10 2. *Before August 1, 2014:*

11 (a) *Passes the examination for licensure pursuant to NRS 625.193; and*

12 (b) *Has a record of 10 years or more of active experience in engineering*
13 *which is satisfactory to the Board and which indicates the person is competent to*
14 *be placed in responsible charge of engineering work.*

15 **Sec. 3.** *The Board may waive any requirement for education that is*
16 *required for licensure as a professional land surveyor pursuant to subsection 3 of*
17 *NRS 625.270 and may issue a license to practice professional land surveying to a*
18 *person who:*

19 1. *Before July 1, 2010, ~~[satisfactorily met the requirements for licensure as~~*
20 *~~a professional land surveyor other than passing]~~ received approval from the*
21 *Board to take the examination on the principles and practices of land surveying*
22 *pursuant to paragraph (b) of subsection 1 of NRS 625.280; and*

23 2. *Before August 1, 2014, passes the examination for licensure pursuant to*
24 *NRS 625.280.*

25 **Sec. 4.** NRS 625.183 is hereby amended to read as follows:

26 625.183 1. A person who:

27 (a) Is 21 years of age or older; and

28 (b) Is a citizen of the United States or is lawfully entitled to remain and work in
29 the United States,

30 ↪ may apply to the Board, in accordance with the provisions of this chapter and
31 any regulations adopted by the Board, for licensure as a professional engineer.

32 2. An applicant for licensure as a professional engineer must:

33 (a) Be of good character and reputation; and

34 (b) Pass the examination on the:

35 (1) Fundamentals of engineering or receive a waiver of that requirement;

36 and

37 (2) Principles and practices of engineering,

38 ↪ pursuant to NRS 625.193.

39 3. ~~[An]~~ *Except as otherwise provided in section 2 of this act, an* applicant for
40 licensure as a professional engineer is not qualified for licensure unless the
41 applicant is a graduate of an engineering curriculum of 4 years or more that is
42 approved by the Board and has a record of 4 years or more of active experience in
43 engineering which is satisfactory to the Board and which indicates that the
44 applicant is competent to be placed in responsible charge of engineering work. An
45 applicant who is eligible to take the examination on the principles and practices of
46 engineering pursuant to subsection 2 of NRS 625.193 may take the examination on

1 the principles and practices of engineering before the applicant meets the active
2 experience requirements for licensure set forth in this subsection.

3 4. To determine whether an applicant for licensure as a professional engineer
4 has an adequate record of active experience pursuant to subsection 3:

5 (a) Graduation from a college or university in a discipline of engineering with
6 a master's or doctoral degree is equivalent to 2 years of active experience, except
7 that, in the aggregate, not more than 2 years of active experience may be satisfied
8 by graduation from a college or university with such degrees, regardless of the
9 number of degrees earned.

10 (b) Two of the 4 years of active experience must have been completed by
11 working under the direct supervision of a professional engineer who is licensed in
12 the discipline in which the applicant is applying for licensure, unless that
13 requirement is waived by the Board.

14 (c) The execution, as a contractor, of work designed by a professional
15 engineer, or the supervision of the construction of that work as a foreman or
16 superintendent, is not equivalent to active experience in engineering.

17 5. A person who is not working in the field of engineering when applying for
18 licensure is eligible for licensure as a professional engineer if the person complies
19 with the requirements for licensure prescribed in this chapter.

20 **Sec. 5.** NRS 625.270 is hereby amended to read as follows:

21 625.270 1. A person who:

22 (a) Is 21 years of age or older; and

23 (b) Is a citizen of the United States or is lawfully entitled to remain and work in
24 the United States,

25 ↪ may apply to the Board, in accordance with the provisions of this chapter and
26 any regulations adopted by the Board, for licensure as a professional land surveyor.

27 2. An applicant for licensure as a professional land surveyor must:

28 (a) Be of good character and reputation; and

29 (b) Pass the examination on the:

30 (1) Fundamentals of land surveying or receive a waiver of that
31 requirement; and

32 (2) Principles and practices of land surveying,

33 ↪ pursuant to NRS 625.280.

34 3. ~~As~~ **Except as otherwise provided in section 3 of this act, an** applicant for
35 licensure as a professional land surveyor may not take the examination on the
36 principles and practices of land surveying, unless the applicant is a graduate of a
37 land-surveying curriculum of 4 years or more that is approved by the Board and has
38 a record of 4 years or more of active experience in land surveying that is
39 satisfactory to the Board and indicates that the applicant is competent to be placed
40 in responsible charge of land-surveying work.

41 4. To determine whether an applicant for licensure as a professional land
42 surveyor has an adequate record of active experience pursuant to subsection 3:

43 (a) Two of the 4 years of active experience must have been completed by
44 working under the direct supervision of a professional land surveyor, unless that
45 requirement is waived by the Board.

46 (b) The execution, as a contractor, of work designed by a professional land
47 surveyor, or the supervision of the construction of that work as a foreman or
48 superintendent, is not equivalent to active experience in land surveying.

49 5. A person who is not working in the field of land surveying when applying
50 for licensure is eligible for licensure as a professional land surveyor if the person
51 complies with the requirements for licensure prescribed in this chapter.

52 **Sec. 6.** This act becomes effective on July 1, 2011.
