AN ACT making an appropriation for the implementation and operation of a principal leadership training program; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
- 2 the Department of Administration to contract with the Clark County Public
- 3 Education Foundation the sum of ~~(\$500,000)~~ \$100,000 for the implementation and
- 4 operation of a principal leadership training program.
- 5 2. The Department of Administration may release the money appropriated by
- 6 subsection 1 only upon receipt of evidence that the Clark County Public Education
- 7 Foundation has matched or exceeded the appropriation from other sources.
- 8 **Sec. 2.** 1. The Clark County Public Education Foundation shall work in
- 9 cooperation with the 17 school districts, other public education foundations in this
- 10 State, and the Regional Professional Development training programs for the
- 11 professional development of teachers and administrators created by NRS 391.512
- 12 to design and implement the training program.
- 13 2. The Clark County Public Education Foundation shall use the money
- 14 appropriated by subsection 1 of section 1 of this act to implement and operate a
- 15 principal leadership training program, including, without limitation:
- 16 (a) Personnel for the program;
- 17 (b) Equipment and supplies for the program;
- 18 (c) Research related to the design of a curriculum;
- 19 (d) Marketing to licensed principals throughout the State; and
- 20 (e) Data systems for the reporting of participation and results.
- 21 **Sec. 3.** Upon acceptance of the money appropriated by subsection 1 of
- 22 section 1 of this act, the Clark County Public Education Foundation shall:

1 1. Prepare and transmit a report to the Director of the Legislative Counsel
2 Bureau for transmission to the Interim Finance Committee on or before December
3 15, 2012, that describes each expenditure made from the money appropriated by
4 subsection 1 of section 1 of this act from the date on which the money was received
5 through December 1, 2012;

6 2. Prepare and transmit a final report to the Director of the Legislative
7 Counsel Bureau for transmittal to the Interim Finance Committee on or before
8 September 20, 2013, that describes each expenditure made from the money
9 appropriated by subsection 1 of section 1 of this act from the date on which the
10 money was received through June 30, 2013; and

11 3. Upon request of the Legislative Commission, make available to the
12 Legislative Auditor any of the books, accounts, claims, reports, vouchers or other
13 records of information, confidential or otherwise, of the Clark County Public
14 Education Foundation, regardless of their form or location, that the Legislative
15 Auditor deems necessary to conduct an audit of the use of the money appropriated
16 by subsection 1 of section 1 of this act.

17 **Sec. 4.** Any remaining balance of the appropriation made by subsection 1 of
18 section 1 of this act must not be committed for expenditure after June 30, 2013, by
19 the entity to which the appropriation is made or any entity to which the money from
20 the appropriation is granted or otherwise transferred in any manner, and any portion
21 of the appropriated money remaining must not be spent for any purpose after
22 September 20, 2013, by either the entity to which the money was appropriated or
23 the entity to which the money was subsequently granted or transferred, and must be
24 reverted to the State General Fund on or before September 20, 2013.

25 **Sec. 5.** This act becomes effective upon passage and approval.
