SUMMARY—Revises provisions governing the release of certain reports of the abuse or neglect of children. (BDR 38-246)

AN ACT relating to the protection of children; authorizing an agency which provides child welfare services to make available reports of the abuse or neglect of children under certain circumstances; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law authorizes an agency which provides child welfare services to release data or  
2 information concerning reports of the abuse or neglect of a child to certain persons. (NRS  
3 432B.290) This bill authorizes such data and information relating to a child over whom a  
4 guardianship is sought pursuant to chapter 159 of NRS or NRS 432B.466 to 432B.468,  
5 inclusive, to be released to: (1) the court which has jurisdiction over the proceeding; (2) the  
6 person who filed **or intends to file** the petition; (3) the proposed guardian or proposed  
7 successor guardian; (4) the parent or guardian of the child; and (5) the child, if he or she is at  
8 least 14 years of age.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 432B.290 is hereby amended to read as follows:  
2 432B.290 1. Except as otherwise provided in subsections 2 and 3 and NRS  
3 432B.165, 432B.175 and 432B.513, data or information concerning reports and  
4 investigations thereof made pursuant to this chapter may be made available only to:  
5 (a) A physician, if the physician has before him or her a child who the  
6 physician has reasonable cause to believe has been abused or neglected;  
7 (b) A person authorized to place a child in protective custody, if the person has  
8 before him or her a child who the person has reasonable cause to believe has been  
9 abused or neglected and the person requires the information to determine whether  
10 to place the child in protective custody;

1 (c) An agency, including, without limitation, an agency in another jurisdiction,  
2 responsible for or authorized to undertake the care, treatment or supervision of:

3 (1) The child; or

4 (2) The person responsible for the welfare of the child;

5 (d) A district attorney or other law enforcement officer who requires the  
6 information in connection with an investigation or prosecution of the abuse or  
7 neglect of a child;

8 (e) ~~(e)~~ *Except as otherwise provided in paragraph (f), a court, for in camera*  
9 *inspection only, unless the court determines that public disclosure of the*  
10 *information is necessary for the determination of an issue before it;*

11 (f) *A court as defined in NRS 159.015 to determine whether a guardian or*  
12 *successor guardian of a child should be appointed pursuant to chapter 159 of*  
13 *NRS or NRS 432B.466 to 432B.468, inclusive;*

14 (g) A person engaged in bona fide research or an audit, but information  
15 identifying the subjects of a report must not be made available to the person;

16 ~~(g)~~ (h) The attorney and the guardian ad litem of the child;

17 ~~(h)~~ (i) *A person who files or intends to file a petition for the appointment of*  
18 *a guardian or successor guardian of a child pursuant to chapter 159 of NRS or*  
19 *NRS 432B.466 to 432B.468, inclusive, if the identity of the person responsible for*  
20 *reporting the abuse or neglect of the child to a public agency is kept confidential;*

21 (j) *The proposed guardian or proposed successor guardian of a child over*  
22 *whom a guardianship is sought pursuant to chapter 159 of NRS or NRS*  
23 *432B.466 to 432B.468, inclusive, if the identity of the person responsible for*  
24 *reporting the abuse or neglect of the child to a public agency is kept confidential;*

25 (k) A grand jury upon its determination that access to these records is  
26 necessary in the conduct of its official business;

27 ~~(k)~~ (l) A federal, state or local governmental entity, or an agency of such an  
28 entity, that needs access to the information to carry out its legal responsibilities to  
29 protect children from abuse and neglect;

30 ~~(l)~~ (m) A person or an organization that has entered into a written agreement  
31 with an agency which provides child welfare services to provide assessments or  
32 services and that has been trained to make such assessments or provide such  
33 services;

34 ~~(m)~~ (n) A team organized pursuant to NRS 432B.350 for the protection of a  
35 child;

36 ~~(n)~~ (o) A team organized pursuant to NRS 432B.405 to review the death of a  
37 child;

38 ~~(o)~~ (p) A parent or legal guardian of the child and an attorney of a parent or  
39 guardian of the child, *including, without limitation, the parent or guardian of a*  
40 *child over whom a guardianship is sought pursuant to chapter 159 of NRS or*  
41 *NRS 432B.466 to 432B.468, inclusive, if the identity of the person responsible for*  
42 *reporting the abuse or neglect of the child to a public agency is kept confidential;*

43 ~~(p)~~ (q) *The child over whom a guardianship is sought pursuant to chapter*  
44 *159 of NRS or NRS 432B.466 to 432B.468, inclusive, if:*

45 (1) *The child is 14 years of age or older; and*

46 (2) *The identity of the person responsible for reporting the abuse or*  
47 *neglect of the child to a public agency is kept confidential;*

48 (r) The persons who are the subject of a report;

49 ~~(q)~~ (s) An agency that is authorized by law to license foster homes or  
50 facilities for children or to investigate persons applying for approval to adopt a  
51 child, if the agency has before it an application for that license or is investigating an  
52 applicant to adopt a child;

1 ~~(p)~~ (t) Upon written consent of the parent, any officer of this State or a city  
2 or county thereof or Legislator authorized, by the agency or department having  
3 jurisdiction or by the Legislature, acting within its jurisdiction, to investigate the  
4 activities or programs of an agency which provides child welfare services if:

5 (1) The identity of the person making the report is kept confidential; and

6 (2) The officer, Legislator or a member of the family of the officer or  
7 Legislator is not the person alleged to have committed the abuse or neglect;

8 ~~(q)~~ (u) The Division of Parole and Probation of the Department of Public  
9 Safety for use pursuant to NRS 176.135 in making a presentence investigation and  
10 report to the district court or pursuant to NRS 176.151 in making a general  
11 investigation and report;

12 ~~(r)~~ (v) Any person who is required pursuant to NRS 432B.220 to make a  
13 report to an agency which provides child welfare services or to a law enforcement  
14 agency;

15 ~~(s)~~ (w) The Rural Advisory Board to Expedite Proceedings for the Placement  
16 of Children created pursuant to NRS 432B.602 or a local advisory board to expedite  
17 proceedings for the placement of children created pursuant to NRS 432B.604;

18 ~~(t)~~ (x) The panel established pursuant to NRS 432B.396 to evaluate agencies  
19 which provide child welfare services; or

20 ~~(u)~~ (y) An employer in accordance with subsection 3 of NRS 432.100.

21 2. An agency investigating a report of the abuse or neglect of a child shall,  
22 upon request, provide to a person named in the report as allegedly causing the  
23 abuse or neglect of the child:

24 (a) A copy of:

25 (1) Any statement made in writing to an investigator for the agency by the  
26 person named in the report as allegedly causing the abuse or neglect of the child; or

27 (2) Any recording made by the agency of any statement made orally to an  
28 investigator for the agency by the person named in the report as allegedly causing  
29 the abuse or neglect of the child; or

30 (b) A written summary of the allegations made against the person who is  
31 named in the report as allegedly causing the abuse or neglect of the child. The  
32 summary must not identify the person responsible for reporting the alleged abuse or  
33 neglect.

34 3. An agency which provides child welfare services shall disclose the identity  
35 of a person who makes a report or otherwise initiates an investigation pursuant to  
36 this chapter if a court, after reviewing the record in camera and determining that  
37 there is reason to believe that the person knowingly made a false report, orders the  
38 disclosure.

39 4. Any person, except for:

40 (a) The subject of a report;

41 (b) A district attorney or other law enforcement officer initiating legal  
42 proceedings; or

43 (c) An employee of the Division of Parole and Probation of the Department of  
44 Public Safety making a presentence investigation and report to the district court  
45 pursuant to NRS 176.135 or making a general investigation and report pursuant to  
46 NRS 176.151,

47 who is given access, pursuant to subsection 1, to information identifying the  
48 subjects of a report and who makes this information public is guilty of a  
49 misdemeanor.

50 5. The Division of Child and Family Services shall adopt regulations to carry  
51 out the provisions of this section.
