SUMMARY—Revises provisions governing the ~~wearing of protective headgear when operating motorcycles.~~ equipment and training required to operate a motorcycle. (BDR 43-571)

AN ACT relating to motorcycles; revising provisions governing the wearing of protective headgear when operating motorcycles under certain circumstances; requiring that all applicants for a motorcycle driver's license complete an approved motorcycle safety course; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law defines a motorcycle to mean a motor vehicle equipped with a seat or a saddle to travel on not more than three wheels, specifically excluding an electric bicycle, a tractor and a moped. (NRS 486.041) Under existing law, an applicant for a motorcycle driver's license is required to complete a written examination and driving test or complete a course of motorcycle safety approved by the Department of Motor Vehicles. (NRS 486.071) Sections 1-3 of this bill require all applicants for a motorcycle driver's license or a motorcycle endorsement to a driver's license to successfully complete an approved motorcycle safety course. Section 5 of this bill exempts a person who obtains such a license or endorsement before July 1, 2011, from the requirement to successfully complete an approved motorcycle safety course. Existing law requires drivers and passengers of motorcycles that are driven on a highway to wear protective headgear and exempts drivers and passengers of trimobiles and mopeds from the requirement. (NRS 486.231) ~~This~~ Section 4 of this bill eliminates the requirement of wearing protective headgear for drivers of motorcycles who: (1) are 21 years of age or older; ~~and~~ (2) have possessed a valid motorcycle license for not less than 1 year ~~, and~~ and (2) have completed an approved motorcycle safety course. ~~This bill~~ Section 4 also removes the exception from these requirements concerning protective headgear for trimobiles and mopeds. ~~Finally, this bill~~ Additionally, section 4 eliminates the requirement of wearing protective headgear for a passenger of a motorcycle who is 21 years of age or older.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1. NRS 486.071 is hereby amended to read as follows:**

2 486.071 Except as otherwise provided in NRS 486.161, the Department shall
3 not issue a motorcycle driver's license unless the applicant:

- 4 1. Is at least 16 years of age; and
- 5 2. Has successfully completed:

6 (a) Such written examination and driving test as may be required by the
7 Department; ~~for and~~

- 8 (b) A course of motorcycle safety approved by the Department.

9 **Sec. 2. NRS 486.131 is hereby amended to read as follows:**

10 486.131 1. The Department may require every applicant for a motorcycle
11 driver's license to submit to an examination conducted by the Department. ~~for~~
12 successfully complete a course of motorcycle safety approved by the Department.]

13 2. An examination may be held in the county where the applicant resides
14 within 30 days after the date application is made and may include:

15 (a) A test of the applicant's ability to understand official devices used to
16 control traffic;

17 (b) A test of the applicant's knowledge of practices for safe driving and the
18 traffic laws of this State;

19 (c) Except as otherwise provided in a regulation adopted pursuant to subsection
20 2 of NRS 483.330, a test of the applicant's eyesight; and

21 (d) An actual demonstration of the applicant's ability to exercise ordinary and
22 reasonable control in the operation of a motorcycle.

23 → The examination may also include such further physical and mental examination
24 as the Department finds necessary to determine the applicant's fitness to drive a
25 motorcycle safely upon the highways.

26 **Sec. 3. NRS 486.161 is hereby amended to read as follows:**

27 486.161 1. Except as otherwise provided in subsection 4, every motorcycle
28 driver's license expires on the fourth anniversary of the licensee's birthday,
29 measured in the case of an original license, a renewal license or a license renewing
30 an expired license, from the birthday nearest the date of issuance or renewal. Any
31 applicant whose date of birth is February 29 is, for the purposes of NRS 486.011 to
32 486.381, inclusive, considered to have the anniversary of his or her birth fall on
33 February 28.

34 2. Every license is renewable at any time before its expiration upon
35 application, submission of the statement required pursuant to NRS 486.084 and
36 payment of the required fee. Every motorcycle endorsement to a driver's license
37 issued on or after January 1, 1972, expires simultaneously with the expiration of the
38 driver's license.

39 3. Except as otherwise provided in subsection 1 of NRS 483.384, each
40 applicant for renewal must appear before an examiner for a driver's license and
41 successfully pass a test of the applicant's eyesight.

42 4. Any person who has been issued a driver's license without having the
43 authority to drive a motorcycle endorsed thereon must, before driving a motorcycle,
44 successfully : ~~pass~~

45 (a) ~~A~~ Pass such driving test ~~conducted as may be required~~ by the
46 Department; ~~for and~~

47 (b) ~~A~~ Complete a course of motorcycle safety approved by the Department,
48 → and have the authority endorsed upon the license.

1 **[Section 1.] Sec. 4.** NRS 486.231 is hereby amended to read as follows:
2 486.231 1. The Department shall adopt standards for protective headgear
3 and protective glasses, goggles or face shields to be worn by the drivers and
4 passengers of motorcycles and transparent windscreens for motorcycles.

5 2. Except as *otherwise* provided in this section, when any motorcycle ~~is~~
6 ~~except a trimobile or moped,~~ is being driven on a highway ~~is~~:

7 (a) *The driver shall wear protective headgear which meets the standards
8 adopted pursuant to subsection 1 and is securely fastened on his or her head,
9 unless the driver:*

10 (I) *Is 21 years of age or older; and*

11 (2) *Has been licensed to operate a motorcycle for not less than 1 year.* ~~is~~
12 and

13 (3) ~~Has completed a course of instruction on motorcycle safety that has
14 been approved pursuant to NRS 486.272.~~

15 (b) *A passenger of a motorcycle shall wear protective headgear which meets
16 the standards adopted pursuant to subsection 1 and is securely fastened on his or
17 her head, unless the passenger is 21 years of age or older.*

18 (c) *Both* the driver and passenger shall wear ~~protective headgear securely
19 fastened on the head and~~ protective glasses, goggles or face shields ~~meeting those
20 standards. Drivers and passengers of trimobiles shall wear protective glasses,
21 goggles or face shields~~ which meet ~~those~~ *the* standards ~~is~~ adopted pursuant to
22 subsection 1.

23 3. When a motorcycle ~~or a trimobile~~ is equipped with a transparent
24 windscreen ~~meeting those standards,~~ *which meets the standards adopted
25 pursuant to subsection 1,* the driver and passenger are not required to wear
26 protective glasses, goggles or face shields.

27 4. When a motorcycle is being driven in a parade authorized by a local
28 authority, the driver and passenger are not required to wear the protective devices
29 provided for in this section.

30 5. When a three-wheel motorcycle on which the driver and passengers ride
31 within an enclosed cab is being driven on a highway, the driver and passengers are
32 not required to wear the protective devices required by this section.

33 **Sec. 5. Notwithstanding the amendatory provisions of this act, the
34 requirement to successfully complete an approved motorcycle safety course
35 before obtaining a motorcycle driver's license or a motorcycle endorsement to
36 a driver's license does not apply to a person who obtains such a license or
37 endorsement before July 1, 2011.**

38 **Sec. 6. This act becomes effective upon passage and approval.**
