SUMMARY—Revises provisions governing pet **cemeteries and** crematories. (BDR 40-979)

AN ACT relating to ~~[pet crematories; repealing provisions which require a person who operates a crematory for pets to operate the crematory on the property of a cemetery for]~~ **pets; reducing the amount of real property required for the operation of a pet cemetery; revising provisions governing crematories for pets;** and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 ~~[This bill repeals provisions requiring]~~ **Section 2 of this bill authorizes the governing**
2 **body of a county, city or town to adopt ordinances for the maintenance and operation of**
3 **a crematory for pets. Section 3 of this bill reduces the amount of real property required**
4 **to have a pet cemetery from 5 acres to 2.5 acres. Section 4 of this bill removes the**
5 **requirement that a crematory for pets must be operated by a person who**
6 **operates a crematory for pets to obtain a certificate of authority from the Nevada State Funeral Board to**
7 **operate a cemetery for pets and to operate the crematory on the premises of the cemetery.**
8 **(NRS 452.675) is a cemetery authority, who has a certificate of authority and who**
9 **operates the crematory on the property of a pet cemetery. Instead, section 4 requires a**
10 **crematory for pets which is independent of a cemetery for pets to have an area of a**
11 **facility that is designated only for the cremation of pets and which complies with any**
12 **applicable laws. Section 5 of the bill allows the operator of a crematory for pets to**
13 **dispose of the remains of a pet which have been left with the crematory when**
14 **arrangements have not been made within 7 days.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** ~~[NRS 452.675 is hereby repealed.]~~ **(Deleted by amendment.)**
2 **Sec. 2.** **NRS 452.650 is hereby amended to read as follows:**
3 452.650 The governing body of a county, city or town may adopt such
4 ordinances for the maintenance and operation of cemeteries for pets, ~~it~~ **and**
5 **crematories for pets,** and for the interment, inurnment and entombment of pets, as

1 it deems appropriate for the public health, safety or welfare. Such an ordinance
 2 must not conflict with the provisions of NRS 452.655 to 452.700, inclusive.

3 **Sec. 3. NRS 452.670 is hereby amended to read as follows:**

4 452.670 A person shall not operate a cemetery for pets unless:

5 1. The trust fund for the endowment care of the cemetery contains a principal
 6 sum of not less than that amount required pursuant to NRS 452.705.

7 2. The cemetery is located on not less than ~~1.5~~ **2.5** acres of real property
 8 which:

9 (a) Is dedicated for use as a cemetery for pets pursuant to NRS 452.655; and

10 (b) Is not subject to any liens, mortgages or other encumbrances, except those
 11 which are subordinate to the dedication of the property for use as a cemetery for
 12 pets.

13 **Sec. 4. NRS 452.675 is hereby amended to read as follows:**

14 452.675 1. A person shall not operate a crematory for pets unless the person

 31 days at the cemetery ~~or crematory~~, if arrangements have not been made with the
 32 cemetery authority **or operator of the pet crematory** for the disposition of the pet.

33 2. Shall post a notice, in a conspicuous place on the grounds of the cemetery
 34 ~~or in the portion of the facility of the crematory where the public is allowed~~
 35 apprising the public of the provisions of subsection 1.
