AN ACT relating to education; revising provisions relating to sponsorship of charter schools; creating the State Public Charter School Authority; prescribing the membership, duties and powers of the State Public Charter School Authority; imposing certain restrictions on contracts between a charter school or proposed charter school and a contractor or educational management organization; repealing the Subcommittee on Charter Schools of the State Board of Education; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law authorizes the formation of charter schools and authorizes school districts, the State Board of Education and colleges and universities within the Nevada System of Higher Education to sponsor charter schools. (NRS 386.500-386.610) **Sections 25-35.5** of this bill create the State Public Charter School Authority and prescribe the membership of the State Public Charter School Authority. **Section 38** of this bill removes the authority of the State Board of Education to sponsor charter schools and authorizes the State Public Charter School Authority to sponsor charter schools. **Section 2** of this bill transfers the duty to prepare an annual report of accountability information of each charter school in this State from the board of trustees of a school district to the sponsor of that charter school. ~~[Sections 59 and 60]~~ **Section 59** of this bill ~~[require]~~ **provides for the appointment of** the Director of the State Public Charter School Authority ~~[and other persons employed by the State Public Charter School Authority to be appointed or hired, as appropriate.]~~ **Section 60 of this bill provides for the transfer of certain personnel positions from the Department of Education to the State Public Charter School Authority.** **Section 61** of this bill requires the members of the State Public Charter School Authority to be appointed. **Section 64** of this bill transfers the sponsorship of all charter schools sponsored by the State Board of Education to the State Public Charter School Authority.

Existing administrative regulations of the Department of Education set forth certain restrictions on contracts and proposed contracts between a charter school or proposed charter school and a contractor or an educational management organization. (NAC 386.403) **Section 35.7** of this bill codifies into statute the provisions of this regulation. **Section 35.7** also defines educational management organization for purposes of that section.

**Section 57** of this bill repeals the Subcommittee on Charter Schools of the State Board of Education.

WHEREAS, The Legislature recognizes that each child in this State should be afforded the opportunity to receive a high-quality education from the public schools of this State; and

WHEREAS, Some children perform better in different learning environments, and the educational programs in public schools should be designed to fit the individual needs of those children; and

WHEREAS, It is the intent of the Legislature to provide teachers and other educational personnel, parents, legal guardians and other persons who are interested in the system of public education in this State the opportunity to:

1. Improve the learning of pupils by creating public schools with rigorous standards for the academic achievement of pupils;

2. Close the achievement gaps between high-performing and low-performing groups of pupils;

3. Increase the opportunities for learning for all pupils;

4. Increase access to alternative educational programs for pupils who are identified as being at risk for academic failure; and

5. Encourage diverse approaches to public education and the use of innovative teaching methods that have proven effective; and

WHEREAS, The Legislature finds that the success of charter schools in this State depends upon the support of high-quality sponsors, effective charter associations and resource centers, effective educational personnel and parents and legal guardians of pupils enrolled in the charter schools; and

WHEREAS, The Legislature finds that the sponsors of successful charter schools maintain high standards for the sponsor and the charter schools they sponsor, preserve autonomy for the charter schools they sponsor and protect the interests of the pupils enrolled in the charter schools and the communities they serve; and

WHEREAS, The Legislature finds that the creation of a State Public Charter School Authority can serve as a model of the best practices in sponsoring charter schools and can foster high-quality public school choice through the charter schools it sponsors by providing pupils with an opportunity to maximize their academic potential; now, therefore,

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** NRS 385.005 is hereby amended to read as follows:

385.005 1. The Legislature reaffirms its intent that public education in the State of Nevada is essentially a matter for local control by local school districts. The provisions of this title are intended to reserve to the boards of trustees of local school districts within this state such rights and powers as are necessary to maintain control of the education of the children within their respective districts. These rights and powers may only be limited by other specific provisions of law.

2. The responsibility of establishing a statewide policy of integration or desegregation of public schools is reserved to the Legislature. The responsibility for establishing a local policy of integration or desegregation of public schools consistent with the statewide policy established by the Legislature is delegated to the respective boards of trustees of local school districts and to the governing body of each charter school.

3. The State Board shall, and *the State Public Charter School Authority*, each board of trustees of a local school district, the governing body of each charter school and any other school officer may, advise the Legislature at each regular session of any recommended legislative action to ensure high standards of equality of educational opportunity for all children in the State of Nevada.

**Sec. 2.** NRS 385.347 is hereby amended to read as follows:

385.347 1. The board of trustees of each school district in this State, in cooperation with associations recognized by the State Board as representing licensed educational personnel in the district, shall adopt a program providing for the accountability of the school district to the residents of the district and to the

1 State Board for the quality of the schools and the educational achievement of the  
2 pupils in the district, including, without limitation, pupils enrolled in charter  
3 schools ~~{nn}~~ **sponsored by** the school district. The board of trustees of each school  
4 district shall report the information required by subsection 2 for each charter school

11 2. The board of trustees of each school district shall, on or before August 15  
12 of each year, prepare an annual report of accountability concerning:

13 (a) The educational goals and objectives of the school district.

14 (b) Pupil achievement for each school in the district and the district as a whole,  
15 including, without limitation, each charter school ~~{nn}~~ **sponsored by** the district. The  
16 board of trustees of the district shall base its report on the results of the  
17 examinations administered pursuant to NRS 389.015 and 389.550 and shall  
18 compare the results of those examinations for the current school year with those of  
19 previous school years. The report must include, for each school in the district,  
20 including, without limitation, each charter school ~~{nn}~~ **sponsored by** the district, and  
21 each grade in which the examinations were administered:

22 (1) The number of pupils who took the examinations.

23 (2) A record of attendance for the period in which the examinations were  
24 administered, including an explanation of any difference in the number of pupils  
25 who took the examinations and the number of pupils who are enrolled in the school.

26 (3) Except as otherwise provided in this paragraph, pupil achievement,  
27 reported separately by gender and reported separately for the following groups of  
28 pupils:

29 (I) Pupils who are economically disadvantaged, as defined by the State  
30 Board;

31 (II) Pupils from major racial and ethnic groups, as defined by the State  
32 Board;

33 (III) Pupils with disabilities;

34 (IV) Pupils who are limited English proficient; and

35 (V) Pupils who are migratory children, as defined by the State Board.

36 (4) A comparison of the achievement of pupils in each group identified in  
37 paragraph (b) of subsection 1 of NRS 385.361 with the annual measurable  
38 objectives of the State Board.

39 (5) The percentage of pupils who were not tested.

40 (6) Except as otherwise provided in this paragraph, the percentage of  
41 pupils who were not tested, reported separately by gender and reported separately  
42 for the groups identified in subparagraph (3).

43 (7) The most recent 3-year trend in pupil achievement in each subject area  
44 tested and each grade level tested pursuant to NRS 389.015 and 389.550, which  
45 may include information regarding the trend in the achievement of pupils for more  
46 than 3 years, if such information is available.

47 (8) Information that compares the results of pupils in the school district,  
48 including, without limitation, pupils enrolled in charter schools ~~{nn}~~ **sponsored by**  
49 the district, with the results of pupils throughout this State. The information  
50 required by this subparagraph must be provided in consultation with the  
51 Department to ensure the accuracy of the comparison.

52 (9) For each school in the district, including, without limitation, each  
53 charter school ~~{nn}~~ **sponsored by** the district, information that compares the results

1 of pupils in the school with the results of pupils throughout the school district and  
2 throughout this State. The information required by this subparagraph must be  
3 provided in consultation with the Department to ensure the accuracy of the  
4 comparison.

5 (10) Information on whether each school in the district, including, without  
6 limitation, each charter school ~~fin~~ *sponsored by* the district, has made progress  
7 based upon the model adopted by the Department pursuant to NRS 385.3595.

8 ➤ A separate reporting for a group of pupils must not be made pursuant to this  
9 paragraph if the number of pupils in that group is insufficient to yield statistically  
10 reliable information or the results would reveal personally identifiable information  
11 about an individual pupil. The State Board shall prescribe the mechanism for  
12 determining the minimum number of pupils that must be in a group for that group  
13 to yield statistically reliable information.

14 (c) The ratio of pupils to teachers in kindergarten and at each grade level for  
15 each elementary school in the district and the district as a whole, including, without  
16 limitation, each charter school ~~fin~~ *sponsored by* the district, and the average class  
17 size for each core academic subject, as set forth in NRS 389.018, for each  
18 secondary school in the district and the district as a whole, including, without  
19 limitation, each charter school ~~fin~~ *sponsored by* the district.

20 (d) Information on the professional qualifications of teachers employed by  
21 each school in the district and the district as a whole, including, without limitation,  
22 each charter school ~~fin~~ *sponsored by* the district. The information must include,  
23 without limitation:

24 (1) The percentage of teachers who are:

25 (I) Providing instruction pursuant to NRS 391.125;

26 (II) Providing instruction pursuant to a waiver of the requirements for  
27 licensure for the grade level or subject area in which the teachers are employed; or

28 (III) Otherwise providing instruction without an endorsement for the  
29 subject area in which the teachers are employed;

30 (2) The percentage of classes in the core academic subjects, as set forth in  
31 NRS 389.018, that are not taught by highly qualified teachers;

32 (3) The percentage of classes in the core academic subjects, as set forth in  
33 NRS 389.018, that are not taught by highly qualified teachers, in the aggregate and  
34 disaggregated by high-poverty compared to low-poverty schools, which for the  
35 purposes of this subparagraph means schools in the top quartile of poverty and the  
36 bottom quartile of poverty in this State;

37 (4) For each middle school, junior high school and high school:

38 (I) ~~{On and after July 1, 2005, the}~~ *The* number of persons employed  
39 as substitute teachers for 20 consecutive days or more in the same classroom or  
40 assignment, designated as long-term substitute teachers, including the total number

43 (II) ~~{On and after July 1, 2006, the}~~ *The* number of persons employed  
44 as substitute teachers for less than 20 consecutive days, designated as short-term  
45 substitute teachers, including the total number of days short-term substitute teachers  
46 were employed at each school, identified by grade level and subject area; and

47 (5) For each elementary school:

48 (I) ~~{On and after July 1, 2005, the}~~ *The* number of persons employed  
49 as substitute teachers for 20 consecutive days or more in the same classroom or  
50 assignment, designated as long-term substitute teachers, including the total number  
51 of days long-term substitute teachers were employed at each school, identified by  
52 grade level; and

(II) ~~{On and after July 1, 2006, the}~~ *The* number of persons employed as substitute teachers for less than 20 consecutive days, designated as short-term substitute teachers, including the total number of days short-term substitute teachers were employed at each school, identified by grade level.

(e) The total expenditure per pupil for each school in the district and the district as a whole, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district. If this State has a financial analysis program that is designed to track educational expenditures and revenues to individual schools, each school district shall use that statewide program in complying with this paragraph. If a statewide program is not available, each school district shall use its own financial analysis program in complying with this paragraph.

(f) The curriculum used by the school district, including:

(1) Any special programs for pupils at an individual school; and

(2) The curriculum used by each charter school ~~{in}~~ *sponsored by* the district.

(g) Records of the attendance and truancy of pupils in all grades, including, without limitation:

(1) The average daily attendance of pupils, for each school in the district and the district as a whole, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district.

(2) For each elementary school, middle school and junior high school in the district, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district that provides instruction to pupils enrolled in a grade level other than high school, information that compares the attendance of the pupils enrolled in the school with the attendance of pupils throughout the district and throughout this State. The information required by this subparagraph must be provided in consultation with the Department to ensure the accuracy of the comparison.

(h) The annual rate of pupils who drop out of school in grade 8 and a separate reporting of the annual rate of pupils who drop out of school in grades 9 to 12, inclusive, for each such grade, for each school in the district and for the district as a whole. The reporting for pupils in grades 9 to 12, inclusive, excludes pupils who:

(1) Provide proof to the school district of successful completion of the examinations of general educational development.

(2) Are enrolled in courses that are approved by the Department as meeting the requirements for an adult standard diploma.

(3) Withdraw from school to attend another school.

(i) Records of attendance of teachers who provide instruction, for each school in the district and the district as a whole, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district.

(j) Efforts made by the school district and by each school in the district, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district, to increase:

(1) Communication with the parents of pupils in the district; and

(2) The participation of parents in the educational process and activities relating to the school district and each school, including, without limitation, the existence of parent organizations and school advisory committees.

(k) Records of incidents involving weapons or violence for each school in the district, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district.

(l) Records of incidents involving the use or possession of alcoholic beverages or controlled substances for each school in the district, including, without limitation, each charter school ~~{in}~~ *sponsored by* the district.

1 (m) Records of the suspension and expulsion of pupils required or authorized  
2 pursuant to NRS 392.466 and 392.467.

3 (n) The number of pupils who are deemed habitual disciplinary problems  
4 pursuant to NRS 392.4655, for each school in the district and the district as a  
5 whole, including, without limitation, each charter school ~~that~~ *sponsored by* the  
6 district.

7 (o) The number of pupils in each grade who are retained in the same grade  
8 pursuant to NRS 392.033 or 392.125, for each school in the district and the district  
9 as a whole, including, without limitation, each charter school ~~that~~ *sponsored by* the  
10 district.

11 (p) The transiency rate of pupils for each school in the district and the district  
12 as a whole, including, without limitation, each charter school ~~that~~ *sponsored by* the  
13 district. For the purposes of this paragraph, a pupil is not transient if the pupil is  
14 transferred to a different school within the school district as a result of a change in  
15 the zone of attendance by the board of trustees of the school district pursuant to  
16 NRS 388.040.

17 (q) Each source of funding for the school district.

18 (r) A compilation of the programs of remedial study that are purchased in  
19 whole or in part with money received from this State, for each school in the district  
20 and the district as a whole, including, without limitation, each charter school  
21 sponsored by the district. The compilation must include:

22 (1) The amount and sources of money received for programs of remedial  
23 study for each school in the district and the district as a whole, including, without  
24 limitation, each charter school ~~that~~ *sponsored by* the district.

25 (2) An identification of each program of remedial study, listed by subject  
26 area.

27 (s) For each high school in the district, including, without limitation, each  
28 charter school ~~that~~ *sponsored by* the district, the percentage of pupils who  
29 graduated from that high school or charter school in the immediately preceding year  
30 and enrolled in remedial courses in reading, writing or mathematics at a university,  
31 state college or community college within the Nevada System of Higher Education.

32 (t) The technological facilities and equipment available at each school,  
33 including, without limitation, each charter school ~~that~~ *sponsored by the district*, and  
34 the district's plan to incorporate educational technology at each school.

35 (u) For each school in the district and the district as a whole, including, without  
36 limitation, each charter school ~~that~~ *sponsored by* the district, the number and  
37 percentage of pupils who received:

38 (1) A standard high school diploma, reported separately for pupils who  
39 received the diploma pursuant to:

40 (I) Paragraph (a) of subsection 1 of NRS 389.805; and

41 (II) Paragraph (b) of subsection 1 of NRS 389.805.

42 (2) An adjusted diploma.

43 (3) A certificate of attendance.

44 (v) For each school in the district and the district as a whole, including, without  
45 limitation, each charter school ~~that~~ *sponsored by* the district, the number and  
46 percentage of pupils who failed to pass the high school proficiency examination.

47 (w) The number of habitual truants who are reported to a school police officer  
48 or law enforcement agency pursuant to paragraph (a) of subsection 2 of NRS  
49 392.144 and the number of habitual truants who are referred to an advisory board to  
50 review school attendance pursuant to paragraph (b) of subsection 2 of NRS  
51 392.144, for each school in the district and for the district as a whole.

52 (x) The amount and sources of money received for the training and  
53 professional development of teachers and other educational personnel for each

1 school in the district and for the district as a whole, including, without limitation,

3 (y) Whether the school district has made adequate yearly progress. If the  
4 school district has been designated as demonstrating need for improvement  
5 pursuant to NRS 385.377, the report must include a statement indicating the  
6 number of consecutive years the school district has carried that designation.

7 (z) Information on whether each public school in the district, including,  
8 without limitation, each charter school ~~that~~ *sponsored by* the district, has made  
9 adequate yearly progress, including, without limitation:

10 (1) The number and percentage of schools in the district, if any, that have  
11 been designated as needing improvement pursuant to NRS 385.3623; and

12 (2) The name of each school, if any, in the district that has been designated  
13 as needing improvement pursuant to NRS 385.3623 and the number of consecutive  
14 years that the school has carried that designation.

15 (aa) Information on the paraprofessionals employed by each public school in  
16 the district, including, without limitation, each charter school ~~that~~ *sponsored by* the  
17 district. The information must include:

18 (1) The number of paraprofessionals employed at the school; and

19 (2) The number and percentage of all paraprofessionals who do not satisfy  
20 the qualifications set forth in 20 U.S.C. § 6319(c). The reporting requirements of  
21 this subparagraph apply to paraprofessionals who are employed in positions  
22 supported with Title I money and to paraprofessionals who are not employed in  
23 positions supported with Title I money.

24 (bb) For each high school in the district, including, without limitation, each  
25 charter school *sponsored by the district* that operates as a high school, information  
26 that provides a comparison of the rate of graduation of pupils enrolled in the high  
27 school with the rate of graduation of pupils throughout the district and throughout  
28 this State. The information required by this paragraph must be provided in  
29 consultation with the Department to ensure the accuracy of the comparison.

30 (cc) An identification of the appropriations made by the Legislature that are  
31 available to the school district or the schools within the district and programs  
32 approved by the Legislature to improve the academic achievement of pupils.

33 (dd) For each school in the district and the district as a whole, including,  
34 without limitation, each charter school ~~that~~ *sponsored by* the district, information  
35 on pupils enrolled in career and technical education, including, without limitation:

36 (1) The number of pupils enrolled in a course of career and technical  
37 education;

38 (2) The number of pupils who completed a course of career and technical  
39 education;

40 (3) The average daily attendance of pupils who are enrolled in a program  
41 of career and technical education;

42 (4) The annual rate of pupils who dropped out of school and were enrolled  
43 in a program of career and technical education before dropping out;

44 (5) The number and percentage of pupils who completed a program of  
45 career and technical education and who received a standard high school diploma, an  
46 adjusted diploma or a certificate of attendance; and

The Department, in consultation with the State Public Charter School Authority and each college or university within the Nevada System of Higher Education that sponsors a charter school, shall prescribe by regulation the information that must be prepared by the State Public Charter School Authority and institution, as applicable, which must include, without limitation, the information contained in paragraphs (a) to (ee), inclusive, of subsection 2, as applicable to charter schools. The Department shall provide for public dissemination of the annual report of accountability prepared pursuant to this section in the manner set forth in 20 U.S.C. § 6311(h)(2)(E) by posting a copy of the report on the Internet website maintained by the Department.

4. Review any effective practices carried out in other states to increase parental involvement and determine the feasibility of carrying out those practices in this State;

5. Identify methods to communicate effectively and provide outreach to parents and legal guardians of pupils who have limited time to become involved in the education of their children for various reasons, including, without limitation, work schedules, single-parent homes and other family obligations;

6. Identify the manner in which the level of parental involvement affects the performance, attendance and discipline of pupils;

7. Identify methods to communicate effectively with and provide outreach to parents and legal guardians of pupils who are limited English proficient;

8. Determine the necessity for the appointment of a statewide parental involvement coordinator or a parental involvement coordinator in each school district, or both;

9. On or before July 1 of each year, submit a report to the Legislative Committee on Education describing the activities of the Advisory Council and any recommendations for legislation; and

10. On or before February 1 of each odd-numbered year, submit a report to the Director of the Legislative Counsel Bureau for transmission to the next regular session of the Legislature describing the activities of the Advisory Council and any recommendations for legislation.

(g) Require the charter school or proposed charter school to request or borrow money from this State to pay the contractor or educational management organization if the contractor or educational management organization will provide financial management to the charter school or proposed charter school;

(h) Contain a provision which restricts the ability of the charter school or proposed charter school to borrow money from a person or entity other than the contractor or educational management organization;

(i) Provide for the allocation to the charter school or proposed charter school of any indirect cost incurred by the contractor or educational management organization;

(j) Authorize the payment of fees to the contractor or educational management organization which are not attributable to the actual services provided by the contractor or educational management organization;

(k) Allow any money received by the charter school or proposed charter school from this State or from the board of trustees of a school district to be transferred to or deposited in a bank, credit union or other financial institution outside this State, including money controlled by the contractor or educational management organization; or

(l) Except as otherwise provided in this paragraph, provide incentive fees to the contractor or educational management organization. A contract or a proposed contract may provide to the contractor or educational management organization incentive fees that are based on the academic improvement of pupils enrolled in the charter school.

As used in this section, "educational management organization" means a corporation, business, organization or other entity, whether or not conducted for profit, with whom a committee to form a charter school or the governing body of a charter school, as applicable, contracts to assist with the operation, management or provision and implementation of educational services and programs of the charter school or proposed charter school. **386.507 Subcommittee on Charter Schools: Appointment of members; terms.** The Subcommittee on Charter Schools of the State Board is hereby created. The President of the State Board shall appoint three members of the State Board to serve on the Subcommittee. Except as otherwise provided in this section, the members of the Subcommittee serve terms of 2 years. If a member is not reelected to the State Board during his or her service on the Subcommittee, the term of the member on the Subcommittee expires when his or her membership on the State Board expires. Members of the Subcommittee may be reappointed.

**386.508 Charter School District for State Board-Sponsored Charter Schools and Nevada System of Higher Education-Sponsored Charter Schools.** There is hereby created a school district to be designated as the Charter School District for State Board-Sponsored Charter Schools and Nevada System of Higher Education-Sponsored Charter Schools. The School District comprises only those charter schools that are sponsored by the State Board or sponsored by a college or university within the Nevada System of Higher Education. The State Board is hereby deemed the Board of Trustees of the School District. The School District is created for the sole purpose of providing local educational agency status to the School District for purposes of federal law governing charter schools.
