AN ACT relating to crimes; prohibiting the sale of black powder and smokeless gunpowder to certain persons; providing a penalty; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Chapter 476 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 ***1. Except as otherwise provided in subsection 2, any person who distributes***
4 ***black:***
5 ***(a) Black powder ~~or smokeless gunpowder~~ to a person under the age of ~~21~~***
6 ***18 years; or***
7 ***(b) Smokeless gunpowder to a person:***
8 ***(1) Under the age of 18 years; or***
9 ***(2) Under the age of 21 years, if the smokeless gunpowder is intended for***
10 ***use other than in a rifle or shotgun.***

1 ~~is guilty of a misdemeanor and shall be punished by a fine of not more than~~
2 ~~\$500.~~

3 2. A person shall be deemed to be in compliance with the provisions of
4 subsection 1 if, before the person distributes black powder or smokeless
5 gunpowder to another person, the person:

6 (a) Asks the other person to declare the intended use for the black powder or
7 smokeless gunpowder;

8 (b) Demands that the other person present a valid driver's license or other
9 written or documentary evidence which shows that the other person ~~is 21 years~~
10 ~~of age or older;~~ meets the appropriate age requirement set forth in subsection 1;

11 ~~(b)~~ (c) Is presented a valid driver's license or other written or documentary
12 evidence which shows that the other person ~~is 21 years of age or older;~~ meets
13 the appropriate age requirement set forth in subsection 1; and

14 ~~(e)~~ (d) Reasonably relies upon the declaration of intended use by the other
15 person and the driver's license or other written or documentary evidence
16 presented by the other person.

17 3. As used in this section, "distribute" has the meaning ascribed to it in
18 NRS 476.010.
