AN ACT relating to state parks; creating the Fund for State Park Interpretative and Educational Programs and Operation of Concessions; authorizing the Administrator of the Division of State Parks of the State Department of Conservation and Natural Resources to establish certain concessions within state parks; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the Division of State Parks of the State Department of Conservation
2 and Natural Resources is funded by grants and gifts of money, fees and legislative
3 appropriations. (NRS 407.075, 407.0762, 407.077) **Section 2** of this bill authorizes the
4 Administrator of the Division to establish concessions within the boundaries of any state park
5 the revenue from which is required to be deposited in the Fund for State Park Interpretative
6 and Educational Programs and Operation of Concessions. **Section 1** of this bill creates the
7 Fund for State Park Interpretative and Educational Programs and Operation of Concessions
8 for the use of the Division and provides for the expenditure of money from the Fund.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 407 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 *1. The Fund for State Park Interpretative and Educational Programs and*
4 *Operation of Concessions is hereby created as an enterprise fund for the use of*
5 *the Division to receive all revenues derived from sales of concessions and vending*
6 *machines operated within state parks and other special revenue generating*
7 *activities.*

8 *2. Money in the Fund must be invested as the money in other state funds is*
9 *invested. The interest and income earned on the money in the Fund, after*

1 *deducting any applicable charges, must be credited to the Fund. Claims against*
2 *the Fund must be paid as other claims against the State are paid.*

3 3. *In addition to any expenditure required by subsection 4, the cost of any*
4 *goods and services used for the sale of concessions and the coordination of*
5 *special revenue generating activities must be expended from the Fund.*

6 4. ~~*Upon*~~ *Money deposited in the Fund must be expended:*

7 *(a) By the Administrator, upon approval by the Director, ~~the Administrator~~*
8 *~~shall expend money deposited in the Fund~~ for special interpretative or*
9 *educational programs and special park projects that enhance the interpretative*
10 *and educational mission of the Division ~~and~~; or*

11 *(b) For any other purpose authorized by the Legislature or by the Interim*
12 *Finance Committee if the Legislature is not in session.*

13 5. *Any balance remaining in the Fund does not revert to the State General*
14 *Fund at the end of any fiscal year.*

15 **Sec. 2.** NRS 407.065 is hereby amended to read as follows:

16 407.065 1. The Administrator, subject to the approval of the Director:

17 (a) Except as otherwise provided in this paragraph, may establish, name, plan,
18 operate, control, protect, develop and maintain state parks, monuments and
19 recreational areas for the use of the general public. The name of an existing state
20 park, monument or recreational area may not be changed unless the Legislature
21 approves the change by statute.

22 (b) Shall protect state parks and property controlled or administered by the
23 Division from misuse or damage and preserve the peace within those areas. The
24 Administrator may appoint or designate certain employees of the Division to have
25 the general authority of peace officers.

26 (c) May allow multiple use of state parks and real property controlled or
27 administered by the Division for any lawful purpose, including, but not limited to,
28 grazing, mining, development of natural resources, hunting and fishing, in
29 accordance with such regulations as may be adopted in furtherance of the purposes
30 of the Division.

31 (d) Shall impose and collect reasonable fees for entering, camping and boating
32 in state parks and recreational areas. The Division shall issue, upon application
33 therefor and proof of residency and age, an annual permit for entering, camping and
34 boating in all state parks and recreational areas in this State to any person who is 65
35 years of age or older and has resided in this State for at least 5 years immediately
36 preceding the date on which the application is submitted. The permit must be issued
37 without charge, except that the Division shall charge and collect an administrative
38 fee for the issuance of the permit in an amount sufficient to cover the costs of
39 issuing the permit.

40 (e) May conduct and operate such special services as may be necessary for the
41 comfort and convenience of the general public, and impose and collect reasonable
42 fees for such special services.

43 (f) May rent or lease concessions located within the boundaries of state parks
44 or of real property controlled or administered by the Division to public or private
45 corporations, to groups of natural persons, or to natural persons for a valuable
46 consideration upon such terms and conditions as the Division deems fit and proper,
47 but no concessionaire may dominate any state park operation.

48 (g) May establish such capital projects construction funds as are necessary to
49 account for the parks improvements program approved by the Legislature. The
50 money in these funds must be used for the construction and improvement of those
51 parks which are under the supervision of the Administrator.

52 *(h) In addition to any concession specified in paragraph (f), may establish*
53 *concessions within the boundaries of any state park to provide for the sale of*

1 *food, drinks, ice, publications, sundries, gifts and souvenirs, and other such*
2 *related items as the Administrator determines are appropriately made available to*
3 *visitors. Any money received by the Administrator for a concession established*
4 *pursuant to this paragraph must be deposited in the Fund for State Park*
5 *Interpretive and Educational Programs and Operation of Concessions.*

6 2. The Administrator:

7 (a) Shall issue an annual permit to a person who pays a reasonable fee as
8 prescribed by regulation which authorizes the holder of the permit to enter each
9 state park and each recreational area in this State and, except as otherwise provided
10 in subsection 3, use the facilities of the state park or recreational area without
11 paying the entrance fee; and

12 (b) May issue an annual permit to a person who pays a reasonable fee as
13 prescribed by regulation which authorizes the holder of the permit to enter a
14 specific state park or specific recreational area in this State and, except as otherwise
15 provided in subsection 3, use the facilities of the state park or recreational area
16 without paying the entrance fee.

17 3. An annual permit issued pursuant to subsection 2 does not authorize the
18 holder of the permit to engage in camping or boating, or to attend special events.
19 The holder of such a permit who wishes to engage in camping or boating, or to
20 attend special events, must pay any fee established for the respective activity.

21 4. Except as otherwise provided in subsection 1 of NRS 407.0762 and
22 subsection 1 of NRS 407.0765, the fees collected pursuant to paragraphs (d), (e)
23 and (f) of subsection 1 or subsection 2 must be deposited in the State General Fund.

24 **Sec. 3.** This act becomes effective on July 1, 2011.
