AN ACT relating to the Nevada System of Higher Education; providing that any increase in any tuition charge, registration fee or other miscellaneous student fee assessed against a student by a university, state college or community college within the System must be retained by that institution and used to support academic programs and other services, activities and uses which advance the educational needs of the students enrolled at the institution and the educational goals of the institution or which otherwise benefit such students; requiring the Board of Regents of the University of Nevada to submit an annual report to the Director of the Legislative Counsel Bureau for transmittal to the Legislature or the Legislative Commission concerning the use of money collected from tuition charges, registration fees and other fees; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law authorizes the Board of Regents of the University of Nevada to fix a tuition
2 charge for certain students at all campuses of the Nevada System of Higher Education. Tuition
3 charges are in addition to registration fees and other charges assessed against students. (NRS
4 396.540) This bill provides that any increase in any tuition charge, registration fee or other
5 charge miscellaneous student fee assessed against a student over the amount that would
6 have been assessed on January 1, 2011, must be retained by the university, state college or
7 community college at which the student is enrolled. This bill further provides that money
8 collected from increases in tuition charges, registration fees and other charges miscellaneous student fees
9 must be used to support academic programs and other services, activities and uses which advance the educational needs of the students enrolled at the
10 institution and the educational goals of the institution or which otherwise benefit such
11 students.

12 This bill requires the Board of Regents to submit an annual report to the Director of the
13 Legislative Counsel Bureau for transmittal to the Legislature, or to the Legislative
14 Commission if the Legislature is not in session, which must include for each university, state
15 college and community college information concerning: (1) the allocation of money collected
16 from tuition charges, registration fees and other charges to each academic program; (2)

18 progress in advancing the educational goals of the institution; (3) whether the expenditure of
19 money collected from tuition charges, registration fees and other charges aligns with the
20 economic development goals identified by the Commission on Economic Development or any
21 regional economic development authority or local redevelopment agency for the region of this
22 State in which the institution is located; and (4) the number of students entering each
23 academic program or major and the number of certificates and degrees awarded by each
24 academic program and major.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 396 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 1. *Any* The amount of any tuition charge, registration fee or [other]
4 miscellaneous student fee assessed against a resident or non-resident student in
5 excess of the amount that would have been assessed as of January 1, 2011, must
6 be retained by the university, state college or community college at which the
7 student is enrolled. Money [collected from tuition charges, registration fees and
8 other fees] retained pursuant to this subsection must be used by the university,
9 state college or community college to support academic programs and other
10 services, activities and uses which advance the educational needs of the students
11 enrolled at the institution and the educational goals of the institution or which
12 otherwise benefit such students.

13 2. *The Board of Regents shall, not later than February 1 of each year,*
14 *submit to the Director of the Legislative Counsel Bureau for transmittal to the*
15 *Legislature in odd-numbered years or the Legislative Commission in even-*
16 *numbered years, a written report concerning the use of money collected from*
17 *tuition charges, registration fees and other fees by each university, state college*
18 *or community college within the System. The report must include, without*
19 *limitation, for each university, state college or community college within the*
20 *System information concerning:*

21 (a) *The allocation of money collected from tuition charges, registration fees*
22 *and other fees to each academic program offered by the university, state college*
23 *or community college;*

24 (b) *Progress in advancing the educational goals of the institution;*

25 (c) *Whether the expenditure by the institution of the money collected from*
26 *tuition charges, registration fees and other fees aligns with the economic*
27 *development goals identified by the Commission on Economic Development or*
28 *any regional economic development authority or local redevelopment agency for*
29 *the region of this State in which the institution is located; and*

30 (d) *The number of students entering each academic program and major*
31 *offered by the institution, and the number of certificates and degrees awarded by*
32 *each academic program and major.*

33 3. *As used in this section, [“tuition”]:*

34 (a) “Miscellaneous student fee” means any fee other than a tuition charge or
35 registration fee that, as of January 1, 2011, was not being retained by the
36 university, state college or community college at which the student is enrolled.
37 The term does not include a special course fee, laboratory fee or differential
38 program fee.

39 (b) “Tuition charge” has the meaning ascribed to it in NRS 396.540.

40 **Sec. 2.** This act becomes effective on July 1, 2011.
