THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General Fund to the
2 Department of Corrections the sum of ~~(\$1,420,522)~~ \$996,105 to offset a reduction
3 in funds for the State Criminal Alien Assistance Program. This appropriation is
4 supplemental to that made by section 23 of chapter 388, Statutes of Nevada 2009, at
5 page 2111.

6 **Sec. 2.** This act becomes effective upon passage and approval.
