SUMMARY—Makes appropriations for the support and evaluation of the regional training programs for the professional development of teachers and administrators. (BDR S-88)

AN ACT making appropriations for the support and evaluation of the regional training programs for the professional development of teachers and administrators; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State General Fund to the Department of Education for allocation to the school districts specified in this section the following sums for Fiscal Years 2011-2012 and 2012-2013:

Clark County School District	\$4,163,202	\$4,163,202
Elko County School District	\$1,396,043	\$1,396,043
Washoe County School District	\$2,238,559	\$2,238,559
TOTAL:	\$7,797,804	\$7,797,804

2. A school district that receives an allocation pursuant to subsection 1 shall serve as fiscal agent for the respective regional training program for the professional development of teachers and

1 administrators. As fiscal agent, each school district is responsible for
2 the payment, collection and holding of all money received from this
3 State for the maintenance and support of the regional training
4 program for the professional development of teachers and
5 administrators and the Nevada Early Literacy Intervention Program
6 established and operated by the governing body of the applicable
7 regional training program.

8 3. Any remaining balance of the appropriation made by
9 subsection 1 for the 2011-2012 Fiscal Year must be added to the
10 money received by the school districts for the 2012-2013 Fiscal
11 Year and may be expended as that money is expended. Any
12 remaining balance of the appropriation made by subsection 1 for the
13 2012-2013 Fiscal Year, including any money added from the
14 appropriation for the previous fiscal year, must not be committed for
15 expenditure after June 30, 2013, by the entity to which the
16 appropriation is made or any entity to which money from the
17 appropriation is granted or otherwise transferred in any manner, and
18 any portion of the appropriated money remaining must not be spent
19 for any purpose after September 20, 2013, by either the entity to
20 which the money was appropriated or the entity to which the money
21 was subsequently granted or transferred, and must be reverted to the
22 State General Fund on or before September 20, 2013.

23 **Sec. 2.** 1. There is hereby appropriated from the State
24 General Fund to the Department of Education for distribution to the
25 Statewide Council for the Coordination of the Regional Training
26 Programs created by NRS 391.516 the following sums for additional
27 training opportunities for educational administrators in Nevada:

28 For the Fiscal Year 2011-2012.....	\$100,000
29 For the Fiscal Year 2012-2013.....	\$100,000

30 2. The Statewide Council shall use the money:

31 (a) To disseminate research-based knowledge related to
32 effective educational leadership behaviors and skills.

33 (b) To develop, support and maintain ongoing activities,
34 programs, training and networking opportunities.

35 (c) For the purposes of providing additional training for
36 educational administrators, including, without limitation, to pay:

37 (1) Travel expenses of administrators who attend the training
38 program;

39 (2) Travel and per diem expenses for any consultants
40 contracted to provide additional training; and

41 (3) Any charges to obtain a conference room for the
42 provision of the additional training.

43 (d) To supplement and not replace the money that the school
44 district or the regional training program would otherwise expend for
45 the training of administrators as described in this section.

1 3. Any remaining balance of the sums appropriated by
2 subsection 1 for the 2011-2012 Fiscal Year must be added to the
3 money received by the Statewide Council for the 2012-2013 Fiscal
4 Year and may be expended as that money is expended. Any
5 remaining balance of the sums appropriated by subsection 1 for the
6 2012-2013 Fiscal Year, including any money added from the
7 appropriation for the previous fiscal year, must not be committed for
8 expenditure after June 30, 2013, by the entity to which the
9 appropriation is made or any entity to which money from the
10 appropriation is granted or otherwise transferred in any manner, and
11 any portion of the appropriated money remaining must not be spent
12 for any purpose after September 20, 2013, by either the entity to
13 which the money was appropriated or the entity to which the money
14 was subsequently granted or transferred, and must be reverted to the
15 State General Fund on or before September 20, 2013.

16 **Sec. 3.** 1. There is hereby appropriated from the State
17 General Fund to the Legislative Bureau of Educational
18 Accountability and Program Evaluation for an evaluation of the
19 regional training programs for the professional development of
20 teachers and administrators created by NRS 391.512:

21 For the Fiscal Year 2011-2012.....\$100,000

22 For the Fiscal Year 2012-2013.....\$100,000

23 2. The sums appropriated by subsection 1 are available for
24 either fiscal year. Any remaining balance of those sums must not be
25 committed for expenditure after June 30, 2013, by the entity to
26 which the appropriation is made or any entity to which money from
27 the appropriation is granted or otherwise transferred in any manner,
28 and any portion of the appropriated money remaining must not be
29 spent for any purpose after September 20, 2013, by either the entity
30 to which the money was appropriated or the entity to which the
31 money was subsequently granted or transferred, and must be
32 reverted to the State General Fund on or before September 20, 2013.

33 **Sec. 4.** This act becomes effective on July 1, 2011.
