

SENATE BILL NO. 11—COMMITTEE ON FINANCE

(ON BEHALF OF THE CLARK COUNTY SCHOOL DISTRICT)

PREFILED DECEMBER 13, 2010

Referred to Committee on Finance

SUMMARY—Directs the Legislative Commission to appoint a committee to conduct an interim study concerning the development of a new method for funding public schools. (BDR 34-304)

AN ACT relating to public school finance; directing the Legislative Commission to appoint a committee to conduct an interim study concerning the development of a new method for funding public schools in this State; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the Nevada Plan for School Finance provides for the
2 financial support of the school districts, charter schools and university schools for
3 profoundly gifted pupils. The formula in the Nevada Plan is expressed as: State
4 financial aid to school districts equals the difference between school district basic
5 support guarantee and local available funds produced by mandatory taxes minus all
6 the local funds attributable to pupils who reside in the county but attend a charter
7 school or a university school for profoundly gifted pupils. (NRS 387.121) **Section**
8 **22** of this bill directs the Legislative Commission to appoint a committee to conduct
9 an interim study concerning the development of a new method for funding public
10 schools in Nevada.

18 **Sec. 21.** The Legislature hereby finds and declares that:

19 1. In 1967, the Legislature, as a response to circumstances
20 prevailing at the time and to allow the State to fulfill its
21 responsibility to appropriately fund public schools, adopted a new
22 method, known as the Nevada Plan, for funding public schools;

23 2. By considering and adopting the Nevada Plan, the
24 Legislature recognized that changing circumstances in the State and
25 changes in the student population in the State would necessitate
26 changes to the Nevada Plan;

27 3. In 2011, the State and its public schools face remarkably
28 different conditions than in 1967;

29 4. Nevada is home to both one of the largest school districts in
30 the nation and one of the smallest school districts in the nation;

31 5. The educational needs and demographic characteristics of
32 students in the public schools vary widely and have disparate
33 impacts on the ability of each student to have a quality education;

34 6. The fundamental purpose of the State's public education
35 system is to ensure a reasonably equal opportunity for each student
36 to have a quality education;

37 7. The needs and characteristics of each student have a direct
38 influence on the ability of that student to take advantage of an
39 opportunity for a quality education;

40 8. Recent education reforms, including the adoption of
41 common core standards, the advancement of empowerment schools
42 and charter schools, the creation of the Teachers and Leaders
43 Council of Nevada and other important advancements in the public
44 education system will enhance the ability of public schools to meet
45 the needs of individual students;



1 9. Such reforms are specifically designed to improve and
2 advance the purpose of the State's public education system and to
3 help prepare students for higher education and for careers;

4 10. The success of these reforms depends on a funding method
5 that effectively meets the variety of individual student needs and
6 characteristics inherent in an ever-growing and increasingly diverse
7 student body;

8 11. Recent economic problems in the State have illustrated the
9 necessity of using every public dollar to its maximum benefit;

10 12. Many other states use funding systems based on individual
11 student needs and characteristics to advance their goals regarding
12 student achievement; and

13 13. A new method for funding public schools in this State is
14 necessary to continue to improve and advance the purpose of the
15 State's public education system.

16 **Sec. 22.** 1. The Legislative Commission shall appoint a
17 committee to conduct an interim study concerning the development
18 of a new method for funding public schools in this State.

19 2. The committee must be composed of six Legislators as
20 follows:

21 (a) Three members appointed by the Majority Leader of the
22 Senate, at least one of whom must be appointed from the
23 membership of the Senate Standing Committee on Education during
24 the 76th Session of the Nevada Legislature; and

25 (b) Three members appointed by the Speaker of the Assembly,
26 at least one of whom must be appointed from the membership of the
27 Assembly Standing Committee on Education during the 76th
28 Session of the Nevada Legislature.

29 3. The committee shall consult with and solicit input from
30 individuals and organizations with expertise in matters relevant to
31 the purpose of developing a new method for funding public schools
32 in this State.

33 4. Any such method proposed by the committee must:

34 (a) Be consistent with the constitutional responsibility of the
35 Legislature to provide for a uniform system of common schools; and

36 (b) Account for, and be based on, differences in the needs and
37 characteristics of individual students.

38 5. The committee shall submit a report on its findings,
39 including, without limitation, any proposed methods for funding
40 public schools in this State and any recommendations for
41 legislation, to the 77th Session of the Nevada Legislature.

42 6. The committee shall carry out the duties of this section only
43 to the extent that money is available to do so from sources
44 including, without limitation, gifts, grants and donations.
