**SUMMARY**—Requires an applicant for a contractor's license or a licensed contractor to notify the State Contractors' Board if the applicant or licensee is convicted of, or pleads guilty, guilty but mentally ill or nolo contendere to, certain crimes. (BDR 54-499)

AN ACT relating to contractors; requiring an applicant for a contractor's license or a licensed contractor to notify the State Contractors' Board if the applicant or licensee is convicted of, or pleads guilty, guilty but mentally ill or nolo contendere to, certain crimes; providing that the failure of an applicant or a licensee to submit such notification constitutes grounds for disciplinary action by the Board; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1      **Section 1** of this bill requires an applicant for a contractor's license or a  
2      licensed contractor to notify the State Contractors' Board in writing within 30 days  
3      after the applicant or licensee is convicted of, or enters a plea of guilty, guilty but  
4      mentally ill or nolo contendere, in this State or any other jurisdiction, to: (1) a crime  
5      against a child; (2) a sexual offense; (3) murder; (4) voluntary manslaughter; or (5)  
6      a felony or crime involving moral turpitude if the conviction occurred or the plea  
7      was entered in the immediately preceding 15 years.

8      **Section 2** of this bill adds to the list of grounds for disciplinary action by the  
9      Board a licensed contractor's failure to submit such notification to the Board.

10     **Section 3** of this bill requires an applicant for a contractor's license or a  
11    licensed contractor to notify the Board in writing not later than December 31, 2011,  
12    if, before July 1, 2011, the applicant or licensee was convicted of, or entered a plea

13 of guilty, guilty but mentally ill or nolo contendere, in this State or any other  
14 jurisdiction, to: (1) a crime against a child; (2) a sexual offense; (3) murder; (4)  
15 voluntary manslaughter; or (5) a felony or crime involving moral turpitude if the  
16 conviction occurred or the plea was entered in the immediately preceding 15 years.  
17 The failure of an applicant or a licensee to submit such notification constitutes  
18 grounds for refusing issuance of a license or for disciplinary action by the Board.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 624 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3     *1. An applicant for a contractor's license or a licensee shall  
4 notify the Board in writing if he or she is convicted of, or enters a  
5 plea of guilty, guilty but mentally ill or nolo contendere to:*

6         *(a) A crime against a child as that term is defined in  
7 NRS 179.245;*

8         *(b) A sexual offense as that term is defined in NRS 179.245;*

9         *(c) Murder as that term is defined in NRS 200.010;*

10         *(d) Voluntary manslaughter as that term is defined in NRS  
11 200.050; or*

12         *(e) Any other felony or crime involving moral turpitude if the  
13 conviction occurred or the plea was entered in the immediately  
14 preceding 15 years,*

15         *in this State or any other jurisdiction.*

16     *2. An applicant for a contractor's license or a licensee shall  
17 submit the notification required by subsection 1 not more than 30  
18 days after the conviction or entry of the plea of guilty, guilty but  
19 mentally ill or nolo contendere.*

20     **Sec. 2.** NRS 624.3016 is hereby amended to read as follows:

21     624.3016 The following acts or omissions, among others,  
22 constitute cause for disciplinary action under NRS 624.300:

23     1. Any fraudulent or deceitful act committed in the capacity of  
24 a contractor, including, without limitation, misrepresentation or the  
25 omission of a material fact.

26     2. A conviction of a violation of NRS 624.730, or a conviction  
27 in this State or any other jurisdiction of a felony relating to the  
28 practice of a contractor or a crime involving moral turpitude.

29     3. Knowingly making a false statement in or relating to the  
30 recording of a notice of lien pursuant to the provisions of  
31 NRS 108.226.

32     4. Failure to give a notice required by NRS 108.227, 108.245  
33 or 108.246.

1       5. Failure to comply with NRS 624.920, 624.930, 624.935 or  
2 624.940 or any regulations of the Board governing contracts for  
3 work concerning residential pools and spas.

4       6. Failure to comply with NRS 624.600.

5       7. Misrepresentation or the omission of a material fact, or the  
6 commission of any other fraudulent or deceitful act, to obtain a  
7 license.

8       8. Failure to pay an assessment required pursuant to  
9 NRS 624.470.

10      9. Failure to file a certified payroll report that is required for a  
11 contract for a public work.

12      10. Knowingly submitting false information in an application  
13 for qualification or a certified payroll report that is required for a  
14 contract for a public work.

15      ***11. Failure to notify the Board of a conviction or entry of a  
16 plea of guilty, guilty but mentally ill or nolo contendere pursuant  
17 to section 1 of this act.***

18      **Sec. 3.** 1. An applicant for a contractor's license or a  
19 licensed contractor who, before July 1, 2011, was convicted of, or  
20 entered a plea of guilty, guilty but mentally ill or nolo contendere to:

21       (a) A crime against a child as that term is defined in  
22 NRS 179.245;

23       (b) A sexual offense as that term is defined in NRS 179.245;

24       (c) Murder as that term is defined in NRS 200.010;

25       (d) Voluntary manslaughter as that term is defined in NRS  
26 200.050; or

27       (e) Any other felony or crime of moral turpitude if the  
28 conviction occurred or the plea was entered in the immediately  
29 preceding 15 years,

30       → in this State or any other jurisdiction shall notify the State  
31 Contractors' Board in writing of that conviction or entry of the plea  
32 of guilty, guilty but mentally ill or nolo contendere not later than  
33 December 31, 2011.

34       2. The failure of an applicant for a contractor's license to  
35 comply with the provisions of subsection 1 constitutes cause for  
36 refusing issuance of a license.

37       3. The failure of a licensed contractor to comply with the  
38 provisions of subsection 1 constitutes cause for disciplinary action  
39 under NRS 624.300.

40      **Sec. 4.** This act becomes effective on July 1, 2011.
