- 18 ***(b) Prepare and submit to the Board an annual report on:***
- 19 ***(1) The complaints mediated through the program;***
- 20 ***(2) The total dollar amount of claims asserted in complaints***
- 21 ***mediated through the program;***
- 22 ***(3) The number of complaints that were resolved through***
- 23 ***the program;***
- 24 ***(4) The cost in dollars paid to offenders to resolve***
- 25 ***complaints through the program; and***
- 26 ***(5) The savings in dollars between the dollar amount of***
- 27 ***claims asserted in complaints and the cost in dollars paid to***
- 28 ***offenders to resolve those complaints.***
- 29 ***3. As used in this section, "administrative act" includes an***
- 30 ***action, omission, decision, recommendation, practice or other***
- 31 ***procedure of the Department.***
