SUMMARY—Creates the Nevada Sunset Commission to evaluate certain governmental programs and services.

AN ACT relating to commissions; creating the Nevada Sunset Commission; providing for its membership; requiring the Commission to evaluate the necessity and efficacy of all governmental programs and services provided in this State; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Section 3** of this bill creates the Nevada Sunset Commission and sets forth the
2 details regarding the members of the Commission, who are appointed by seven
3 different appointing authorities. **Section 5** of this bill sets forth the duties of the
4 Commission which include, without limitation, reviewing and evaluating all
5 governmental programs and services in this State for necessity and efficacy and for
6 duplication by other programs and services offered by the Federal Government, this
7 State or local governments in this State. **Section 4** of this bill requires the
8 Commission to meet at least bimonthly and to annually report its findings and
9 recommendations to the Governor and the Legislature. **Section 6** of this bill
10 authorizes the Commission to apply for and receive gifts, grants, contributions or
11 other money to carry out its duties.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Title 18 of NRS is hereby amended by adding
2 thereto a new chapter to consist of the provisions set forth as
3 sections 2 to 6, inclusive, of this act.

4 **Sec. 2.** *As used in this chapter, unless the context otherwise
5 requires, "Commission" means the Nevada Sunset Commission
6 created by section 3 of this act.*

7 **Sec. 3. 1. The Nevada Sunset Commission is hereby
8 created.**

9 **2. The Commission consists of:**

10 (a) *One member appointed by the Governor;*
11 (b) *One member appointed by the Majority Leader of the
Senate;*

12 (c) *One member appointed by the Minority Leader of the
Senate;*

13 (d) *One member appointed by the Speaker of the Assembly;*

14 (e) *One member appointed by the Minority Leader of the
Assembly;*

15 (f) *One member appointed by the Nevada League of Cities and
Municipalities; and*

16 (g) *One member appointed by the Nevada Association of
Counties.*

17 **3. An elected officer may not be appointed or serve as a
member of the Commission.**

18 **4. The member of the Commission appointed by the Governor
serves, ex officio, as the Chair of the Commission.**

19 **5. Each member of the Commission serves at the pleasure of
the appointing authority who appointed the member.**

20 **6. After the initial terms, each member of the Commission
serves for a term of 3 years. Each member of the Commission
continues in office until the member's successor is appointed. Any
member of the Commission may be reappointed.**

21 **7. A vacancy in the membership of the Commission must be
filled in the same manner as the original appointment for the
remainder of the unexpired term.**

22 **8. The members of the Commission serve without
compensation. If sufficient money is available, the members of the
Commission are entitled to receive the per diem allowance and
travel expenses provided for state officers and employees generally
while engaged in the business of the Commission.**

23 **Sec. 4. 1. The Commission shall meet at the call of the
Chair as frequently as required to perform its duties, but no less
often than every other month.**

1 **2. A majority of the members of the Commission constitutes a
2 quorum for the transaction of business, and a majority of those
3 present at any meeting is sufficient for any official action taken by
4 the Commission.**

5 **3. The Commission shall, on or before January 1 of each
6 year, submit a report to the Governor and the Legislature, or if the
7 Legislature is not in session, to the Legislative Commission,
8 summarizing the Commission's findings and activities for the
9 previous year. In each report submitted on or before January 1 of
10 each odd-numbered year, the Commission shall include any
11 recommendations for legislation based on its review of
12 governmental programs and services for the previous biennium.**

13 **Sec. 5. The Commission shall continuously review all
14 governmental programs and services provided in this State. Such
15 review must include, without limitation:**

16 **1. An evaluation of whether the program or service is
17 effectively serving the purpose for which it was created;**

18 **2. An evaluation of the necessity of the program or service,
19 including, without limitation, a consideration of any change in
20 state or federal law since the time the program or service was
21 created; and**

22 **3. An examination of other programs and services provided
23 by the Federal Government, this State and local governments in
24 this State to determine if any other provided programs or services
25 duplicate those provided by the program or service.**

26 **Sec. 6. The Commission may apply for and receive gifts,
27 grants, contributions or other money from governmental and
28 private agencies, affiliated associations and other persons for the
29 purposes of carrying out the provisions of this chapter and for
30 defraying expenses incurred by the Commission in the discharge
31 of its duties.**

32 **Sec. 7. As soon as practicable after July 1, 2011:**

33 **1. The Governor, the Majority Leader of the Senate and the
34 Minority Leader of the Senate shall each appoint one member of the
35 Nevada Sunset Commission created by section 3 of this act to a term
36 that expires on July 1, 2013; and**

37 **2. The Speaker of the Assembly, the Minority Leader of the
38 Assembly, the Nevada League of Cities and Municipalities and the
39 Nevada Association of Counties shall each appoint one member of
40 the Nevada Sunset Commission created by section 3 of this act to a
41 term that expires on July 1, 2014.**

42 **Sec. 8. This act becomes effective on July 1, 2011.**
