SUMMARY—Revises provisions governing the issuance of special license plates. (BDR 43-1144)

AN ACT relating to motor vehicles; revising provisions governing the issuance of special license plates; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the Department of Motor Vehicles is prohibited from, at
2 any one time, issuing more than 25 separate designs of special license plates. (NRS
3 482.367008) This bill raises the maximum number of separate designs of special
4 license plates that the Department may issue, at any one time, from 25 to 30.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.367008 is hereby amended to read as
2 follows:
3 482.367008 1. As used in this section, “special license plate”
4 means:
5 (a) A license plate that the Department has designed and
6 prepared pursuant to NRS 482.367002 in accordance with the
7 system of application and petition described in that section;
8 (b) A license plate approved by the Legislature that the
9 Department has designed and prepared pursuant to NRS 482.3747,
10 482.37903, 482.37905, 482.37917, 482.379175, 482.37918,
11 482.37919, 482.3792, 482.3793, 482.37933, 482.37934, 482.37935,
12 482.379355, 482.379365, 482.37937, 482.379375, 482.37938 or
13 482.37945; and



1 (c) Except for a license plate that is issued pursuant to NRS
2 482.3785, a license plate that:

3 (1) Is approved by the Legislature after July 1, 2005; and

4 (2) Differs substantially in design from the license plates that
5 are described in subsection 1 of NRS 482.270.

6 2. Notwithstanding any other provision of law to the contrary,
7 the Department shall not, at any one time, issue more than ~~25~~ 30
8 separate designs of special license plates. Whenever the total
9 number of separate designs of special license plates issued by the
10 Department at any one time is less than ~~25~~ 30, the Department
11 shall issue a number of additional designs of special license plates
12 that have been authorized by an act of the Legislature or the
13 application for which has been approved by the Commission on
14 Special License Plates pursuant to subsection 5 of NRS 482.367004,
15 not to exceed a total of ~~25~~ 30 designs issued by the Department at
16 any one time. Such additional designs must be issued by the
17 Department in accordance with the chronological order of their
18 authorization or approval.

19 3. Except as otherwise provided in this subsection, on
20 October 1 of each year the Department shall assess the viability of
21 each separate design of special license plate that the Department is
22 currently issuing by determining the total number of validly
23 registered motor vehicles to which that design of special license
24 plate is affixed. The Department shall not determine the total
25 number of validly registered motor vehicles to which a particular
26 design of special license plate is affixed if:

27 (a) The particular design of special license plate was designed
28 and prepared by the Department pursuant to NRS 482.367002; and

29 (b) On October 1, that particular design of special license plate
30 has been available to be issued for less than 12 months.

31 4. Except as otherwise provided in subsection 6, if, on
32 October 1, the total number of validly registered motor vehicles to
33 which a particular design of special license plate is affixed is:

34 (a) In the case of special license plates designed and prepared by
35 the Department pursuant to NRS 482.367002, less than 1,000; or

36 (b) In the case of special license plates authorized directly by the
37 Legislature which are described in paragraph (b) of subsection 1,
38 less than the number of applications required to be received by the
39 Department for the initial issuance of those plates,

40 ➔ the Director shall provide notice of that fact in the manner
41 described in subsection 5.

42 5. The notice required pursuant to subsection 4 must be
43 provided:



1 (a) If the special license plate generates financial support for a
2 cause or charitable organization, to that cause or charitable
3 organization.

4 (b) If the special license plate does not generate financial
5 support for a cause or charitable organization, to an entity which is
6 involved in promoting the activity, place or other matter that is
7 depicted on the plate.

8 6. If, on December 31 of the same year in which notice was
9 provided pursuant to subsections 4 and 5, the total number of validly
10 registered motor vehicles to which a particular design of special
11 license plate is affixed is:

12 (a) In the case of special license plates designed and prepared by
13 the Department pursuant to NRS 482.367002, less than 1,000; or

14 (b) In the case of special license plates authorized directly by the
15 Legislature which are described in paragraph (b) of subsection 1,
16 less than the number of applications required to be received by the
17 Department for the initial issuance of those plates,

18 ➤ the Director shall, notwithstanding any other provision of law to
19 the contrary, issue an order providing that the Department will no
20 longer issue that particular design of special license plate. Such an
21 order does not require existing holders of that particular design of
22 special license plate to surrender their plates to the Department and
23 does not prohibit those holders from renewing those plates.

24 **Sec. 2.** This act becomes effective on July 1, 2011.
