SUMMARY—Revises provisions governing assistance to parents and relatives caring for certain persons with mental retardation and related conditions. (BDR 39-1215)

AN ACT relating to public assistance; revising provisions governing assistance provided to parents and relatives caring for certain persons with mental retardation or related conditions or children with certain developmental delays; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides assistance to parents and relatives caring for certain
2 persons with mental retardation or related conditions or, if the person being cared
3 for is under 6 years of age, similar developmental delays if certain other criteria
4 relating to income and the quality of care are met. (NRS 435.365) This bill provides
5 that such assistance is available only to the extent that money is available for that
6 purpose and requires the Division of Mental Health and Developmental Services of
7 the Department of Health and Human Services to establish a waiting list for eligible
8 applicants who are not provided assistance because of a shortage of money.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 435.365 is hereby amended to read as follows:
2 435.365 1. **[Whenever To the extent that money is available**
3 **for that purpose, whenever** a person with mental retardation or a
4 related condition is cared for by a parent or other relative with
5 whom the person lives, that parent or relative is eligible to receive

1 assistance on a monthly basis from the Division for each such
2 person who lives and is cared for in the home if the Division finds
3 that:

4 (a) The person with mental retardation or a related condition has
5 been diagnosed as having profound or severe mental retardation or,
6 if he or she is under 6 years of age, has developmental delays that
7 require support that is equivalent to the support required by a person
8 with profound or severe mental retardation or a related condition;

9 (b) The person with mental retardation or a related condition is
10 receiving adequate care; and

11 (c) The person with mental retardation or a related condition and
12 the parent or other relative with whom the person lives is not
13 reasonably able to pay for his or her care and support.

14 ➔ The amount of the assistance must be established by legislative
15 appropriation for each fiscal year.

16 2. The Division shall adopt regulations:

17 (a) Which establish a procedure of application for assistance;

18 (b) For determining the eligibility of an applicant pursuant to
19 subsection 1; and

20 (c) For determining the amount of assistance to be provided to
21 an eligible applicant.

22 3. *The Division shall establish a waiting list for applicants
23 who are eligible for assistance but who are denied assistance
24 because the legislative appropriation is insufficient to provide
25 assistance for all eligible applicants.*

26 4. The decision of the Division regarding eligibility for
27 assistance or the amount of assistance to be provided is a final
28 administrative decision.

29 **Sec. 2.** This act becomes effective on July 1, 2011.
