SUMMARY—Revises provisions relating to the financial administration of certain local governments. (BDR 30-1313)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted-material]** is material to be omitted.

AN ACT relating to local government financial administration; revising provisions regarding the establishment and maintenance of a reserve account for payment of the outstanding bonds of a school district; authorizing certain modifications after a local improvement project has begun and assessments have been levied; requiring the Regional Transportation Commission of Southern Nevada to establish a demonstration project for a toll road in connection with the Boulder City Bypass Project; authorizing the Commission to enter into one or more public-private partnerships to design, construct, develop, finance, operate or maintain the demonstration project; authorizing the issuance of certain bonds or notes of the Commission to finance the Project; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, the board of trustees of a school district may issue certain
- 2 general obligation bonds. At the time the bonds are issued, the board of trustees
- 3 must establish in its debt service fund a reserve account for payment of the
- 4 outstanding bonds of the school district. (NRS 350.020) **Section 1** of this bill
- 5 changes the amount of the reserves required to 10 percent of the outstanding
- 6 principal or 25 percent, for larger counties, and 50 percent, for smaller counties, of
- 7 the amount of principal and interest payments due on all outstanding bonds of the
- 8 school district in the next fiscal year, whichever is less.

Existing law authorizes counties, cities and towns to initiate and levy assessments and issue bonds for local improvement projects under certain conditions. (NRS 271.265, 271.270) After a governing body passes an ordinance ordering such a project, modifications may be made to the project by amending the ordinance provided that no construction contracts have yet been entered. (NRS 271.325) **Section 4** of this bill allows certain modifications to be made after the project has begun and assessments have been levied. **Section 6** of this bill provides procedures for a governing body to modify such a project without holding a hearing if, after receiving a report on the proposed modification from the municipal engineer or a competent engineer or an engineering firm hired by the governing body, the governing body determines that the magnitude of the changes to the original project do not exceed certain thresholds. **Sections 6-11** of this bill provide procedures, including procedures for notice, hearings and judicial review, for a governing body to modify such an agreement if those thresholds are exceeded. **Sections 12-14** of this bill provide further requirements for a governing body that modifies a local improvement project, and **section 15** of this bill authorizes a governing body that begins procedures to modify a local improvement project at the request of a person to require that person to pay any expenses incurred by the governing body in connection with the modification.

Section 34 of this bill requires the Regional Transportation Commission of Southern Nevada to establish a demonstration project for a toll road in connection with the Boulder City Bypass Project. **Section 34** also provides that the demonstration project must be and remain a public highway owned by the Commission. **Section 35** of this bill authorizes the Commission to enter into contracts with one or more public-private partners for planning, designing, financing, constructing, improving, maintaining, operating or acquiring rights-of-way for the demonstration project. **Section 41** of this bill requires the Commission to establish or include in a public-private partnership: (1) a schedule of user fees for the use of the demonstration project or a methodology for establishing such a schedule; and (2) administrative fines and other penalties for nonpayment of user fees. **Section 41** also authorizes the Commission to establish exemptions from the user fees for certain motor vehicles. **Section 42** of this bill provides that registered owners are subject to administrative fines and penalties for failure to pay a required user fee. **Section 42** also requires the Department of Motor Vehicles to place a hold on the renewal of the registration of a motor vehicle if the Department of Transportation or a private partner provides notice to the Department of Motor Vehicles that the registered owner of the motor vehicle has failed to pay a required user fee.

Section 43 of this bill requires that all money that is received and is to be retained by the Commission pursuant to a public-private partnership in connection with the demonstration project that is derived from the imposition of any charge with respect to the operation of any motor vehicle upon any public highway in this State must be deposited in the State Highway Fund and, except for costs of administration, must be used exclusively for the construction, maintenance and repair of the public highways of this State. **Section 43** also provides that the money must first be used to defray the obligations of the Commission under the public-private partnership, including, without limitation, the costs of administration, design, construction, operation, maintenance, financing and repair of the demonstration project.

Section 44 of this bill provides that the demonstration project and any property improvement determined by the Commission to be necessary or desirable therefor may be financed by the private partner to a public-private partnership using its own funds or obtaining funds in any lawful manner for that entity or by the issuance of revenue bonds or notes of the Commission.



Section 46 of this bill provides that a private partner is exempt from any assessment on property which the Commission provides to the private partner pursuant to a public-private partnership and on which the demonstration project is located. **Section 47** of this bill requires a private partner to pay prevailing wages to workers engaged in construction on the demonstration project.

Section 50 of this bill requires the Regional Transportation Commission of Southern Nevada to submit a report concerning the demonstration project to the Legislative Commission on or before February 1 of each even-numbered year and to the Director of the Legislative Counsel Bureau for transmittal to the Legislature on or before February 1 of each odd-numbered year. **Section 52** of this bill requires the Regional Transportation Commission of Southern Nevada to submit quarterly reports relating to the demonstration project to the Legislative Commission and the Interim Finance Committee.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 350.020 is hereby amended to read as follows:
350.020 1. Except as otherwise provided by subsections 3 and 4, if a municipality proposes to issue or incur general obligations, the proposal must be submitted to the electors of the municipality at a special election called for that purpose or the next general municipal election or general state election.

2. Such a special election may be held:

(a) At any time, including, without limitation, on the date of a primary municipal election or a primary state election, if the governing body of the municipality determines, by a unanimous vote, that an emergency exists; or

(b) On the first Tuesday after the first Monday in June of an odd-numbered year,

↪ except that the governing body shall not determine that an emergency exists if the special election is for the purpose of submitting to the electors a proposal to refund the bonds. The determination made by the governing body is conclusive unless it is shown that the governing body acted with fraud, a gross abuse of discretion or in violation of the provisions of this subsection. An action to challenge the determination made by the governing body must be commenced within 15 days after the governing body's determination is final. As used in this subsection, "emergency" means any occurrence or combination of occurrences which requires immediate action by the governing body of the municipality to prevent or mitigate a substantial financial loss to the municipality or to enable the governing body to provide an essential service to the residents of the municipality.

3. If payment of a general obligation of the municipality is additionally secured by a pledge of gross or net revenue of a project to be financed by its issue, and the governing body determines, by

1 an affirmative vote of two-thirds of the members elected to the
2 governing body, that the pledged revenue will at least equal the
3 amount required in each year for the payment of interest and
4 principal, without regard to any option reserved by the municipality
5 for early redemption, the municipality may, after a public hearing,
6 incur this general obligation without an election unless, within 90
7 days after publication of a resolution of intent to issue the bonds, a
8 petition is presented to the governing body signed by not less than 5
9 percent of the registered voters of the municipality. Any member
10 elected to the governing body whose authority to vote is limited by
11 charter, statute or otherwise may vote on the determination required
12 to be made by the governing body pursuant to this subsection. The
13 determination by the governing body becomes conclusive on the last
14 day for filing the petition. For the purpose of this subsection, the
15 number of registered voters must be determined as of the close of
16 registration for the last preceding general election. The resolution of
17 intent need not be published in full, but the publication must include
18 the amount of the obligation and the purpose for which it is to be
19 incurred. Notice of the public hearing must be published at least 10
20 days before the day of the hearing. The publications must be made
21 once in a newspaper of general circulation in the municipality.
22 When published, the notice of the public hearing must be at least as
23 large as 5 inches high by 4 inches wide.

24 4. The board of trustees of a school district may issue general
25 obligation bonds which are not expected to result in an increase in
26 the existing property tax levy for the payment of bonds of the school
27 district without holding an election for each issuance of the bonds if
28 the qualified electors approve a question submitted by the board of
29 trustees that authorizes issuance of bonds for a period of 10 years
30 after the date of approval by the voters. If the question is approved,
31 the board of trustees of the school district may issue the bonds for a
32 period of 10 years after the date of approval by the voters, after
33 obtaining the approval of the debt management commission in the
34 county in which the school district is located and, in a county whose
35 population is 100,000 or more, the approval of the oversight panel
36 for school facilities established pursuant to NRS 393.092 in that
37 county, if the board of trustees of the school district finds that the
38 existing tax for debt service will at least equal the amount required
39 to pay the principal and interest on the outstanding general
40 obligations of the school district and the general obligations
41 proposed to be issued. The finding made by the board of trustees is
42 conclusive in the absence of fraud or gross abuse of discretion. As
43 used in this subsection, "general obligations" does not include
44 medium-term obligations issued pursuant to NRS 350.087 to
45 350.095, inclusive.

5. At the time of issuance of bonds authorized pursuant to subsection 4, the board of trustees shall establish a reserve account in its debt service fund for payment of the outstanding bonds of the school district. The reserve account must be established and maintained in an amount at least equal to the lesser of :

(a) *For a school district located in a county whose population is 100,000 or more, twenty-five percent; and*

(b) *For a school district located in a county whose population is less than 100,000, fifty percent,*

➤ of the amount of principal and interest payments due on all of the outstanding bonds of the school district in the next fiscal year or 10 percent of the outstanding principal amount of the outstanding bonds of the school district.

6. If the amount in the reserve account falls below the amount required by ~~this subsection;~~ **subsection 5:**

(a) The board of trustees shall not issue additional bonds pursuant to subsection 4 until the reserve account is restored to the level required by ~~this subsection;~~ **subsection 5;** and

(b) The board of trustees shall apply all of the taxes levied by the school district for payment of bonds of the school district that are not needed for payment of the principal and interest on bonds of the school district in the current fiscal year to restore the reserve account to the level required pursuant to ~~this subsection.~~ **subsection 5.**

~~6-~~ 7. A question presented to the voters pursuant to subsection 4 may authorize all or a portion of the revenue generated by the debt rate which is in excess of the amount required:

(a) For debt service in the current fiscal year;

(b) For other purposes related to the bonds by the instrument pursuant to which the bonds were issued; and

(c) To maintain the reserve account required pursuant to subsection 5,

➤ to be transferred to the county school district's fund for capital projects established pursuant to NRS 387.328 and used to pay the cost of capital projects which can lawfully be paid from that fund. Any such transfer must not limit the ability of the school district to issue bonds during the period of voter authorization if the findings and approvals required by subsection 4 are obtained.

~~7-~~ 8. A municipality may issue special or medium-term obligations without an election.

1 **Sec. 2.** Chapter 271 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 3 to 15, inclusive, of this
3 act.

4 **Sec. 3.** *The provisions of sections 3 to 15, inclusive, of this*
5 *act shall only apply to local improvement projects or districts*
6 *created before July 1, 2011.*

7 **Sec. 4.** *After the acquisition or improvement of a project*
8 *ordered pursuant to NRS 271.325 has begun and any special*
9 *assessment thereon has been levied and divided into installments,*
10 *the governing body may modify the project subject to the*
11 *provisions of sections 3 to 15, inclusive, of this act by:*

- 12 1. *Eliminating a portion of the project;*
- 13 2. *Making changes or additions to the project;*
- 14 3. *Modifying the assessments to reflect the changes or*
15 *additions to the project;*
- 16 4. *Modifying the assessment installments and the due dates of*
17 *the assessment installments; or*
- 18 5. *Any combination of subsections 1 to 4, inclusive.*

19 **Sec. 5.** *Whenever the governing body determines that a*
20 *modification authorized pursuant to section 4 of this act is*
21 *warranted, the engineer shall prepare and file with the clerk a*
22 *report showing:*

- 23 1. *The proposed modification of the project;*
- 24 2. *If the modified portion of the project is, as modified,*
25 *functionally equivalent to that portion of the project before*
26 *modification, a statement to that effect;*
- 27 3. *The estimated cost of the project, as modified;*
- 28 4. *The amount of maximum special benefits estimated to be*
29 *derived from the project, as modified, by each tract in the*
30 *improvement district;*
- 31 5. *The modification, if any, of the assessment on each tract in*
32 *the improvement district resulting from the modification of the*
33 *project;*
- 34 6. *The modification, if any, of the assessment installments*
35 *and the due dates of the assessment installments;*
- 36 7. *A revised map showing the location of the project, as*
37 *modified;*
- 38 8. *If the assessments on each tract in the improvement district*
39 *are proposed to be modified, an assessment plat with the modified*
40 *assessments, apportioned based on the project, as modified; and*
- 41 9. *Whether, upon modification of the project the assessment*
42 *on each tract in the improvement district will exceed the estimated*
43 *maximum special benefits to be derived by each such tract from*
44 *the project.*



1 **Sec. 6. 1.** After receipt of the report required pursuant to
2 section 5 of this act, the governing body may, by ordinance and
3 without a protest hearing, modify the project, the assessments on
4 each tract in the improvement project, the assessment installments
5 and the due dates of the assessment installments as provided in the
6 report pursuant to the provisions of this section if:

7 (a) The governing body determines that the public convenience
8 and necessity require the modification;

9 (b) The owner of each tract in the improvement district which
10 is proposed to have its assessment modified or which derives
11 benefits from the portion of the project proposed to be eliminated
12 or modified or from the additions proposed to be made to the
13 project has filed written consent to the modification with the clerk
14 and there are no residential lots within 1,500 feet of the portion of
15 the project impacted;

16 (c) There has been filed with the clerk:

17 (1) Evidence that the modification has been consented to by
18 the owners of the bonds for the improvement district which are
19 payable from the assessments in the manner as provided in the
20 ordinance or in the indenture, fiscal agent agreement, resolution
21 or other instrument pursuant to which the bonds are issued; or

22 (2) An opinion from independent bond counsel stating that
23 the modification does not materially and adversely affect the
24 interests of the owners of the bonds; and

25 (d) The governing body determines that, upon modification of
26 the project and, if applicable, the assessments, the amount
27 assessed against each tract in the improvement district does not
28 exceed the maximum special benefits to be derived by each such
29 tract from the project.

30 2. A determination that is made pursuant to this section is
31 conclusive in the absence of fraud or gross abuse of discretion.

32 3. An ordinance adopted pursuant to this section may be
33 adopted as if an emergency existed.

34 **Sec. 7. 1.** After receipt of the report required pursuant to
35 section 5 of this act, if the governing body does not proceed
36 pursuant to section 6 of this act, the governing body may make a
37 provisional order by resolution to the effect that the project will be
38 modified.

39 2. In a provisional order made pursuant to subsection 1, the
40 governing body shall set a time, at least 20 days thereafter, and a
41 place at which the owner of each tract in the improvement district,
42 or any other interested person, may appear before the governing
43 body and be heard as to the propriety and advisability of modifying
44 the project and, if applicable, the assessments, the assessment
45 installments and the due dates of the assessment installments. If



1 *there are residential lots within 1,500 feet of the project or a*
2 *mobile home park is located on a tract in the improvement district,*
3 *the notice must be given to the owner of the tract and each owner*
4 *of a residential lot within 1,500 feet and each tenant of the mobile*
5 *home park.*

6 3. Notice must be given:

7 (a) By publication.

8 (b) By mail.

9 (c) By posting.

10 4. Proof of publication must be by affidavit of the publisher.

11 5. Proof of mailing and proof of posting must be by affidavit
12 of the engineer, clerk, or any deputy mailing the notice and
13 posting the notice, respectively.

14 6. Proof of publication, proof of mailing and proof of posting
15 must be maintained in the records of the municipality until all the
16 assessments appertaining to the project have been paid in full,
17 including principal, interest, penalties and any collection costs.

18 7. The notice must be prepared by the engineer, ratified by
19 the governing body and state:

20 (a) In general terms, the proposed modification of the project.

21 (b) The estimated cost of the project, as modified, and the
22 amount by which that cost is greater or less than the original cost
23 of the project, as reflected in the ordinance creating the
24 improvement district and ordering the project to be acquired or
25 improved.

26 (c) The time and place of the hearing where the governing
27 body will consider all objections to the modification of the project
28 and, if applicable, the assessments, the assessment installments
29 and the due dates of the assessment installments.

30 (d) That all written objections to the modification of the project
31 and, if applicable, the assessments, the assessment installments
32 and the due dates of the assessment installments must be filed with
33 the clerk at least 3 days before the time set for the hearing.

34 (e) That if the owners of tracts in the improvement district
35 which:

36 (1) Are proposed to have assessments modified or which
37 derive benefits from the portion of the project proposed to be
38 eliminated or changed or from the additions proposed to be made
39 to the project; and

40 (2) Upon the modification of the project and, if applicable,
41 the assessments, will in the aggregate have assessments greater
42 than 50 percent of the aggregate amount of the assessments on the
43 tracts in the improvement district which are proposed to have
44 assessments modified or which derive benefits from the portion of

1 the project proposed to be eliminated or changed or from the
2 additions proposed to be made to the project,

3 ➡ object in writing, within the time stated in paragraph (d), to
4 such modification of the project and, if applicable, the
5 assessments, the assessment installments and the due dates of the
6 installments will not be made.

7 (f) That if the assessment on any tract is increased as a result
8 of the modification of the project, the modification of the project
9 and, if applicable, the assessments, the assessment installments
10 and the due dates of the assessment installments will not be made
11 unless the owner of each such tract has consented in writing to the
12 increase.

13 (g) That the modification of the project and, if applicable, the
14 assessments, the assessment installments and the due dates of the
15 assessment installments will not be made unless there has been
16 filed with the clerk:

17 (1) Evidence that the modification is consented to:

18 (I) By the owners of the bonds for the improvement
19 district which are payable from the assessments; and

20 (II) In the same manner as amendments to the
21 ordinance creating the improvement district and ordering the
22 project to be acquired or improved, as provided in the ordinance or
23 in the indenture, fiscal agent agreement, resolution or other
24 instrument pursuant to which the bonds are issued; or

25 (2) An opinion from an independent bond counsel stating
26 that the modification does not materially adversely affect the
27 interests of the owners of the bonds.

28 (h) That all proceedings regarding and records of the
29 following are available for inspection at the office of the clerk:

30 (1) The amount of maximum special benefits estimated to
31 be derived from the project, as modified, by each tract in the
32 improvement district;

33 (2) If applicable, the modified assessment on each tract in
34 the improvement district resulting from the modification of the
35 project; and

36 (3) If applicable, the modified assessment installments and
37 the due dates of the assessment installments.

38 (i) That a person may object to the modification of the project
39 and, if applicable, the assessments, the assessment installments
40 and the due dates of the assessment installments using the
41 procedure outlined in the notice.

42 (j) That if a person objects to the amount of maximum special
43 benefits estimated to be derived from the project, as modified, or to
44 the legality of the proposed modification in any respect:



(1) The person is entitled to be represented by counsel at the hearing;

(2) Any evidence the person wants to present must be presented at the hearing; and

(3) Evidence that is not presented at the hearing may not be presented in an action brought pursuant to section 10 of this act.

8. No substantial change in the proposed modification of the project or, if applicable, the assessments, the assessment installments or the due dates of the assessment installments may be made after the first publication, posting or mailing of notice to property owners, whichever occurs first.

Sec. 8. A modification may not be made pursuant to the provisions of section 7 of this act if, within the time specified in the notice pursuant to paragraph (d) of subsection 7 of section 7 of this act, the owners of tracts in the improvement district which:

1. Are proposed to have assessments modified or which derive benefits from the portion of the project proposed to be eliminated or changed or from the additions proposed to be made to the project; and

2. Upon the modification of the project and, if applicable, the assessments, will in the aggregate have assessments greater than 50 percent of the aggregate amount of the assessments on the tracts in the improvement district which are proposed to have assessments modified or which derive benefits from the portion of the project proposed to be eliminated or changed or from the additions proposed to be made to the project,

↪ file a written objection to the modification with the clerk.

Sec. 9. 1. On the date and at the place fixed for the hearing, any and all property owners and other interested persons may present their views to the governing body with respect to the proposed modification. The governing body may adjourn the hearing from time to time.

2. After the hearing has been concluded, all written complaints, protests and objections have been read and considered, and all persons desiring to be heard in person have been heard, the governing body shall consider the arguments, if any, and any other relevant material put forth, and shall by resolution or ordinance, as the governing body determines, pass upon the merits of each such complaint, protest or objection.

3. If the governing body determines that it is not in the public interest that the proposed modification of the project and, if applicable, the assessments, the assessment installments and the due dates of the assessment installments be made, the governing body shall make an order by resolution to that effect, and thereupon the proceedings for the modification of the project and,



1 *if applicable, the assessments, the assessment installments and the*
2 *due dates of the assessment installments determined against by the*
3 *order must stop and must not be begun again until the adoption of*
4 *a new resolution.*

5 4. Any complaint, protest or objection to:

6 (a) The modification of the project or, if applicable, the
7 assessments, the assessment installments or the due dates of the
8 assessment installments;

9 (b) The estimated cost of the project, as modified;

10 (c) The method used to estimate the special benefits to be
11 derived from the project, as modified, generally or by any tract in
12 the improvement district;

13 (d) The basis established for the apportionment of the
14 assessments based on the project, as modified; or

15 (e) The regularity, validity and correctness of any other
16 proceedings or instruments taken, adopted or made before the date
17 of the hearing,

18 ↪ shall be deemed waived unless presented at the hearing
19 described in this section or in writing at the time and in the
20 manner provided by section 8 of this act.

21 **Sec. 10.** 1. Any person filing a written complaint, protest or
22 objection as provided in section 8 of this act, within 30 days after
23 the governing body has finally passed on the complaint, protest or
24 objection by resolution or ordinance as provided in subsection 2 of
25 section 9 of this act, may commence an action or suit in any court
26 of competent jurisdiction to correct or set aside the determination,
27 but thereafter all actions or suits attacking the validity of the
28 proceedings and the amount of special benefits are perpetually
29 barred.

30 2. Any person who brings an action pursuant to this section
31 must plead with particularity and prove the facts upon which he or
32 she relies to establish:

33 (a) That the estimate of the cost of the project, as modified, the
34 special benefits to be derived from the project, as modified, or the
35 method used to apportion the cost of the project, as modified, has a
36 material adverse economic impact upon that person or is
37 fraudulent, arbitrary or unsupported by substantial evidence; or

38 (b) That a provision of sections 3 to 15, inclusive, of this act
39 has been violated.

40 3. Conclusory allegations of fact or law are insufficient to
41 comply with the requirements of subsections 1 and 2.

42 4. In any action brought pursuant to this section, judicial
43 review of the proceedings is confined to the record before the
44 governing body. Evidence that has not been presented to the
45 governing body must not be considered by the court.



1 **Sec. 11. 1. After the hearing and after the governing body**
2 **has:**

3 **(a) Disposed of all verbal and written complaints, protests and**
4 **objections;**

5 **(b) Determined that no assessment on a tract in the**
6 **improvement district is increased as a result of the modification**
7 **or, if any such assessment is increased, that the written consent**
8 **described in paragraph (f) of subsection 7 of section 7 of this act**
9 **has been filed with the clerk;**

10 **(c) Determined that the written consent described in paragraph**
11 **(g) of subsection 7 of section 7 of this act has been filed with the**
12 **clerk; and**

13 **(d) Determined that no written objections to the modification**
14 **were filed pursuant to section 8 of this act,**

15 **↪ and if the governing body has jurisdiction to proceed, the**
16 **governing body shall determine whether to proceed with the**
17 **modification of the project and, if applicable, the assessments,**
18 **the assessment installments and the due dates of the assessment**
19 **installments.**

20 **2. Any determination made pursuant to this section is**
21 **conclusive in the absence of fraud or gross abuse of discretion.**

22 **Sec. 12. 1. If the governing body determines pursuant to**
23 **section 11 of this act to proceed with the modification of the**
24 **project and, if applicable, the assessments, the assessment**
25 **installments and the due dates of the assessment installments, the**
26 **governing body may, by ordinance, modify the project and, if**
27 **applicable, the assessments, the assessment installments and the**
28 **due dates of the assessment installments as provided in the report**
29 **of the engineer filed pursuant to section 5 of this act if:**

30 **(a) The governing body determines that the public convenience**
31 **and necessity require the modification; and**

32 **(b) The governing body finds and determines that, upon the**
33 **modification, the amount assessed against each tract in the**
34 **improvement district does not exceed the maximum special**
35 **benefits to be derived by such tract from the project, as modified.**

(l) That a person should object to the formation of the district using the procedure outlined in the notice if the person's support for the district is based upon a statement or representation concerning the project that is not contained in the language of the notice.

(1) The person is entitled to be represented by counsel at the hearing;

(2) Any evidence the person desires to present on these issues must be presented at the hearing; and

(j) Enter into a bond indenture, loan agreement, interest rate swap, financing agreement, security agreement, pledge agreement, credit facility, trust agreement or other financial agreement in connection with the financing of the demonstration project.

3. The demonstration project, whether planned, designed, financed, constructed, improved, maintained or operated by the Commission or private partner, must be and remain:

(a) A public highway;

(b) A public use;

(c) A public facility; and

(d) Owned by the Commission.

4. Before construction of the demonstration project begins, U.S. Highway 93 and U.S. Highway 95 shall be deemed alternate routes to the toll road which do not require a user fee. The Commission may establish one or more additional alternate routes to the toll road which do not require a user fee and which can accommodate all types of vehicles.

Sec. 35. 1. The Commission may enter into a public-private partnership with one or more private partners for planning, designing, financing, constructing, improving, maintaining, operating or acquiring rights-of-way for the demonstration project. A public-private partnership entered into pursuant to this section may include, without limitation, a concession and must be awarded through one or more solicitations that must include, without limitation, some or all of the requests for qualifications, short-listing of qualified proposers, requests for proposals, negotiations and best and final offers.

2. For any solicitation in which the Commission issues a request for qualifications, request for proposals or similar solicitation for a public-private partnership, the Commission may determine which factors it will consider and, except as otherwise provided in subsection 5, the relative weight of those factors in the evaluation process for the demonstration project to obtain the best value for the Commission.

3. Each request for proposals issued for the demonstration project must require each person submitting a proposal to include with the proposal an executive summary. The executive summary must address the major elements of the proposal but must not include the financial terms of the proposal, the financing plan or other confidential or proprietary information or trade secrets that the person submitting the proposal intends to be exempt from disclosure.

1 4. The executive summary for each proposal must be released
2 to the public by the Commission.

3 5. After evaluation of the proposals submitted in response to a
4 request for proposals, the Commission may enter into negotiations
5 with the applicant whose proposal appeared to have the best value to
6 enter into a public-private partnership. In determining the best value,
7 the Commission shall assign a relative weight of 5 percent to an
8 applicant who submits to the Commission a signed affidavit which
9 certifies that, for the planning, design, construction, improvement,
10 maintenance and operation of the demonstration project:

11 (a) At least 50 percent of all workers employed on the
12 demonstration project, including, without limitation, any employees
13 of the applicant, contractor and any subcontractors engaged in the
14 demonstration project will hold a valid driver's license or
15 identification card issued by the Department of Motor Vehicles;

16 (b) All vehicles used primarily for the demonstration project
17 will be:

18 (1) Registered and partially apportioned to Nevada pursuant
19 to the International Registration Plan, as adopted by the Department
20 of Motor Vehicles pursuant to NRS 706.826; or

21 (2) Registered in this State;

22 (c) At least 50 percent of the design professionals working on
23 the demonstration project, including, without limitation, any
24 employees of the applicant, contractor and any subcontractor
25 engaged on the demonstration project, will have a valid driver's
26 license or identification card issued by the Department of Motor
27 Vehicles;

28 (d) At least 25 percent of the suppliers of the materials used for
29 the demonstration project will be located in this State unless the
30 Commission requires the acquisition of materials or equipment that
31 cannot be obtained from a supplier located in this State; and

32 (e) The applicant, contractor and any subcontractor engaged on
33 the demonstration project will maintain and make available for
34 inspection within this State his or her records concerning payroll
35 relating to the demonstration project.

36 6. If the Commission is unable to negotiate a public-private
37 partnership with the applicant whose proposal appeared to have the
38 best value, upon such terms and conditions that the Commission
39 determines to be in the best interest of the public, the Commission
40 may suspend or terminate negotiations with that applicant. The
41 Commission may then undertake negotiations with the next highest-
42 ranked applicant in sequence until a public-private partnership is
43 entered into or a determination is made by the Commission to reject
44 all applicants that submitted proposals.



7. After the award and execution of the public-private partnership, the Commission shall make available to the applicants and the public the results of the evaluations of proposals and the final rankings of the applicants.

8. Notwithstanding any other law to the contrary, to maximize competition and to obtain the best value for the public, no part of a proposal other than the executive summary may be released or disclosed by the Commission before the award and execution of the public-private partnership and the conclusion of any specified period to protest or otherwise challenge the award, except pursuant to an administrative or judicial order requiring release or disclosure of any part of the proposal.

Sec. 36. 1. A public-private partnership awarded to an applicant who receives a preference in bidding described in subsection 5 of section 35 of this act must:

(a) Include a provision in the public-private partnership that substantially incorporates the requirements of paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this act; and

(b) Provide that a failure to comply with any requirement of paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this act is a material breach of the public-private partnership and entitles the Commission to liquidated damages only as provided in subsections 5 and 6.

2. Any contract entered into between a private partner and a contractor engaged on the demonstration project and between a contractor and any subcontractor engaged on the demonstration project must:

(a) Include a provision in the contract that substantially incorporates the requirements of paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this act; and

(b) Provide that a failure to comply with any requirement of paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this act is a material breach of the contract.

3. A person or entity who believes that an applicant has obtained a preference in bidding as described in subsection 5 of section 35 of this act but has failed to comply with a requirement of paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this act may file a written objection with the Commission. A written objection authorized pursuant to this subsection must set forth proof or substantiating evidence to support the belief of the person or entity that the applicant has failed to comply with a requirement of paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this act.

4. If the Commission receives a written objection pursuant to subsection 3, the Commission shall determine whether the objection

1 is accompanied by the proof or substantiating evidence required
2 pursuant to that subsection. If the Commission determines that the
3 objection is not accompanied by the required proof or substantiating
4 evidence, the Commission shall dismiss the objection. If the
5 Commission determines that the objection is accompanied by the
6 required proof or substantiating evidence or if the Commission
7 determines on its own initiative that proof or substantiating evidence
8 of a failure to comply with a requirement of paragraphs (a) to (e),
9 inclusive, of subsection 5 of section 35 of this act exists, the
10 Commission shall determine whether the applicant has failed to
11 comply with a requirement of paragraphs (a) to (e), inclusive, of
12 subsection 5 of section 35 of this act and the Commission may
13 proceed to award the contract accordingly or, if the contract has
14 already been awarded, seek the remedy authorized in subsection 5.

15 5. The Commission may recover, by civil action against the
16 party responsible for a failure to comply with a requirement of
17 paragraphs (a) to (e), inclusive, of subsection 5 of section 35 of this
18 act, liquidated damages as described in subsection 6 for a breach of
19 a contract for the demonstration project caused by a failure to
20 comply with a requirement of paragraphs (a) to (e), inclusive, of
21 subsection 5 of section 35 of this act. If the Commission recovers
22 liquidated damages pursuant to this subsection for a breach of a
23 contract for the demonstration project, the Commission shall report
24 to the State Contractors' Board the date of the breach, the name of
25 each entity which breached the contract and the cost of the public-
26 private partnership. The Board shall maintain this information for
27 not less than 6 years. Upon request, the Board shall provide this
28 information to any public body or its authorized representative.

29 6. If an applicant submits the affidavit described in subsection
30 1, receives a preference in bidding described in subsection 5 of
31 section 35 of this act and is awarded the public private partnership,
32 the public-private partnership, each contract between the applicant
33 and a contractor or a subcontractor or supplier and each contract
34 between a subcontractor and a subcontractor or supplier must
35 provide that:

36 (a) If a party to the contract causes a material breach of the
37 contract between the applicant and the Commission as a result of a
38 failure to comply with a requirement of paragraphs (a) to (e),
39 inclusive, of subsection 5 of section 35 of this act, the party is liable
40 to the Commission for liquidated damages in the amount of 10
41 percent of the cost of the largest contract to which he or she is a
42 party or \$50,000, whichever is less;

43 (b) The right to recover the amount determined pursuant to
44 paragraph (a) by the Commission pursuant to subsection 5 may be

2 the material breach; and

3 (c) No other party to the contract is liable to the Commission for
4 liquidated damages.

5 **Sec. 37.** 1. The provisions of NRS 338.141 apply to a
6 public-private partnership entered into pursuant to this act.

7 2. To be eligible as a private partner in connection with a
8 public-private partnership, a private partner must:

9 (a) Obtain a performance bond, payment bond, letter of credit,
10 parent guarantee or other security acceptable to the Commission, or
11 any combination thereof, as the Commission may require;

12 (b) Obtain insurance covering general liability and liability for
13 errors and omissions, in amounts determined by the Commission;

14 (c) Not have been found liable for breach of contract with
15 respect to a previous project with the Commission, other than a
16 breach for legitimate cause during the 5 years immediately
17 preceding the commencement of the solicitation of the public-
18 private partnership; and

19 (d) Not have been disqualified from being awarded a contract
20 pursuant to NRS 338.017, 338.13895 or 338.1475.

21 3. A private partner is not required to hold the licenses and
22 certifications required to undertake the work for the demonstration
23 project as a condition of eligibility to be a private partner but must
24 ensure that any work which requires a license or certification is
25 performed by persons that possess the required licenses and
26 certifications.

27 **Sec. 38.** Information obtained by or disclosed to the
28 Commission during the procurement or negotiation of a public-
29 private partnership may be kept confidential until the public-private
30 partnership is executed, except that the Commission may exempt
31 from release any proprietary information obtained by or disclosed to
32 the Commission during the procurement or negotiation.

33 **Sec. 39.** 1. Except as otherwise provided in subsection 2,
34 notwithstanding any other law to the contrary, a public-private
35 partnership may be for a term of not more than 40 years after the
36 opening of the demonstration project to the public and the
37 commencement of its full operations and collection of revenue.

38 2. A public-private partnership may be extended:

39 (a) As a result of an event in the nature of force majeure;

40 (b) As a means to compensate the private partner for events set
41 forth in the public-private partnership that entitle the private partner
42 to compensation; or

43 (c) For additional terms upon the mutual agreement of the
44 private partner and the Commission.

1 **Sec. 40.** 1. A public-private partnership entered into
2 pursuant to this act may include provisions that:

3 (a) Authorize the Commission and the private partner to charge,
4 collect, use, enforce and retain user fees, including, without
5 limitation, provisions that:

6 (1) Specify the technology to be used in the demonstration
7 project;

8 (2) Establish circumstances under which the Commission
9 may receive the revenues or a share of the revenues from such user
10 fees;

11 (3) State that the user fees may be collected directly by the
12 Commission, the private partner or by a third party engaged for that
13 purpose;

14 (4) Prescribe a formula, indexation or mechanism for the
15 adjustment of user fees during the term of the public-private
16 partnership;

39 relating to or arising out of the termination of the public-private

41 (c) Allow the Commission to accept payments of money from,
42 and share revenues with, the private partner. The Commission shall
43 deposit such money in the State Highway Fund.

(d) Address the manner in which the Commission and the private partner will share management of the risks of the demonstration project.

(e) Specify the manner in which the Commission and the private partner will share the costs of any development of the demonstration project.

(f) Allocate financial responsibility for any costs that exceed the amount specified in the public-private partnership.

(g) Establish applicable liquidated or stipulated damages to be assessed for nonperformance by the private partner.

(h) Establish performance measurements, as described in section 41 of this act, or incentives, or both.

(i) Address the acquisition of rights-of-way and other property interests that may be required for the demonstration project, including, without limitation, provisions that address the exercise of eminent domain by the Commission in the manner authorized pursuant to NRS 277A.250 and chapter 37 of NRS.

(j) Establish recordkeeping, accounting and auditing standards to be used for the project.

(k) Upon termination of the public-private partnership, address responsibility for repair, rehabilitation, reconstruction or renovations that are required for the demonstration project to meet all applicable standards set forth in the public-private partnership upon reversion of the demonstration project to the Commission.

(l) Provide for security and law enforcement.

(m) Identify any specifications of the Commission that must be satisfied, including, without limitation, provisions allowing the private partner to request and receive authorization to deviate from the specifications on making a showing satisfactory to the Commission.

(n) Specify remedies available and procedures for dispute resolution, including, without limitation, the right of the private partner to institute legal proceedings to obtain an enforceable judgment or award against the Commission in the event of a default by the Commission and procedures for the use of dispute review boards, mediation, facilitated negotiation, nonbinding and binding arbitration and other alternative dispute resolution procedures.

2. A public-private partnership entered into pursuant to this act must contain a provision by which the private partner expressly agrees to be barred from seeking injunctive or other equitable relief to delay, prevent or otherwise hinder the Commission from developing or constructing a facility which was planned at the time the public-private partnership was executed and which may impact the revenue that the private partner derives from the demonstration project developed under the public-private partnership. The



1 public-private partnership may provide for reasonable compensation
2 to the private partner for the adverse effect on revenue from the
3 demonstration project developed under the public-private
4 partnership resulting from the development or construction of
5 another facility by the Commission.

6 **Sec. 41.** 1. If the Commission enters into a public-private
7 partnership pursuant to this act, the Commission:

8 (a) Shall adopt, establish or include in the public-private
9 partnership a schedule of user fees or a methodology for
10 establishing the user fees that may be charged by the Commission or
11 a private partner for the use of the demonstration project, which may
12 include, without limitation, provisions for adjusting the user fees

34 2. The following motor vehicles are exempt from any user fee
35 established by the Commission:

36 (a) A transit bus or vanpool vehicle owned or operated by an
37 agency or political subdivision of this State or the United States, to
38 the extent that such vehicles are exempted pursuant to an agreement
39 between the agency or political subdivision and the Commission or
40 a private partner.

41 (b) An authorized emergency vehicle if the person operating it

43 (1) Responding to an emergency and its emergency lights are

(c) A vehicle that is exempt pursuant to the terms of a public-private partnership.

3. Not less frequently than once each calendar year, the Commission shall review any fee schedule established pursuant to this section and any adjustments to the fee schedule made by the Commission or a private partner to determine whether the user fees effectively manage travel times, speed and reliability with regard to the demonstration project. The Commission shall review and, if applicable, make any necessary adjustments at a public hearing held in compliance with chapter 241 of NRS.

4. The Commission or a private partner may use any method it determines appropriate to collect a user fee, including, without limitation, the issuance of invoices, prepayment requirements and the use of an electronic, video or automated collection system. An electronic, video or automated collection system may be used to verify payment or to charge the user fee to the:

(a) Account of a person whose vehicle is equipped with a transponder approved by the Commission or other automated payment technology approved by the Commission;

(b) Account of a person who otherwise registers to use the demonstration project in accordance with the policies and procedures established by the Commission or set forth in the public-private partnership; or

(c) Registered owner.

5. The name, address, other personal identifying information and trip data of a user is confidential, and the Commission, a private partner, consultant, contractor or representative thereof shall not release, sell or distribute such information without the express written consent of the user, except that the Commission or a private partner may release such information:

(a) As is necessary to collect a user fee and enforce any penalty for a violation of this act or any policies and procedures established pursuant thereto or set forth in the public-private partnership; and

(b) To a law enforcement agency pursuant to a subpoena.

6. The Commission or a private partner may solicit and contract with any person to provide services relating to the collection of a user fee.

7. The Commission shall establish a privacy policy regarding the collection and use of personal identifying information pursuant to this section. The policy must include, without limitation, provisions requiring that:

(a) Except as otherwise provided in paragraph (b), any personal identifying information used to collect and enforce user fees be destroyed not later than 30 days after the person has paid the user

1 fee and any administrative fines, late fees or other penalties and
2 charges imposed;

3 (b) Any personal identifying information collected for the
4 establishment of an account for the use of an automated collection
5 system be:

6 (1) Stored longer than 30 days only if the information is

8 billing and other activities directly related to the use of the account;
9 and

10 (2) Destroyed within 30 days after receiving written notice
11 that the person who established the account wants to close the
12 account; and

13 (c) Each person establishing an account for use in an automated
14 collection system be provided a copy, in a clear and conspicuous
15 manner, of the privacy policy required by this subsection and all
16 other applicable privacy laws.

17 **Sec. 42.** 1. Except as otherwise provided in subsection 3, a
18 registered owner who fails to pay a user fee is subject to an
19 administrative fine for nonpayment and is liable to the Commission
20 or private partner for the payment of the user fee, the administrative
21 fine and any additional charges or penalties prescribed by the
22 Commission or set forth in the public-private partnership.

23 2. If a driver or registered owner fails to pay a user fee, the
24 Commission or private partner shall provide notice of nonpayment
25 to the registered owner. The notice must describe the claimed

2 charges resulting from the failure to pay the user fee.

3 4. The Commission or a private partner may use a photo-
4 monitoring, video, image capture or other automated or technology-
5 based enforcement and collections system to detect the failure of a
6 motor vehicle to register payment of the required user fee, to detect
7 the failure of the driver or registered owner to pay a user fee or to
8 verify and assess the payment of a user fee. The data, including
9 photographs, images, videotapes and other vehicle and owner
10 information generated and obtained by the system, may be used to
11 establish the nonpayment of the user fee and to enforce collection of
12 the user fee and any administrative fines, late charges and other

27 6. Upon receipt of the notice described in subsection 5, the
28 Department of Motor Vehicles shall place a hold on the renewal of

31 7. In addition to any administrative fine, late charge or other
32 penalty or charge for nonpayment of a user fee established pursuant

1 **Sec. 43.** 1. All money that is received and is to be retained
2 by the Commission pursuant to a public-private partnership in
3 connection with the demonstration project that is derived from the
4 imposition of any charge with respect to the operation of any motor
5 vehicle upon any public highway in this State must be deposited in
6 the State Highway Fund and, except for costs of administration,
7 must be used exclusively for the design, construction, operation,
8 maintenance, financing and repair of the public highways of this
9 State. The money must first be used to defray the obligations of the
10 Commission under the public-private partnership, including, without
11 limitation, the costs of administration, design, construction,
12 operation, maintenance, financing and repair of the demonstration

14 2. Any other money received by the Commission pursuant to
15 this act or any policies or procedures established by the Commission

18 income on the money in the account, after deducting any applicable
19 charges, must be credited to the account. The money in the account
20 may be used for:

21 (a) The payment of the costs of planning, designing, financing,
22 constructing, improving, maintaining, operating or acquiring rights-
23 of-way for the demonstration project;

24 (b) The payment of the costs of administering the demonstration
25 project and enforcing the collection of user fees;

26 (c) Satisfaction of any obligations of the Commission pursuant
27 to a public-private partnership; and

28 (d) The costs of administration, construction, maintenance and
29 repair of the public highways located in Clark County.

30 **Sec. 44.** 1. The demonstration project and any property
31 improvement determined by the Commission to be necessary or
32 desirable therefor may, as determined by the Commission be
33 financed:

34 (a) By the private partner using its own funds or obtaining funds
35 in any lawful manner for that entity.

36 (b) By the issuance of revenue bonds or notes of the
37 Commission which are payable from and secured by:

38 (1) Revenues from the demonstration project, including,
39 without limitation, user fees and payments established, due and
40 collected pursuant to sections 41 and 42 of this act, other than
41 subsection 7 of section 42 of this act;

42 (2) Payments from the Commission to the private partner
43 pursuant to a public-private partnership;

44 (3) Payments from the private partner as described in section
45 43 of this act;



(4) Guarantees or other forms of financial assistance from the private partner or any other person;

(5) Any grants, donations or other sources of funding mentioned in paragraph (f), (g) or (h) of subsection 2 of section 34 of this act, if use of the money to pay and secure the payment of the principal of and interest on those bonds or notes is consistent with and not prohibited by the instrument, law or regulation under which the money is received;

(6) Interest or other gain accruing on any of the money deposited in the State Highway Fund pursuant to section 43 of this act; and

(7) Any combination thereof,

as described in the resolution authorizing the issuance of the bonds or notes. The bonds or notes may have a maturity of up to 40 years after the date of issuance. Any bonds or notes authorized by this paragraph are special, limited obligations of the Commission payable solely from the revenues specifically pledged to the payment of those obligations, as specified in the resolution for the issuance of the bonds or notes, and shall never be a debt of the State under Section 3 of Article 9 of the Constitution of the State of Nevada.

(c) By the issuance of revenue bonds or notes of the Commission, to finance the demonstration project directly or by making a loan to the private partner, pursuant to a financing agreement entered into between the Commission and the private partner to secure the bonds or notes and provide for their payment. Any bonds or notes issued under this paragraph must be solely payable from and secured by payments made by and property of and other security provided by the private partner, including, without limitation, any payments made to the private partner by the Commission pursuant to the public-private partnership. Any bonds or notes issued pursuant to this paragraph may have a maturity of up to 40 years from the date of issuance. Any bonds or notes authorized by this paragraph are special, limited obligations of the Commission payable solely from the revenues specifically pledged to the payment of those obligations, as specified in the resolution for the issuance of bonds or notes, and shall never be a debt of the State under Section 3 of Article 9 of the Constitution of the State of Nevada.

(d) By the issuance of private activity bonds or notes of the Commission or other eligible issuer, to finance the demonstration project directly or by making a loan to the private partner, pursuant to a financing agreement entered into between the Commission and the private partner for the purpose of securing the bonds or notes and providing for their payment. Any bonds or notes issued

1 pursuant to this paragraph must be payable solely from and secured
2 by payments made by and property of and other security provided
3 by the private partner, including, without limitation, any payments
4 made to the private partner by the Commission pursuant to the
5 public-private partnership. Any bonds or notes issued pursuant to

7 of issuance. Any bonds or notes authorized by this paragraph are

23 subsection 2 of section 34 of this act, or from user fees.

24 (h) By any combination of paragraphs (a) to (g), inclusive.

25 2. If so determined by the Commission, any bonds or notes
26 issued as described in paragraph (b) of subsection 1 may also be
27 payable from and secured by taxes which are credited to the State
28 Highway Fund and which would not cause the bonds or notes to
29 create a public debt under the provisions of Section 3 of Article 9 of
30 the Constitution of the State of Nevada. In addition, the Commission
31 may pledge those taxes to and use those taxes for the payment of
32 any of its obligations under a public-private partnership.

33 **Sec. 45.** 1. The Commission may acquire, condemn or hold
34 real property and related appurtenances under fee title, lease,

1 3. The Department of Transportation shall assist the
2 Commission in any way necessary for the Commission to carry out

6 **Sec. 46.** Notwithstanding any specific statute to the contrary, a
7 private partner is exempt from any assessment on property:

8 1. Which the Department of Transportation or the Commission
9 owns or acquires or in which the Department or the Commission has
10 a possessory interest;

11 2. Which the Department or the Commission provides to the
12 private partner pursuant to a public-private partnership; and

13 3. On which the demonstration project is located.

14 **Sec. 47.** A private partner who enters into a contract for
15 construction work pursuant to a public-private partnership shall pay

Sec. 51. Upon completion of the demonstration project, the Commission shall:

1. Subject to review by the Department of Transportation, conduct a cost-benefit analysis of the demonstration project; or

2. Request that the Department of Transportation conduct a cost-benefit analysis of the demonstration project.

➔ The Commission shall submit the analysis to the Director of the Legislative Counsel Bureau for transmittal to the next regular session of the Legislature.

Sec. 52. 1. In addition to the requirements of section 50 of this act, the Regional Transportation Commission of Southern Nevada shall report on the status of the demonstration project to the Legislative Commission and the Interim Finance Committee. The report must include, without limitation:

(a) The current status of the demonstration project.

(b) The amount of user fees collected by the Regional Transportation Commission of Southern Nevada and any private partners.

(c) The amount of money received by the Regional Transportation Commission of Southern Nevada in connection with the demonstration project from sources other than user fees.

(d) The amount paid by the Regional Transportation Commission of Southern Nevada under any public-private partnership.

(e) Such other information as the Legislative Commission or the Interim Finance Committee determines appropriate.

2. The report required pursuant to subsection 1 must be submitted at least quarterly and at such other times as the Legislative Commission or the Interim Finance Committee may require.
