Chairman Atkinson:

Marji Paslov Thomas:

I have prepared a Committee Brief (<u>Exhibit D</u>). I would like to cover a couple of highlights of this brief. On page 2 is the Committee activity during the 2009 Legislative Session. Assembly Commerce and Labor was one of the busiest committees, if not the busiest. The Committee considered 155 bills and passed 93 bills to the Governor. The Committee's jurisdiction in the past has generally covered commercial instruments and transactions; manufactured housing; trade regulations and practices; labor and industrial relations; professions, occupations, and businesses; banks, financial institutions, and similar entities; insurance, except measures affecting state and local revenue; energy; and public utilities.

On pages 3 through 4 are some policy issues which may arise this session. This is somewhat subjective because we do not know exactly what bills have been drafted. The issues are taken from the list of bill draft requests (BDRs) put out by the Legal Division. Generally, we have quite a few bills on health care professions, health insurance, energy, mortgage lending and foreclosure, workers' compensation and worker safety, and employee misclassification. There was an interim study regarding employee misclassification, which is available online or from me.

Page 5 has a list of session deadlines. Next Monday, February 14, 2011, is the deadline for your personal BDRs. Pages 6 through 8 show a list of agency contacts. If you need additional information or any other contacts, please feel free to contact me or access those online on the legislative website. Appendix A is a list of frequently used acronyms. Appendix B has Committee staff contact information.
