BILLS

- [S.B. 72](#) (R1) Revises provisions governing the assignment of certain criminal offenders to residential confinement. (BDR 16-120)
- [S.B. 75](#) Establishes a program to provide private equity funding to businesses engaged in certain industries in this State. (BDR 31-523)
- [S.B. 188](#) (R1) Revises provisions relating to the work schedules of certain employees of the Department of Corrections. (BDR 23-699)
- [S.B. 265](#) (R1) Revises provisions governing sentencing of criminal offenders and determining eligibility of prisoners for parole. (BDR 14-311)
- [S.B. 349](#) Provides for the establishment of a community court pilot project to provide an alternative to sentencing for misdemeanor offenders. (BDR S-387)
- [S.B. 443](#) Requires counties to pay the expense of presentence or general investigations and reports made by the Division of Parole and Probation of the Department of Public Safety. (BDR 14-1202)
