- A.B. 376 (R1) Makes various changes regarding the financing of certain local improvements with revenue pledged from sales and use taxes. (BDR 21-148)
- A.B. 472 (R1) Revises provisions relating to youth shelters. (BDR 20-1134)
- A.B. 544 (R1) Provides for uniformity in the naming of group homes and similar facilities. (BDR 20-675)
- A.B. 545 (R1) Makes changes to the population basis for the exercise of certain powers by local governments. (BDR 20-548)
