FIRST REVISED AGENDA

- [S.B. 146](#) Makes various changes relating to biodiesel. (BDR 32-218)

- [S.J.R. 12](#) Expresses opposition to the designation of certain public lands as Wild Lands and urges the Secretary of the Interior to rescind the order requiring that designation. (BDR R-1113)

- [S.B. 309](#) Authorizes a person to remove from his or her property an animal for which he or she has, by contract, provided care and shelter under certain circumstances. (BDR 50-703)
