[S.B. 364](#)                      Prohibits a person from engaging in horse tripping or organizing a horse tripping event under certain circumstances. (BDR 50-357)

[S.B. 417](#)                      Provides for the placement of recycling containers in certain locations. (BDR 40-1108)
