- [A.B. 472](#) Increases the maximum amount of the fee that the Director of the Department of Public Safety is required to establish for the Program for the Education of Motorcycle Riders. (BDR 43-1152)
- [A.B. 477](#) Makes an appropriation to the Office of the State Controller to replace computer servers for the statewide financial system. (BDR S-1176)
