[S.B. 14](#) Revises certain provisions governing highways under the jurisdiction of the Department of Transportation. (BDR 43-362) Transportation

[S.B. 43](#) Revises provisions relating to the operation or movement of certain vehicles. (BDR 43-340) Transportation
