SUMMARY—Revises provisions requiring the Board of Regents of the University of Nevada to pay certain educational fees and expenses for certain dependent children. (BDR 34-187)

AN ACT relating to education; expanding the provisions that require the Board of Regents of the University of Nevada to pay certain fees and expenses associated with undergraduate classes taken by certain dependent children to include the children of public safety officers killed in the line of duty; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the Board of Regents of the University of Nevada is
2 required, to the extent money is available, to pay certain fees and expenses
3 associated with undergraduate classes taken at a school within the Nevada System
4 of Higher Education by the dependent children of a police officer, firefighter,
5 officer of the Nevada Highway Patrol, volunteer ambulance driver or attendant who
6 was killed while performing his or her duties. (NRS 396.545) This bill expands the
7 applicability of this provision to include the payment of those fees and expenses for
8 dependent children of a public safety officer killed in the line of duty. This bill
9 further defines the term “public safety officer” to mean a person serving a public
10 agency in an official capacity, with or without compensation, as a peace officer,
11 firefighter or as a member of a rescue or emergency medical services crew.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 396.545 is hereby amended to read as follows:
2 396.545 1. To the extent of money available for this purpose,
3 the Board of Regents shall pay all registration fees, laboratory fees
4 and expenses for required textbooks and course materials assessed
5 against or incurred by a dependent child of ~~†~~;
6 ~~(a) A police officer, firefighter or officer of the Nevada~~
7 ~~Highway Patrol~~ *a public safety officer* who was killed in the line of
8 duty, ~~†~~; ~~or~~
9 ~~(b) A volunteer ambulance driver or attendant who was killed~~
10 ~~while engaged as a volunteer ambulance driver or attendant,~~
11 ~~†~~ for classes taken towards satisfying the requirements of an
12 undergraduate degree at a school within the System. No such
13 payment may be made for any fee assessed after the child reaches
14 the age of 23 years.
15 2. There is hereby created in the State General Fund a Trust
16 Account for the Education of Dependent Children. The Board of
17 Regents shall administer the Account. The Board of Regents may
18 accept gifts and grants for deposit in the Account. All money held
19 by the State Treasurer or received by the Board of Regents for that
20 purpose must be deposited in the Account. The money in the
21 Account must be invested as the money in other state accounts is
22 invested. After deducting all applicable charges, all interest and
23 income earned on the money in the Account must be credited to the
24 Account. Any money remaining in the Account at the end of a fiscal
25 year does not revert to the State General Fund, and the balance in
26 the Account must be carried forward to the next fiscal year.
27 3. For each fiscal year, the Board of Regents shall estimate:
28 (a) The amount of money in the Trust Account that is available
29 to make payments pursuant to subsection 1 for that fiscal year; and
30 (b) The anticipated amount of such payments for that fiscal year.
31 ➔ If the anticipated amount of payments estimated for the fiscal
32 year exceeds the estimated amount of money available in the
33 Account in the fiscal year for such payments, the Board of Regents
34 may request an allocation from the Contingency Account created in
35 the State General Fund pursuant to NRS 353.266 to cover the
36 projected shortfall.

35 ***(f) "Public agency" means an agency, bureau, commission,***
36 ***department or division of the State of Nevada or a political***
37 ***subdivision of the State of Nevada that provides police,***
38 ***firefighting, rescue or emergency medical services.***

39 ***(g) "Public safety officer" means a person serving a public***
40 ***agency in an official capacity, with or without compensation, as a***
41 ***peace officer, a firefighter or a member of a rescue or emergency***
42 ***medical services crew.***

43 **Sec. 2.** This act becomes effective upon passage and approval.
