AN ACT relating to governmental administration; transferring the duties of the State Advisory Board of Trustees for the Trust Relating to the Fairground to the Nevada Junior Livestock Show Board; abolishing the State Advisory Board of Trustees for the Trust Relating to the Fairground; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law creates the State Advisory Board of Trustees for the Trust
2 Relating to the Fairground and requires the Advisory Board to perform certain
3 duties relating to the real property leased to Washoe County for use as a fairground.
4 (NRS 551.020) **Section 2** of this bill abolishes the Advisory Board. **Section 1** of
5 this bill transfers the duties of the Advisory Board to the Nevada Junior Livestock
6 Show Board.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 563.080 is hereby amended to read as follows:
2 563.080 1. The Board shall have possession and care of all
3 property of the Nevada Junior Livestock Show and the Nevada
4 Youth Livestock and Dairy Show and shall be entrusted with the
5 direction of the entire business and financial affairs of these
6 exhibitions.
7 2. The Board may:
8 (a) Appoint employees and define their duties.
9 (b) Adopt bylaws, rules and regulations for the government of
10 the Nevada Junior Livestock Show Board, the Nevada Junior
11 Livestock Show and the Nevada Youth Livestock and Dairy Show
12 and for all exhibitions of livestock.
13 (c) Acquire or lease real and personal property, buildings and
14 improvements.
15 **3. *The Board shall review:***
16 ***(a) All uses of the real property leased to Washoe County for***
17 ***use as a fairground; and***
18 ***(b) Any physical improvements or changes to the facilities at***
19 ***the fairground,***
20 ***↪ to ensure that the use of the property for purposes related to***
21 ***agriculture and livestock continues to comply with the provisions***
22 ***of the trust relating to the fairground imposed upon the***
23 ***conveyance.***
24 **Sec. 2.** NRS 551.020 is hereby repealed.
25 **Sec. 3.** This act becomes effective upon passage and approval.

TEXT OF REPEALED SECTION

**551.020 State Advisory Board of Trustees for Trust
Relating to Fairground: Creation; number, appointment and
qualifications of members; duties.**

1. The State Advisory Board of Trustees for the Trust Relating to the Fairground, consisting of ten members appointed by the Governor, is hereby created.

2. The Governor shall appoint:

(a) As representatives of the Nevada State Fair Board, its President and Manager.

(b) As representatives of the Reno Rodeo Association, its President and Vice President.

(c) A representative of the 4-H Club Leaders' Council.



(d) A representative of the Nevada Junior Livestock Show Board.

(e) A member of the Legislature.

(f) A representative of the Nevada State Horsemen's Association.

(g) A prominent member of one of the cattle breeders' associations in the State, to represent those associations.

(h) A person engaged in a business related to farming or ranching.

3. The Board shall review:

(a) All uses of the real property leased to Washoe County for use as a fairground.

(b) Any physical improvements or changes to the facilities at the fairground,

↳ to ensure that the use of the property for purposes related to agriculture and livestock continues in compliance with the trust provisions imposed upon the conveyance.
