

ASSEMBLY BILL NO. 246—COMMITTEE ON NATURAL  
RESOURCES, AGRICULTURE, AND MINING

MARCH 13, 2013

Referred to Committee on Natural Resources,  
Agriculture, and Mining

SUMMARY—Prohibits the sale or transfer of ownership of a live animal at a swap meet under certain circumstances. (BDR 50-747)

AN ACT relating to animals; prohibiting the sale or transfer of ownership of a live animal at a swap meet under certain circumstances; providing exceptions; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law sets forth various requirements for operators, retailers and dealers  
2 of dogs and cats concerning the care of those dogs and cats, including, without  
3 limitation, requirements for buildings, enclosures, outdoor facilities, floor space,  
4 food and water, sanitation and examinations by veterinarians. (NRS 574.360-  
5 574.510) This bill prohibits a person from selling, attempting to sell, offering for  
6 adoption or transferring ownership of a live animal at a swap meet unless: (1) the  
7 swap meet is conducted in a county or incorporated city in this State which has  
8 adopted an ordinance authorizing the sale of a live animal at a swap meet; (2) the  
9 person sells, attempts to sell, offers for adoption or transfers ownership of  
10 the animal in accordance with the ordinance; and (3) the ordinance adopted by the  
11 county or incorporated city is substantially similar to those provisions of existing  
12 law, but is applicable to all animals for sale and all persons who sell, attempt to sell,  
13 or offer for adoption or transfer ownership of an animal at a swap meet. This bill  
14 does not apply to the transfer or sale of livestock or to the adoption of a cat or dog  
15 at an event held outdoors by an animal shelter or rescue organization that is  
16 recognized as exempt under section 501(c)(3) of the Internal Revenue Code.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 574 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3       1. *Except as otherwise provided in subsection 2, a person who*  
4 *sells or attempts to sell, offers for adoption or transfers ownership*  
5 *of a live animal at a swap meet is guilty of a misdemeanor.*

6       2. *A person may sell, attempt to sell, offer for adoption or*  
7 *transfer ownership of a live animal at a swap meet if:*

8       (a) *The swap meet is conducted in a county or incorporated*  
9 *city in this State that has adopted an ordinance authorizing the*  
10 *sale of live animals at a swap meet;*

11       (b) *The person sells, attempts to sell, offers for adoption or*  
12 *transfers ownership of the animal in accordance with the*  
13 *ordinance; and*

14       (c) *The ordinance, at a minimum:*

15       (1) *Includes provisions which are substantially similar to*  
16 *the provisions of NRS 574.360 to 574.510, inclusive, and are*  
17 *applicable to all animals offered for sale and all persons who sell,*  
18 *attempt to sell, offer for adoption or transfer ownership of an*  
19 *animal at the swap meet; and*

20       (2) *Does not authorize a person to commit an act of cruelty*  
21 *to an animal in violation of NRS 574.050 to 574.200, inclusive.*

22       3. *The provisions of this section do not:*

23       (a) *Apply to any sale or transfer of ownership of any livestock.*

24       (b) *Apply to any adoption of a dog or cat at an event held*  
25 *outdoors by an animal shelter or rescue organization that is*  
26 *recognized as exempt under section 501(c)(3) of the Internal*  
27 *Revenue Code, 26 U.S.C. § 501(c)(3).*

28       (c) *Exempt a person from complying with:*

29       (1) *Any requirement to obtain a license or other*  
30 *authorization to engage in a business in a county or incorporated*  
31 *city in this State; or*

32       (2) *Any other requirement of the county or incorporated*  
33 *city to engage in business or to sell, attempt to sell, offer for*  
34 *adoption or transfer ownership of a live animal at a swap meet.*

35       4. *As used in this section:*

36       (a) *“Livestock” has the meaning ascribed to it in*  
37 *NRS 569.0085.*

38       (b) *“Sell” means to barter, exchange, sell, trade, offer for sale,*  
39 *expose for sale, have in possession for sale, arrange the sale of or*  
40 *solicit for sale.*



- 1 (c) "Swap meet" means a flea market, open-air market or
- 2 other organized event at which two or more persons offer
- 3 merchandise for sale or exchange.
