

ASSEMBLY BILL NO. 24—COMMITTEE ON TRANSPORTATION

(ON BEHALF OF THE DEPARTMENT OF MOTOR VEHICLES)

PREFILED DECEMBER 19, 2012

Referred to Committee on Transportation

SUMMARY—Makes various changes to provisions relating to license plates. (BDR 43-367)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to motor vehicles; providing for the limited issuance of special license plates to commemorate the 150th anniversary of Nevada's admission into the Union; imposing a fee for the issuance or renewal of such license plates; revising provisions relating to the number of characters required to be contained on a license plate; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill provides for the issuance of a special license plate to commemorate
2 the 150th anniversary of Nevada's admission into the Union. Existing law provides
3 that the regular fees for the initial issuance and renewal of a special license plate are
4 \$35 and \$10, respectively, exclusive of any additional fees which may be added to
5 generate funds for a particular cause. (NRS 482.265) Unlike the fees set forth in
6 existing law, the fee set forth in this bill for the initial issuance of a special license
7 plate to commemorate the 150th anniversary (sesquicentennial) of Nevada's
8 admission into the Union is \$7.50 and there is no basic charge for the renewal of
9 the special license plates, other than the fee that is required to be distributed to the
10 Nevada Cultural Affairs Foundation. Existing law also requires \$35 of the fee
11 received by the Department of Motor Vehicles for the initial issuance of a special
12 license plate, exclusive of any additional fees which may be added to generate
13 funds for a particular cause, to be deposited in the State Highway Fund for credit to
14 the Revolving Account for the Issuance of Special License Plates. (NRS 482.1805)
15 This bill requires the Department to deposit the \$7.50 received for the initial
16 issuance of the sesquicentennial license plate with the State Treasurer for credit to
17 that Revolving Account. This bill also requires that an annual report concerning the
18 revenues received and expenditures made in connection with the issuance of the

commemorative license plates be submitted to the Director of the Legislative Counsel Bureau, and provides that in no event may the commemorative license plates be issued by the Department after October 31, 2016. For a person who is a Legislator of this State, this bill allows the commemorative license plates to be combined with special legislative license plates issued to the Legislator pursuant to NRS 482.374.

This bill also provides that the additional fees collected for the issuance of the plate must be deposited in the State General Fund. The State Treasurer is required to distribute those additional fees, on a quarterly basis, to the Nevada Cultural Affairs Foundation. This bill exempts these special license plates from: (1) the provisions that require a minimum number of applications for the plates; (2) the requirement that the Commission on Special License Plates approve or disapprove the plates; and (3) the limit on the number of separate designs of special license plates that may be issued by the Department at any one time.

Section 5 of this bill deletes the requirement that a redesign of license plates ordered by the Director of the Department: (1) be in colors that are predominately blue and silver; and (2) contain letters and numbers that are of the same size. **Sections 6 and 11-19** of this bill delete the requirement that a license plate contain a certain finite number of characters and provide instead that the Director will determine the number of characters to be contained on each license plate.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 482 of NRS is hereby amended by adding thereto a new section to read as follows:

1. Except as otherwise provided in subsection 8, the Department, in cooperation with the Nevada Cultural Affairs Foundation or its successor, shall design, prepare and issue license plates which commemorate the 150th anniversary of Nevada's admission into the Union, using any colors and designs that the Department deems appropriate.

2. The Department shall issue the commemorative license plates for a passenger car or light commercial vehicle upon application by a person who is entitled to license plates pursuant to NRS 482.265 and who otherwise complies with the requirements for registration and licensing pursuant to this chapter. A person may request that:

(a) Special legislative license plates issued to a Legislator pursuant to NRS 482.374 be combined with the commemorative license plates if that person:

(1) Qualifies for special legislative license plates issued pursuant to NRS 482.374; and

(2) Pays the fees for the special legislative license plates in addition to the fees for the commemorative license plates pursuant to subsections 3 and 4; or

(b) Personalized prestige license plates issued pursuant to NRS 482.3667 be combined with the commemorative license plates if



1 *that person pays the fees for the personalized license plates in*
2 *addition to the fees for the commemorative license plates pursuant*
3 *to subsections 3 and 4.*

4 *3. The fee for the commemorative license plates is \$7.50, in*
5 *addition to all other applicable registration and license fees and*
6 *governmental services taxes. The Department shall deposit the fee*
7 *collected pursuant to this subsection with the State Treasurer for*
8 *credit to the Revolving Account for the Issuance of Special*
9 *License Plates created pursuant to NRS 482.1805.*

10 *4. Except as otherwise provided in this subsection, in addition*
11 *to all other applicable registration and license fees and*
12 *governmental services taxes and the fees prescribed in subsection*
13 *3, a person who requests a set of the commemorative license plates*
14 *must pay for the initial issuance of the plates an additional fee of*
15 *\$25 and for each renewal of the plates a fee of \$20, to be*
16 *distributed pursuant to subsection 5. The fees otherwise required*
17 *to be paid pursuant to this subsection must not be charged after*
18 *the date announced by the Director pursuant to subsection 8.*

19 *5. The Department shall deposit the fees collected pursuant to*
20 *subsection 4 with the State Treasurer for credit to the State*
21 *General Fund. For the duration of the collection of such fees, the*
22 *State Treasurer shall, on a quarterly basis, distribute the fees to*
23 *the Nevada Cultural Affairs Foundation or its successor to be*
24 *used for:*

25 *(a) A celebration of the 150th anniversary of Nevada's*
26 *admission into the Union;*

27 *(b) Projects relating to the commemoration of Nevada's*
28 *admission to the Union, including, without limitation, historical*
29 *markers, tours of historic sites and improvements to or restoration*
30 *of historic buildings and structures;*

31 *(c) Education relating to the history of the State of Nevada;*
32 *and*

33 *(d) Other projects relating to preserving and protecting the*
34 *heritage of the State of Nevada.*

35 *6. On or before January 1 of each calendar year, the Division*
36 *of Museums and History of the Department of Tourism and*
37 *Cultural Affairs shall produce a report of:*

38 *(a) Revenues received from the issuance of the*
39 *commemorative license plates issued pursuant to the provisions of*
40 *this section; and*

41 *(b) Associated expenditures,*
42 *↪ and shall submit the report to the Director of the Legislative*
43 *Counsel Bureau for transmission to the Legislature or the*
44 *Legislative Commission, as appropriate.*

1 7. *If, during a registration year, the holder of the*
2 *commemorative license plates issued pursuant to the provisions of*
3 *this section disposes of the vehicle to which the plates are affixed,*
4 *the holder shall:*

5 (a) *Retain the commemorative license plates and affix them to*
6 *another vehicle that meets the requirements of this section if the*
7 *holder pays the fee for the transfer of the registration and any*
8 *registration fee or governmental services tax due pursuant to*
9 *NRS 482.399; or*

10 (b) *Within 30 days after removing the commemorative license*
11 *plates from the vehicle, return them to the Department.*

12 8. *The Director shall determine and, by public proclamation,*
13 *announce the last date on which the Department will issue the*
14 *commemorative license plates. The Department shall publish the*
15 *announcement on its Internet website. In no case may the date*
16 *that is determined and announced to be the last date on which the*
17 *Department will issue the commemorative license plates be after*
18 *October 31, 2016. The Department shall not issue:*

19 (a) *The commemorative license plates after the date*
20 *announced by the Director pursuant to this subsection.*

21 (b) *Replacement commemorative license plates for those*
22 *license plates more than 5 years after the date announced by the*
23 *Director pursuant to this subsection.*

24 **Sec. 2.** NRS 482.1805 is hereby amended to read as follows:

25 482.1805 1. The Revolving Account for the Issuance of
26 Special License Plates is hereby created as a special account in the
27 State Highway Fund. An amount equal to \$35 of the fee received by
28 the Department for the initial issuance of a special license plate, not
29 including any additional fee which may be added to generate
30 financial support for a particular cause or charitable organization,
31 must be deposited in the State Highway Fund for credit to the
32 Account.

33 2. The Department shall use the money in the Account to:

34 (a) Pay the expenses involved in issuing special license plates;
35 and

36 (b) Purchase improved and upgraded technology, including,
37 without limitation, digital technology for the production of special
38 license plates, to ensure that special license plates are produced in
39 the most efficient manner possible.

40 3. Money in the Account must be used only for the purposes
41 specified in subsection 2.

42 4. At the end of each fiscal year, the State Controller shall
43 transfer from the Account to the State Highway Fund an amount of
44 money equal to the balance in the Account which exceeds \$50,000.

5. The provisions of this section do not apply to section 1 of this act.

Sec. 3. NRS 482.216 is hereby amended to read as follows:

482.216 1. Upon the request of a new vehicle dealer, the Department may authorize the new vehicle dealer to:

(a) Accept applications for the registration of the new motor vehicles he or she sells and the related fees and taxes;

(b) Issue certificates of registration to applicants who satisfy the requirements of this chapter; and

(c) Accept applications for the transfer of registration pursuant to NRS 482.399 if the applicant purchased from the new vehicle dealer a new vehicle to which the registration is to be transferred.

2. A new vehicle dealer who is authorized to issue certificates of registration pursuant to subsection 1 shall:

(a) Transmit the applications received to the Department within the period prescribed by the Department;

(b) Transmit the fees collected from the applicants and properly account for them within the period prescribed by the Department;

(c) Comply with the regulations adopted pursuant to subsection 4; and

(d) Bear any cost of equipment which is necessary to issue certificates of registration, including any computer hardware or software.

3. A new vehicle dealer who is authorized to issue certificates of registration pursuant to subsection 1 shall not:

(a) Charge any additional fee for the performance of those services;

(b) Receive compensation from the Department for the performance of those services;

(c) Accept applications for the renewal of registration of a motor vehicle; or

(d) Accept an application for the registration of a motor vehicle if the applicant wishes to:

(1) Obtain special license plates pursuant to NRS 482.3667 to 482.3823, inclusive ~~§~~, **and section 1 of this act**; or

(2) Claim the exemption from the governmental services tax provided pursuant to NRS 361.1565 to veterans and their relations.

4. The Director shall adopt such regulations as are necessary to carry out the provisions of this section. The regulations adopted pursuant to this subsection must provide for:

(a) The expedient and secure issuance of license plates and decals by the Department; and

(b) The withdrawal of the authority granted to a new vehicle dealer pursuant to subsection 1 if that dealer fails to comply with the regulations adopted by the Department.

Sec. 4. NRS 482.265 is hereby amended to read as follows:

482.265 1. The Department shall furnish to every owner whose vehicle is registered two license plates for a motor vehicle other than a motorcycle and one license plate for all other vehicles required to be registered hereunder. Upon renewal of registration, the Department may issue one or more license plate stickers, tabs or other suitable devices in lieu of new license plates.

2. The Director shall have the authority to require the return to the Department of all number plates upon termination of the lawful use thereof by the owner under this chapter.

3. Except as otherwise specifically provided by statute, for the issuance of each special license plate authorized pursuant to this chapter:

(a) The fee to be received by the Department for the initial issuance of the special license plate is \$35, exclusive of any additional fee which may be added to generate funds for a particular cause or charitable organization;

(b) The fee to be received by the Department for the renewal of the special license plate is \$10, exclusive of any additional fee which may be added to generate financial support for a particular cause or charitable organization; and

(c) The Department shall not design, prepare or issue a special license plate unless, within 4 years after the date on which the measure authorizing the issuance becomes effective, it receives at least 250 applications for the issuance of that plate.

4. The provisions of subsection 3 do not apply to section 1 of this act.

Sec. 5. NRS 482.270 is hereby amended to read as follows:

482.270 1. Except as otherwise provided in this section or by specific statute, the Director shall order the redesign and preparation of motor vehicle license plates . ~~[with colors that are predominately blue and silver. The Director may substitute white in place of silver when no suitable material is available.]~~

2. Except as otherwise provided in subsection 3, the Department shall, upon the payment of all applicable fees, issue redesigned motor vehicle license plates pursuant to this section to persons who apply for the registration or renewal of the registration of a motor vehicle on or after January 1, 2001.

3. The Department shall not issue redesigned motor vehicle license plates pursuant to this section to a person who was issued motor vehicle license plates before January 1, 1982, or pursuant to NRS 482.3747, 482.3763, 482.3775, 482.378 or 482.379, *or section 1 of this act* without the approval of the person.

4. The Director may determine and vary the size, shape and form and the material of which license plates are made, but each

1 license plate must be of sufficient size to be plainly readable from a
2 distance of 100 feet during daylight. All license plates must be
3 treated to reflect light and to be at least 100 times brighter than
4 conventional painted number plates. When properly mounted on an
5 unlighted vehicle, the license plates, when viewed from a vehicle
6 equipped with standard headlights, must be visible for a distance of
7 not less than 1,500 feet and readable for a distance of not less than
8 110 feet.

9 5. Every license plate must have displayed upon it:

10 (a) The registration number, or combination of letters and
11 numbers, assigned to the vehicle and to the owner thereof;

12 (b) The name of this State, which may be abbreviated;

13 (c) If issued for a calendar year, the year; and

14 (d) If issued for a registration period other than a calendar year,
15 the month and year the registration expires.

23 suggested pursuant to paragraph (e) of subsection 2 of that section;

25 (b) The remainder of the plate conforms to the requirements for

27 **Sec. 6.** NRS 482.272 is hereby amended to read as follows:

28 482.272 Each license plate for a motorcycle may contain ~~up to~~
29 ~~six~~ **a number of** characters, including numbers and letters ~~+~~ **, as**
30 **determined necessary by the Director.** Only one plate may be
31 issued for a motorcycle.

32 **Sec. 7.** NRS 482.367002 is hereby amended to read as
33 follows:

34 482.367002 1. A person may request that the Department
35 design, prepare and issue a special license plate by submitting an
36 application to the Department. A person may submit an application
37 for a special license plate that is intended to generate financial
38 support for an organization only if:

39 (a) For an organization which is not a governmental entity, the
40 organization is established as a nonprofit charitable organization
41 which provides services to the community relating to public health,
42 education or general welfare;

43 (b) For an organization which is a governmental entity, the
44 organization only uses the financial support generated by the special

1 license plate for charitable purposes relating to public health,
2 education or general welfare;

3 (c) The organization is registered with the Secretary of State, if
4 registration is required by law, and has filed any documents required
5 to remain registered with the Secretary of State;

6 (d) The name and purpose of the organization do not promote,
7 advertise or endorse any specific product, brand name or service that
8 is offered for profit;

9 (e) The organization is nondiscriminatory; and

10 (f) The license plate will not promote a specific religion, faith or
11 antireligious belief.

12 2. An application submitted to the Department pursuant to
13 subsection 1:

14 (a) Must be on a form prescribed and furnished by the
15 Department;

16 (b) Must specify whether the special license plate being
17 requested is intended to generate financial support for a particular
18 cause or charitable organization and, if so, the name of the cause or
19 charitable organization;

20 (c) Must include proof that the organization satisfies the
21 requirements set forth in subsection 1;

22 (d) Must be accompanied by a surety bond posted with the
23 Department in the amount of \$5,000; and

24 (e) May be accompanied by suggestions for the design of and
25 colors to be used in the special license plate.

26 3. The Department may design and prepare a special license
27 plate requested pursuant to subsection 1 if:

28 (a) The Department determines that the application for that plate
29 complies with subsection 2; and

30 (b) The Commission on Special License Plates approves the

33 4. Except as otherwise provided in NRS 482.367008, the

10 have been issued pursuant to the assessment of the viability of the
11 design of the special license plate conducted pursuant to
12 NRS 482.367008.

13 6. If, during a registration year, the holder of license plates
14 issued pursuant to the provisions of this section disposes of the
15 vehicle to which the plates are affixed, the holder shall:

16 (a) Retain the plates and affix them to another vehicle that meets
17 the requirements of this section if the holder pays the fee for the
18 transfer of the registration and any registration fee or governmental
19 services tax due pursuant to NRS 482.399; or

29 the Assembly Standing Committee on Transportation during the
30 most recent legislative session. That Legislator may designate an
31 alternate to serve in place of the Legislator when absent. The
32 alternate must be another Legislator who also served on the
33 Assembly Standing Committee on Transportation during the most
34 recent legislative session.

35 (2) One of whom is the Legislator who served as the Chair of
36 the Senate Standing Committee on Transportation during the most
37 recent legislative session. That Legislator may designate an alternate
38 to serve in place of the Legislator when absent. The alternate must

40 Committee on Transportation during the most recent legislative
41 session.

42 (b) Three nonvoting members consisting of:

(2) The Director of the Department of Public Safety, or a designee of the Director.

(3) The Director of the Department of Tourism and Cultural Affairs, or a designee of the Director.

2. Each member of the Commission appointed pursuant to paragraph (a) of subsection 1 serves a term of 2 years, commencing on July 1 of each odd-numbered year. A vacancy on the Commission must be filled in the same manner as the original appointment.

3. Members of the Commission serve without salary or compensation for their travel or per diem expenses.

4. The Director of the Legislative Counsel Bureau shall provide administrative support to the Commission.

5. The Commission shall approve or disapprove:

(a) Applications for the design, preparation and issuance of special license plates that are submitted to the Department pursuant to subsection 1 of NRS 482.367002;

(b) The issuance by the Department of special license plates that have been designed and prepared pursuant to NRS 482.367002; and

(c) Except as otherwise provided in subsection 6, applications for the design, preparation and issuance of special license plates that have been authorized by an act of the Legislature after January 1, 2007.

➤ In determining whether to approve such an application or issuance, the Commission shall consider, without limitation, whether it would be appropriate and feasible for the Department to, as applicable, design, prepare or issue the particular special license plate. The Commission shall consider each application in the chronological order in which the application was received by the Department.

6. The provisions of paragraph (c) of subsection 5 do not apply with regard to special license plates that are issued pursuant to NRS 482.3785 or 482.3787 **H or section 1 of this act.**

7. The Commission shall:

(a) Approve or disapprove any proposed change in the distribution of money received in the form of additional fees. As used in this paragraph, "additional fees" means the fees that are charged in connection with the issuance or renewal of a special license plate for the benefit of a particular cause, fund or charitable organization. The term does not include registration and license fees or governmental services taxes.

(b) If it approves a proposed change pursuant to paragraph (a) and determines that legislation is required to carry out the change, request the assistance of the Legislative Counsel in the preparation of a bill draft to carry out the change.

26 have been authorized by an act of the Legislature or the application
27 for which has been approved by the Commission on Special License
