SUMMARY—Makes various changes to the Charter of Carson City. (BDR S-41)

AN ACT relating to the Charter of Carson City; revising provisions of the Charter relating to the Charter Committee; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

The Charter of Carson City provides for the appointment of a Charter Committee to advise the Board of Supervisors concerning potential amendments to the Charter. (Carson City Charter §§ 1.080, 1.090) Currently, each Supervisor and each member of the Senate and Assembly delegation representing the residents of Carson City nominates at least one person for membership on the Charter Committee, and the Board appoints the members of the Committee. The Charter also provides that each member of the Committee serves a term concurrent with the term of the public officer who nominated him or her for appointment. (Carson City Charter § 1.080) **Section 1** of this bill revises the appointment process to provide that the Mayor, each other member of the Board and each member of the Senate and Assembly delegation representing the residents of Carson City is to appoint one member of the Committee. **Section 1** also provides that each member of the Committee serves a term concurrent to the term of the public officer by whom he or she was appointed, or at the pleasure of that public officer.

Section 1.5 of this bill revises provisions of the current Charter governing the meetings and duties of the Committee.

The current Charter also authorizes the Board of Supervisors to remove members of the Committee for good cause and requires the Board to fill any vacancy that occurs on the Committee. (Carson City Charter § 1.100) **Section 2** of

20 this bill authorizes the public officer, or his or her successor, who has appointed a
21 member of the Committee to remove the member with or without cause and fill any
22 vacancy created by the removal or resignation of a member.

23 **Section 3** of this bill provides that a member who is serving on the Committee
24 as of the effective date of this bill (January 1, 2014) may continue to serve until the
25 expiration of his or her term or until he or she is removed.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 1.080 of the Charter of Carson City, being
2 chapter 341, Statutes of Nevada 1999, at page 1406, is hereby
3 amended to read as follows:

4 Sec. 1.080 Charter Committee: ~~Nomination;~~
5 ~~appointment; terms;~~ Appointment; qualifications; ~~terms;~~
6 compensation.

7 1. The ~~candidates for membership on~~ members of the
8 Charter Committee must be ~~nominated~~ appointed as
9 follows:

10 (a) ~~Each Supervisor~~ The Mayor and each other

13 (b) Each member of the Senate and Assembly delegation

25 (c) Reside in Carson City during his or her term of office;
26 and

27 (d) Serve without compensation.

28 **Sec. 1.5.** Section 1.090 of the Charter of Carson City, being
29 chapter 341, Statutes of Nevada 1999, as amended by chapter 68,
30 Statutes of Nevada 2003, at page 451, is hereby amended to read as
31 follows:

32 Sec. 1.090 Charter Committee: Officers; meetings;
33 duties. The Charter Committee shall:

1 1. Elect ~~a Chair and Vice Chair~~ from among its
2 members **a Chair and Vice Chair**, who each serve for a term
3 of 2 years ~~unless he or she resigns or is removed from the~~
4 ~~Committee pursuant to section 1.100;~~

5 2. Meet at least once every 2 years before the beginning
6 of each regular session of the Legislature and when requested
7 by the Board or the Chair of the Committee;

8 3. ~~Meet jointly with the Board on a date to be set after~~
9 ~~the final biennial meeting of the Committee is conducted~~
10 ~~pursuant to subsection 2 and before the beginning of the next~~
11 ~~regular session of the Legislature to advise the Board with~~
12 ~~regard to the recommendations of the Committee concerning~~
13 ~~necessary amendments to this Charter; and~~

14 4. ~~Assist the Board in the timely preparation of such~~
15 **Prepare recommendations to be presented to the Legislature**
16 **on behalf of the City concerning all necessary amendments**

19 for presentation to the Legislature ~~on behalf of the City~~
20 **by the Committee; and**

21 5. **Perform all functions and do all things necessary to**
22 **accomplish the purposes for which it is established,**
23 **including, without limitation, hold meetings and public**
24 **hearings and obtain assistance from officers of the City.**

25 Sec. 2. Section 1.100 of the Charter of Carson City, being
26 chapter 341, Statutes of Nevada 1999, at page 1406, is hereby
27 amended to read as follows:

28 Sec. 1.100 Charter Committee: Removal ~~of~~ **of**
29 **members;** vacancies.

30 1. A member of the Charter Committee may be removed
31 by the ~~Board for:~~

32 ~~(a) Missing three consecutive regular meetings; or~~

33 ~~(b) Other good cause.~~ **public officer, or his or her**
34 **successor in office, who appointed the member.**

35 2. ~~The Board shall fill any~~ **Any** vacancy that occurs on
36 the Charter Committee ~~for the unexpired term.~~ **must be**
37 **filled as provided by section 1.080.**

38 Sec. 3. 1. Any person who is serving as a member of the
39 Charter Committee of Carson City on January 1, 2014, and is
40 qualified to serve in that capacity pursuant to subsection 2 of section
41 1.080 of the Charter of Carson City, as amended by section 1 of this
42 act, may continue to serve until:

43 (a) The expiration of his or her term; or

44 (b) He or she is removed pursuant to section 1.100 of the
45 Charter, as amended by section 2 of this act.

1 2. Any person described in subsection 1 whose term expires on
2 or after January 1, 2014, may be reappointed to the Charter
3 Committee pursuant to section 1.080 of the Charter, as amended by
4 section 1 of this act.

5 **Sec. 4.** This act becomes effective on January 1, 2014.
