AN ACT relating to public employees; increasing the maximum period during which certain public officers and employees of the State who are active members of the military must be relieved from their duties to serve under orders without loss of compensation; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1        This bill increases, from not more than 15 working days to not more than 39  
2        working days in a calendar year, the period during which certain public officers and  
3        employees of the State who are active members of the military must be relieved  
4        from their duties as public officers and employees to serve under orders without  
5        loss of compensation.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1        **Section 1.** NRS 281.145 is hereby amended to read as follows:  
2        281.145 **[Any]**

3        **1. Except as otherwise provided in subsection 2, any** public  
4        officer or employee of the State or any agency thereof, or of a  
5        political subdivision or an agency of a political subdivision, who is  
6        an active member of the United States Army Reserve, the United  
7        States Naval Reserve, the United States Marine Corps Reserve, the  
8        United States Coast Guard Reserve, the United States Air Force

1 Reserve or the Nevada National Guard must be relieved from the  
2 officer's or employee's duties, upon the officer's or employee's  
3 request, to serve under orders without loss of the officer's or  
4 employee's regular compensation for a period of not more than 15  
5 working days in any 1 calendar year. No such absence may be a part  
6 of the employee's annual vacation provided for by law.

7     *2. Any public officer or employee of the State or any agency  
8 thereof whose work schedule includes Saturday or Sunday and  
9 who is an active member of the United States Army Reserve, the  
10 United States Naval Reserve, the United States Marine Corps  
11 Reserve, the United States Coast Guard Reserve, the United States  
12 Air Force Reserve or the Nevada National Guard must be relieved  
13 from the officer's or employee's duties, upon the officer's or  
14 employee's request, to serve under orders without loss of the  
15 officer's or employee's regular compensation for a period of not  
16 more than 39 working days in any 1 calendar year. No such  
17 absence may be a part of the employee's annual vacation provided  
18 for by law.*
