AN ACT relating to crimes; revising the provisions governing the crime of sexual conduct between certain school employees or volunteers at a school and a pupil; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law prohibits a person who is employed in a position of authority or
2 who volunteers in a position of authority at a public or private school from
3 engaging in sexual conduct with a pupil who is enrolled in or attending the public
4 school or private school at which the person is employed or volunteering. (NRS
5 201.540) This bill expands this provision by prohibiting a person who is employed
6 in a position of authority or who volunteers in a position of authority at a public
7 school or private school from engaging in sexual conduct with a pupil with whom
8 the person has had contact in the course of performing his or her duties as an
9 employee or volunteer.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 201.540 is hereby amended to read as follows:
2 201.540 1. Except as otherwise provided in subsection 4, a
3 person who:
4 (a) Is 21 years of age or older;



1 (b) Is employed in a position of authority by a public school or
2 private school or volunteering in a position of authority at a public
3 or private school; and

4 (c) Engages in sexual conduct with a pupil ~~{who}~~ :

5 (1) *Who* is 16 or 17 years of age ; and ~~{who is enrolled in or~~
6 ~~attending the public school or private school at which}~~

7 (2) *With whom* the person ~~{is employed or volunteering,}~~
8 *has had contact in the course of performing his or her duties as an*
9 *employee or volunteer,*

10 ➤ is guilty of a category C felony and shall be punished as provided
11 in NRS 193.130.

12 2. Except as otherwise provided in subsection 4, a person who:

13 (a) Is 21 years of age or older;

14 (b) Is employed in a position of authority by a public school or
15 private school or volunteering in a position of authority at a public
16 or private school; and

17 (c) Engages in sexual conduct with a pupil ~~{who}~~ :

18 (1) *Who* is 14 or 15 years of age ; and ~~{who is enrolled in or~~
19 ~~attending the public school or private school at which}~~

20 (2) *With whom* the person ~~{is employed or volunteering,}~~
21 *has had contact in the course of performing his or her duties as an*
22 *employee or volunteer,*

23 ➤ is guilty of a category B felony and shall be punished by
24 imprisonment in the state prison for a minimum term of not less
25 than 1 year and a maximum term of not more than 6 years, and may
26 be further punished by a fine of not more than \$5,000.

27 3. For the purposes of subsections 1 and 2, a person shall be
28 deemed to be employed in a position of authority by a public school
29 or private school or deemed to be volunteering in a position of
30 authority at a public or private school if the person is employed or
31 volunteering as:

32 (a) A teacher or instructor;

33 (b) An administrator;

34 (c) A head or assistant coach; or

35 (d) A teacher's aide or an auxiliary, nonprofessional employee
36 who assists licensed personnel in the instruction or supervision of
37 pupils pursuant to NRS 391.100.

38 4. The provisions of this section do not apply to a person who
39 is married to the pupil.

40 **Sec. 2.** This act becomes effective on July 1, 2013.
