SUMMARY—Revises provisions governing residency requirements for candidates for public office. (BDR 23-606)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to public officers; revising provisions relating to residency requirements with reference to eligibility for public office; prohibiting a district court from issuing a declaratory judgment determining a question of residency of a candidate for certain offices after a certain date; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Under existing law, a person’s “actual residence” for the purpose of eligibility to be a candidate for and hold elective public office is the place where the person is legally domiciled and maintains a permanent habitation. If the person maintains more than one such habitation, the place the person declares as his or her principal permanent habitation when declaring or accepting candidacy is deemed to be his or her actual residence. Existing law provides a district court with jurisdiction to determine a question of residency in an action for declaratory judgment. (NRS 281.050)

Section 1 of this bill removes: (1) the provision regarding legal domicile and permanent habitation constituting “actual residency”; and (2) the provision authorizing a person with multiple habitations to declare an actual residence when declaring or accepting candidacy for public office. Instead, a person’s residence is deemed to be that place where the person has been actually, physically and corporeally within the State. **Section 1** also provides that a district court does not have jurisdiction in an action to determine the residency of candidates for the Legislature or certain state offices after the statutory deadline for making a change to the ballot for a general election, which is the fourth Friday in June of the year of the general election. (NRS 293.165, 293.166)

Section 3 of this bill provides that, for a state officer who can be removed from office only through impeachment pursuant to Article 7 of the Nevada Constitution, ceasing to reside in the State or, for a certain type of judicial officer, in the district

in which he or she is required to reside to be a candidate for the judicial office, is malfeasance for the purposes of impeachment.

Section 4 of this bill clarifies that a person who receives a certificate of election or appointment to office as a Legislator may be removed from office by reason of not residing in the district from which he or she is a Legislator only through expulsion from the Legislator's own House pursuant to Section 6 of Article 4 of the Nevada Constitution, except that the election of a person to office as a Legislator may be contested on the grounds that the person does not reside in the district from which he or she is a Legislator pursuant to provisions regarding the contest of elections. (NRS 293.407-293.435)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 281.050 is hereby amended to read as follows:

281.050 1. The residence of a person with reference to eligibility to office is ~~the person's actual residence~~ *that place where the person has been actually, physically and corporeally* within the State or county or district, as the case may be, during all the period for which residence is claimed by the person. If any person absents himself or herself from the jurisdiction of that person's residence with the intention in good faith to return without delay and continue such residence, the period of absence must not be considered in determining the question of residence.

2. If a person who has filed as a candidate for elective office moves the person's residence out of the State, county, district, ward, subdistrict or any other unit prescribed by law for which the person is a candidate and in which the person is required ~~actually, as opposed to constructively,~~ to reside, a vacancy is created thereby and the appropriate action for filling the vacancy must be taken. A person shall be deemed to have moved the person's residence for the purposes of this section if:

(a) The person has acted affirmatively to remove himself or herself from one place; and

(b) The person has an intention to remain in another place.

3. ~~The~~ *Except as otherwise provided in subsection 4, the* district court has jurisdiction to determine the question of residence in an action for declaratory judgment.

4. ~~As used in this section, "actual residence" means the place where a person is legally domiciled and maintains a permanent habitation. If the person maintains more than one such habitation, the place the person declares to be the person's principal permanent habitation when filing a declaration or affidavit pursuant to NRS 293.177 or 293C.185 shall be deemed to be the person's actual residence.~~ *A district court does not have*

10 **Sec. 2.** NRS 283.040 is hereby amended to read as follows:

11 283.040 1. Every office becomes vacant upon the occurring
12 of any of the following events before the expiration of the term:

13 (a) The death or resignation of the incumbent.

14 (b) The removal of the incumbent from office.

15 (c) The confirmed insanity of the incumbent, found by a court of
16 competent jurisdiction.

17 (d) A conviction of the incumbent of any felony or offense
18 involving a violation of the incumbent's official oath or bond or a
19 violation of NRS 241.040, 293.1755 or 293C.200.

20 (e) A refusal or neglect of the person elected or appointed to
21 take the oath of office, as prescribed in NRS 282.010, or, when a
22 bond is required by law, a refusal or neglect of the person to give the
23 bond within the time prescribed by law.

24 (f) Except as otherwise provided in NRS 266.400, the ceasing of
25 the incumbent to be ~~an actual, as opposed to constructive,~~ *in*
26 *accordance with the provisions of NRS 281.050,* a resident of the
27 State, district, county, city, ward or other unit prescribed by law in
28 which the duties of the incumbent's office are to be exercised, or
29 from which the incumbent was elected or appointed, or in which the
30 incumbent was required to reside to be a candidate for office or
31 appointed to office.

32 (g) The neglect or refusal of the incumbent to discharge the
33 duties of the incumbent's office for a period of 30 days, except
34 when prevented by sickness or absence from the State or county, as
35 provided by law. In a county whose population is less than 15,000,
36 after an incumbent, other than a state officer, has been prevented by
37 sickness from discharging the duties of the incumbent's office for at
38 least 6 months, the district attorney, either on the district attorney's
39 own volition or at the request of another person, may petition the
40 district court to declare the office vacant. If the incumbent holds
41 the office of district attorney, the Attorney General, either on the
42 Attorney General's own volition or at the request of another person,
43 may petition the district court to declare the office vacant. The
44 district court shall hold a hearing to determine whether to declare



1 the office vacant and, in making its determination, shall consider
2 evidence relating to:

3 (1) The medical condition of the incumbent;

4 (2) The extent to which illness, disease or physical weakness
5 has rendered the incumbent unable to manage independently and
6 perform the duties of the incumbent's office; and

7 (3) The extent to which the absence of the incumbent has had
8 a detrimental effect on the applicable governmental entity.

9 (h) The decision of a competent tribunal declaring the election
10 or appointment void or the office vacant.

11 (i) A determination pursuant to NRS 293.182 or 293C.186
12 that the incumbent fails to meet any qualification required for the
13 office.

14 2. Upon the happening of any of the events described in
15 subsection 1, if the incumbent fails or refuses to relinquish the
16 incumbent's office, the Attorney General shall, if the office is a state
17 office or concerns more than one county, or the district attorney
18 shall, if the office is a county office or concerns territory within one
19 county, commence and prosecute, in a court of competent
20 jurisdiction, any proceedings for judgment and decree declaring that
21 office vacant.

22 3. The provisions of this section do not apply to the extent that
23 they conflict or are otherwise inconsistent with any provision of the
24 Constitution of the State of Nevada regarding the power to judge of
25 the qualifications, elections and returns of or to punish, impeach,
26 expel or remove from office the Governor, other state and judicial
27 officers or State Legislators.

28 **Sec. 3.** NRS 283.140 is hereby amended to read as follows:

29 283.140 1. Any state officer shall be liable to impeachment
30 for misdemeanor or malfeasance in office pursuant to Article 7 of
31 the Nevada Constitution. *A state officer who is not a judicial*
32 *officer commits malfeasance in office for the purposes of Article 7*
33 *of the Nevada Constitution by ceasing to reside in this State in*
34 *violation of the provisions of NRS 281.050, and a judicial officer*
35 *other than a justice of the peace commits malfeasance in office for*
36 *the purposes of Article 7 of the Nevada Constitution by ceasing to*
37 *reside in the district in which he or she is required to reside to be a*
38 *candidate for the judicial office in violation of the provisions of*
39 *NRS 281.050.*

40 2. As used in NRS 283.140 to 283.290, inclusive, "state
41 officer" means the Governor and other state and judicial officers,
42 except:



- 1 (a) Justices of the peace; and
- 2 (b) State Legislators removable from office only through

13 *Nevada Constitution.*

14 *2. The election of a person to office as a Legislator may be*

15 *contested pursuant to NRS 293.407 to 293.435, inclusive, on the*

16 *grounds that the person does not reside in the district for which*

17 *the person is a Legislator, in violation of the provisions of*

18 *NRS 281.050.*

19 **Sec. 5.** NRS 218A.200 is hereby amended to read as follows:

20 218A.200 A person is not eligible to be elected or appointed to

21 office as a Legislator unless the person:

22 1. Is a qualified elector;

23 2. Has been ~~{an actual, as opposed to constructive,}~~ *, in*

24 *accordance with the provisions of NRS 281.050, a* citizen resident

25 of this State for 1 year next preceding the person's election or

26 appointment; and

27 3. At the time of election or appointment, has attained the age

28 of 21 years.

29 **Sec. 6.** NRS 218A.260 is hereby amended to read as follows:

30 218A.260 1. If a vacancy occurs in the office of a Legislator

31 during a regular or special session or at a time when no biennial

32 election or regular election at which county officers are to be elected

33 will take place between the occurrence of the vacancy and the next

34 regular or special session, the vacancy must be filled in the manner

35 provided in this section.

36 2. If the former Legislator was elected or appointed from a

37 district wholly within one county, the board of county

38 commissioners of the county in which the district is located shall fill

39 the vacancy by appointing a person who is a member of the same

40 political party as the former Legislator and who ~~{actually, as~~

41 ~~opposed to constructively,}~~ *, in accordance with the provisions of*

42 *NRS 281.050, resides in the district.*

43 3. If the former Legislator was elected or appointed

44 from a district comprising more than one county, the county

45 commissioners of each county within or partly within the district



1 shall fill the vacancy by appointing a person who is a member

6 (a) Each board of county commissioners shall first meet

11 commissioners of the county with the largest population in the
12 district. At the joint meeting:

13 (1) The chair of each board, on behalf of that board, shall

16 board's county is of the population of the entire district. Populations
17 must be determined by the last decennial census or special census
18 conducted by the Bureau of the Census of the United States
19 Department of Commerce.

20 (2) The person who receives a plurality of these votes is
21 appointed to fill the vacancy. If no person receives a plurality of the
22 votes, the boards of county commissioners of the respective counties
23 shall each select a candidate, and the appointee must be chosen by
24 drawing lots among the candidates so selected.

25 4. The board of county commissioners or the board of the
26 county with the largest population in the district shall issue a
27 certificate of appointment naming the appointee. The county clerk
28 or the clerk of the county with the largest population in the district
29 shall give the certificate to the appointee and send a copy of the
30 certificate to the Secretary of State.

31 **Sec. 7.** NRS 218A.700 is hereby amended to read as follows:

32 218A.700 1. Except as otherwise provided in this section,
33 when the Legislature or a member thereof discharges a duty or
34 exercises a power conferred by law to appoint a person to a new
35 term or to fill a vacancy on a board, commission, committee,
36 council, authority or similar body, the appointing authority
37 shall appoint a person who has, in accordance with the provisions of
38 NRS 281.050, ~~factually, as opposed to constructively,~~ resided, for
39 at least 6 months immediately preceding the date of the
40 appointment:

41 (a) In this State; and

42 (b) If current residency in a particular county, district, ward,
43 subdistrict or any other unit is prescribed by the provisions of law
44 that govern the position, also in that county, district, ward,
45 subdistrict or other unit.



2. The provisions of subsection 1 do not apply if:

(a) A requirement of law concerning another characteristic or status that a member must possess, including, without limitation, membership in another organization, would make it impossible to fulfill the provisions of subsection 1; or

(b) The membership of the particular board, commission, committee, council, authority or similar body includes residents of another state and the provisions of subsection 1 would conflict with a requirement that applies to all members of that body.

Sec. 8. NRS 223.195 is hereby amended to read as follows:

223.195 1. Except as otherwise provided in this section, when the Governor discharges a duty or exercises a power conferred by law to appoint a person to a new term or to fill a vacancy on a board, commission, committee, council, authority or similar body, the Governor shall appoint a person who has, in accordance with the provisions of NRS 281.050, ~~factually, as opposed to constructively,~~ resided, for at least 6 months immediately preceding the date of the appointment:

(a) In this State; and

(b) If current residency in a particular county, district, ward, subdistrict or any other unit is prescribed by the provisions of law that govern the position, also in that county, district, ward, subdistrict or other unit.

2. The provisions of subsection 1 do not apply if:

(a) A requirement of law concerning another characteristic or status that a member must possess, including, without limitation, membership in another organization, would make it impossible to fulfill the provisions of subsection 1; or

(b) The membership of the particular board, commission, committee, council, authority or similar body includes residents of another state and the provisions of subsection 1 would conflict with a requirement that applies to all members of that body.

Sec. 9. NRS 232A.020 is hereby amended to read as follows:

232A.020 1. Except as otherwise provided in this section, a person appointed to a new term or to fill a vacancy on a board, commission or similar body by the Governor must have, in accordance with the provisions of NRS 281.050, ~~factually, as opposed to constructively,~~ resided, for the 6 months immediately preceding the date of the appointment:

(a) In this State; and

(b) If current residency in a particular county, district, ward, subdistrict or any other unit is prescribed by the provisions of law that govern the position, also in that county, district, ward, subdistrict or other unit.



2. After the Governor's initial appointments of members to boards, commissions or similar bodies, all such members shall hold office for terms of 3 years or until their successors have been appointed and have qualified.

3. A vacancy on a board, commission or similar body occurs when a member dies, resigns, becomes ineligible to hold office or is absent from the State for a period of 6 consecutive months.

4. Any vacancy must be filled by the Governor for the remainder of the unexpired term.

5. A member appointed to a board, commission or similar body as a representative of the general public must be a person who:

(a) Has an interest in and a knowledge of the subject matter which is regulated by the board, commission or similar body; and

(b) Does not have a pecuniary interest in any matter which is within the jurisdiction of the board, commission or similar body.

6. The Governor shall not appoint a person to a board, commission or similar body if the person is a member of any other board, commission or similar body.

7. The provisions of subsection 1 do not apply if:

(a) A requirement of law concerning another characteristic or status that a member must possess, including, without limitation, membership in another organization, would make it impossible to fulfill the provisions of subsection 1; or

(b) The membership of the particular board, commission or similar body includes residents of another state and the provisions of subsection 1 would conflict with a requirement that applies to all members of that body.

Sec. 10. NRS 293.166 is hereby amended to read as follows:

293.166 1. A vacancy occurring in a party nomination for the office of State Senator, Assemblyman or Assemblywoman from a legislative district comprising more than one county may be filled as follows, subject to the provisions of subsections 2 and 3. The county commissioners of each county, all or part of which is included within the legislative district, shall meet to appoint a person who is of the same political party as the former nominee and who ~~actually, as opposed to constructively,~~ *, in accordance with the provisions of NRS 281.050,* resides in the district to fill the vacancy, with the chair of the board of county commissioners of the county whose population residing within the district is the greatest presiding. Each board of county commissioners shall first meet separately and determine the single candidate it will nominate to fill the vacancy. Then, the boards shall meet jointly and the chairs on behalf of the boards shall cast a proportionate number of votes according to the



1 percent, rounded to the nearest whole percent, which the population
2 of its county is of the population of the entire district. Populations
3 must be determined by the last decennial census or special census
4 conducted by the Bureau of the Census of the United States
5 Department of Commerce. The person who receives a plurality of
6 these votes is appointed to fill the vacancy. If no person receives a
7 plurality of the votes, the boards of county commissioners of the
8 respective counties shall each as a group select one candidate, and
9 the nominee must be chosen by drawing lots among the persons so
10 selected.

11 2. No change may be made on the ballot after the fourth Friday
12 in June of the year in which the general election is held. If a
13 nominee dies after that date, the nominee's name must remain on
14 the ballot and, if elected, a vacancy exists.

15 3. The designation of a nominee pursuant to this section must
16 be filed with the Secretary of State on or before 5 p.m. on the fourth
17 Friday in June of the year in which the general election is held, and
18 the statutory filing fee must be paid with the designation.

19 **Sec. 11.** NRS 293.1755 is hereby amended to read as follows:

20 293.1755 1. In addition to any other requirement provided by
21 law, no person may be a candidate for any office unless, for at least
22 the 30 days immediately preceding the date of the close of filing of
23 declarations of candidacy or acceptances of candidacy for the office
24 which the person seeks, the person has, in accordance with NRS
25 281.050, ~~factually, as opposed to constructively,~~ resided in the
26 State, district, county, township or other area prescribed by law to
27 which the office pertains and, if elected, over which he or she will
28 have jurisdiction or will represent.

29 2. Any person who knowingly and willfully files an acceptance
30 of candidacy or declaration of candidacy which contains a false
31 statement in this respect is guilty of a gross misdemeanor.

32 3. The provisions of this section do not apply to candidates for
33 the office of district attorney.

34 **Sec. 12.** NRS 293.177 is hereby amended to read as follows:

35 293.177 1. Except as otherwise provided in NRS 293.165, a
36 name may not be printed on a ballot to be used at a primary election
37 unless the person named has filed a declaration of candidacy or an
38 acceptance of candidacy, and has paid the fee required by NRS
39 293.193 not earlier than:

40 (a) For a candidate for judicial office, the first Monday in
41 January of the year in which the election is to be held nor
42 later than 5 p.m. on the second Friday after the first Monday in
43 January; and



(b) For all other candidates, the first Monday in March of the year in which the election is to be held nor later than 5 p.m. on the second Friday after the first Monday in March.

2. A declaration of candidacy or an acceptance of candidacy required to be filed by this section must be in substantially the following form:

3. The address of a candidate which must be included in the declaration of candidacy or acceptance of candidacy pursuant to subsection 2 must be the street address of the residence where the candidate ~~factually, as opposed to constructively,~~ resides in accordance with NRS 281.050, if one has been assigned. The declaration or acceptance of candidacy must not be accepted for filing if:

(a) The candidate's address is listed as a post office box unless a street address has not been assigned to his or her residence; or

(b) The candidate does not present to the filing officer:

(1) A valid driver's license or identification card issued by a governmental agency that contains a photograph of the candidate and the candidate's residential address; or

(2) A current utility bill, bank statement, paycheck, or document issued by a governmental entity, including a check which indicates the candidate's name and residential address, but not including a voter registration card issued pursuant to NRS 293.517.

4. The filing officer shall retain a copy of the proof of identity and residency provided by the candidate pursuant to paragraph (b) of subsection 3. Such a copy:

(a) May not be withheld from the public; and

(b) Must not contain the social security number or driver's license or identification card number of the candidate.

5. By filing the declaration or acceptance of candidacy, the candidate shall be deemed to have appointed the filing officer for the office as his or her agent for service of process for the purposes

1 of a proceeding pursuant to NRS 293.182. Service of such process
2 must first be attempted at the appropriate address as specified by the
3 candidate in the declaration or acceptance of candidacy. If the
4 candidate cannot be served at that address, service must be made by
5 personally delivering to and leaving with the filing officer duplicate
6 copies of the process. The filing officer shall immediately send, by
7 registered or certified mail, one of the copies to the candidate at the
8 specified address, unless the candidate has designated in writing to
9 the filing officer a different address for that purpose, in which case
10 the filing officer shall mail the copy to the last address so
11 designated.

12 6. If the filing officer receives credible evidence indicating that
13 a candidate has been convicted of a felony and has not had his or her
14 civil rights restored by a court of competent jurisdiction, the filing
15 officer:

The address of a candidate that must be included in the declaration or acceptance of candidacy pursuant to subsection 2 must be the street address of the residence where the candidate ~~factually, as opposed to constructively,~~ resides in accordance with NRS 281.050, if one has been assigned. The declaration or acceptance of candidacy must not be accepted for filing if:

(a) The candidate's address is listed as a post office box unless a street address has not been assigned to the residence; or

(b) The candidate does not present to the filing officer:

(1) A valid driver's license or identification card issued by a governmental agency that contains a photograph of the candidate and the candidate's residential address; or

(2) A current utility bill, bank statement, paycheck, or document issued by a governmental entity, including a check which indicates the candidate's name and residential address, but not including a voter registration card issued pursuant to NRS 293.517.

4. The filing officer shall retain a copy of the proof of identity and residency provided by the candidate pursuant to paragraph (b) of subsection 3. Such a copy:

(a) May not be withheld from the public; and

(b) Must not contain the social security number or driver's license or identification card number of the candidate.
