1 WHEREAS, The dedicated work of the staff of the Legislative
2 Counsel Bureau is readily apparent upon entering the Legislative
3 Building where the fastidiously clean and maintained surroundings
4 welcome visitors throughout the year; and

5 WHEREAS, Without the outstanding service and continued
6 cooperation of the staff of the Legislative Counsel Bureau, the
7 Legislature could not function or fulfill its obligations to the people
8 of the State of Nevada; and

1 WHEREAS, The goal of the Legislative Counsel Bureau is to
2 continue to meet the ever-increasing challenges of providing
3 nonpartisan, centralized services to members of both Houses of the
4 Legislature and their constituents in the most efficient, professional
5 manner possible; and

6 WHEREAS, Through the years, the Legislative Counsel Bureau
7 has evolved into an organization of public servants who provide a
8 full range of services for the “people’s branch” of government; and

9 WHEREAS, In the Administrative Division of the Legislative
10 Counsel Bureau, the staff of Information Technology Services and
11 Broadcast and Production Services maintain and improve
12 technology for the legislative process, the staff of the Buildings
13 Unit, the Grounds Unit and the Janitorial Unit prepare and
14 meticulously maintain the building and its grounds as a showplace
15 in Carson City, and the staff of the Accounting Unit, the General
16 Services Unit, the Legislative Police, the Las Vegas Office and the
17 Director’s Office, and the session staff in the message center, the
18 bill mail room and the lobbyist registration center keep the
19 Legislature functioning smoothly; and

20 WHEREAS, The Legislative Auditor and staff of the Audit
21 Division provide the Legislature with independent and reliable
22 information about the operations of state agencies, programs,
23 activities and functions by conducting high quality performance
24 audits to promote accountability in State Government, and by
25 overseeing the annual single audit of State Government to ensure
26 continued funding of federal programs; and

27 WHEREAS, The Senate and Assembly Fiscal Analysts and the
28 staff of the Fiscal Analysis Division review the Governor’s
29 Executive Budget and related bills and amendments while
30 maintaining their usual accuracy and efficiency, obtain and review
31 fiscal notes, provide expenditure and revenue analyses, provide staff
32 support for the Senate Committee on Revenue and Economic
33 Development and the Assembly Committee on Taxation, and
34 respond to the Legislators’ requests for information concerning
35 budgets and taxation; and

36 WHEREAS, The Legislative Counsel and the staff of the Legal
37 Division, including the State Printing Office, Publications and the
38 Gift Shop, draft bills and amendments and produce reprints with
39 meticulous attention to detail, while staffing standing committees
40 and providing legal advice on the usual wide range of issues to the

42 bills and resolutions and publish Nevada Revised Statutes and other
