AN ACT relating to alcoholic beverages; providing for the licensing and operation of craft distilleries in this State; setting forth the conditions under which spirits manufactured at such craft distilleries may be sold; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law provides for the operation of brew pubs and instructional wine-making facilities. (NRS 597.230, 597.245) Under existing law, facilities such as brew pubs and instructional wine-making facilities must be licensed, a fee is imposed for the license, and a person who engages in business in this State without having the appropriate permit or license for the business is guilty of a misdemeanor. (NRS 360.490, 369.180, 369.300).<sup>¶</sup>

This Sections 1 and 2-8 of this bill: (1) ~~authorized~~ authorize the operation of craft distilleries in Nevada; (2) ~~sets~~ set forth the permissible scope of operation for those craft distilleries; (3) ~~requires~~ require that the craft distilleries be licensed; and (4) ~~imposes~~ impose a licensing fee of \$75.

Existing law prohibits a supplier of malt beverages, distilled spirits and wines from unilaterally terminating or refusing to continue a franchise with a wholesaler or causing a wholesaler to resign from a franchise without first establishing good cause. (NRS 597.160) Section 1.5 of this bill revises an exception to that provision so that suppliers who sell less than 2,000 rather than 2,500 barrels of malt beverage in any calendar year are excluded from that requirement.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** Chapter 597 of NRS is hereby amended by adding thereto a new  
2      section to read as follows:

3      ***1. A person may operate a craft distillery if the person:***

1           (a) *Obtains a license for the facility pursuant to chapter 369 of NRS;*

2           (b) *Complies with the requirements of this section; and*

3           (c) *Complies with any other applicable governmental requirements.*

4           2. *A person who operates a craft distillery pursuant to this section may:*

5           (a) *In addition to manufacturing spirits from agricultural raw materials*  
6           *through distillation, blend, age, store and bottle the spirits so manufactured. The*  
7           *person operating the craft distillery shall ensure that none of the spirits*  
8           *manufactured at the craft distillery are derived from neutral or distilled spirits*  
9           *manufactured by another manufacturer.*

10           (b) *In any calendar year, sell manufacture for sale and transport in Nevada*  
11           *not more than 15,000 a combined total of 10,000 cases of spirits manufactured*  
12           *at all the craft distillery to a person who holds a valid license to engage in*  
13           *business as a wholesale dealer of liquor pursuant to chapter 369 of NRS,*  
14           *distilleries the person operates.*

15           (c) *Export in any quantity In any calendar year, manufacture for*  
16           *exportation to another state the, not more than a combined total of 20,000*  
17           *cases of spirits manufactured at all the craft distillery, distilleries the person*  
18           *operates.*

19           (d) *On the premises of the craft distillery, serve samples of the spirits*  
20           *manufactured at the craft distillery. Any such samples must not exceed, per*  
21           *person, per day, 1 fluid ounce; 2 fluid ounces in volume, of each type of spirit*  
22           *manufactured at the craft distillery.]*

23           (e) *On the premises of the craft distillery. +*

24           (1) *Serve the spirits manufactured at the craft distillery by the glass for*  
25           *consumption on the premises, and*

26           (2) *Sell sell the spirits manufactured at the craft distillery at retail for*  
27           *consumption on or off the premises. Any such spirits sold at retail for off-*  
28           *premises consumption must not exceed, per person, per day, one half gallon in*  
29           *volume of each type of spirit manufactured at the craft distillery, month, one-*  
30           *half of a case of spirits. Spirits purchased on the premises of a craft distillery*  
31           *may must not be resold by the purchaser or any retail liquor store.*

32           3. *As used in this section, "case of spirits" means 12 bottles, each*  
33           *containing 750 milliliters of distilled spirits.*

34           Sec. 1.5. NRS 597.160 is hereby amended to read as follows:

35           597.160 1. Except as otherwise provided in subsection 4, if more than one  
36           franchise for the same brand or brands of malt beverages, distilled spirits and  
37           wines, or all of them, is granted to different wholesalers in this state, it is a violation  
38           of NRS 597.120 to 597.180, inclusive, for any supplier to discriminate between  
39           such wholesalers with respect to any of the terms, provisions and conditions of  
40           these franchises.

41           2. Except as otherwise provided in this subsection and notwithstanding the  
42           terms, provisions or conditions of any franchise, a supplier shall not unilaterally  
43           terminate or refuse to continue any franchise with a wholesaler or cause a  
44           wholesaler to resign from that franchise unless the supplier has first established  
45           good cause for that termination, noncontinuance or causing of that resignation. This  
46           subsection does not apply to a supplier who sells less than 12,500 2,000 barrels of  
47           malt beverages, less than 250 cases of distilled spirits or less than 2,000 cases of  
48           wine in this state in any calendar year, or who operates a winery pursuant to NRS  
49           597.240.

50           3. A wholesaler may, within 60 days after he or she receives a notice required  
51           pursuant to NRS 597.155, correct any failure to comply with the terms, provisions  
52           and conditions of the franchise alleged by the supplier.

1       4. Unless otherwise specified by contract between the supplier and  
2 wholesaler, a supplier shall not grant more than one franchise to a wholesaler for  
3 any brand of alcoholic beverage in a marketing area.

4       **Sec. 2.** NRS 597.200 is hereby amended to read as follows:

5       597.200 As used in NRS 597.190 to 597.250, inclusive, ***and section 1 of this***  
6 ***act,*** unless the context otherwise requires:

7       1. “Alcoholic beverage” means any malt beverage or spirituous, vinous or  
8 malt liquor which contains 1 percent or more ethyl alcohol by volume.

9       2. “Brew pub” means an establishment which manufactures malt beverages  
10 and sells those malt beverages at retail pursuant to the provisions of NRS 597.230.

11       3. ***“Craft distillery” means an establishment which:***

12       (a) ***Manufactures distilled spirits from agricultural raw materials through***  
13 ***distillation; and***

14       (b) ***Is authorized to sell and distribute those distilled spirits pursuant to the***  
15 ***provisions of section 1 of this act.***

16       4. ***“Distillation” means the process of producing or purifying spirituous***  
17 ***liquor by successive evaporation and condensation.***

18       5. “Engage in” includes participation in a business as an owner or partner, or  
19 through a subsidiary, affiliate, ownership equity or in any other manner.

20       ~~44~~ 6. “Instructional wine-making facility” means an instructional wine-  
21 making facility operated pursuant to NRS 597.245.

22       ~~45~~ 7. “Legal age” means the age at which a person is legally permitted to  
23 purchase an alcoholic beverage pursuant to NRS 202.020.

24       ~~46~~ 8. “Malt beverage” means beer, ale, porter, stout and other similar  
25 fermented beverages of any name or description, brewed or produced from malt,  
26 wholly or in part.

27       ~~47~~ 9. “Supplier” has the meaning ascribed to it in NRS 597.140.

28       ~~48~~ 10. “Wine” has the meaning ascribed to it in NRS 369.140.

29       **Sec. 3.** NRS 597.210 is hereby amended to read as follows:

30       597.210 1. Except as otherwise provided in ***subsection 2 and*** NRS 597.240,  
31 ***and section 1 of this act,*** a person engaged in business as a supplier or engaged in  
32 the business of manufacturing, blending or bottling alcoholic beverages within or  
33 without this State shall not ~~engage~~:

34       (a) ***Engage*** in the business of importing, wholesaling or retailing alcoholic  
35 beverages ~~44~~ or

36       (b) ***Operate or otherwise locate his or her business on the premises or***  
37 ***property of another person engaged in the business of importing, wholesaling or***  
38 ***retailing alcoholic beverages.***

39       2. This section does not:

40       (a) Preclude any person engaged in the business of importing, wholesaling or  
41 retailing alcoholic beverages from owning less than 2 percent of the outstanding  
42 ownership equity in any organization which manufactures, blends or bottles  
43 alcoholic beverages.

44       (b) Prohibit a person engaged in the business of rectifying or bottling alcoholic  
45 beverages from importing neutral or distilled spirits in bulk only for the express  
46 purpose of rectification pursuant to NRS 369.415.

47       (c) Prohibit a person from operating a brew pub pursuant to NRS 597.230.

48       (d) Prohibit a person from operating an instructional wine-making facility  
49 pursuant to NRS 597.245.

50       (e) ***Prohibit a person from operating a craft distillery pursuant to section 1 of***  
51 ***this act.***

1           **Sec. 4.** NRS 597.220 is hereby amended to read as follows:

2       597.220 1. ~~Any~~ **Except as otherwise provided in section 1 of this act,**  
3       subsection 3, a person who is engaged in the business of importing or wholesaling  
4       alcoholic beverages in the State of Nevada shall not engage in the business of  
5       retailing alcoholic beverages in this state.

6           2. For the purposes of this section, a person who transfers or receives  
7       alcoholic beverages in the manner described in NRS 369.4865 must not be  
8       considered to be engaged in the business of wholesaling alcoholic beverages based  
9       solely upon those transfers.

10          **3. This section does not prohibit a person from operating a craft distillery**  
11          **pursuant to section 1 of this act.**

12           **Sec. 5.** NRS 597.250 is hereby amended to read as follows:

13       597.250 The license of any person who violates the provisions of NRS  
14       597.210, 597.220, 597.230 or 597.245 **or section 1 of this act** must be suspended or  
15       revoked in the manner provided in chapter 369 of NRS.

16           **Sec. 6.** NRS 369.180 is hereby amended to read as follows:

17       369.180 1. In addition to the limitations imposed by NRS 597.210 and  
18       597.220, a person shall not:

19           (a) Import liquors into this State unless the person first secures an importer's  
20       license or permit from this State.

21           (b) Engage in business as a wholesale dealer of wines and liquors in this State  
22       unless the person first secures a wholesale wine and liquor dealer's license from  
23       this State.

24           (c) Engage in business as a wholesale dealer of beer in this State unless the  
25       person first secures a wholesale beer dealer's license from this State.

26           (d) Operate a winery in this State or export wine from this State unless the  
27       person first secures a wine-maker's license from this State.

28           (e) Operate an instructional wine-making facility in this State unless the person  
29       first secures a license for the instructional wine-making facility from this State.

30           (f) Operate a brewery in this State unless the person first secures a brewer's  
31       license from this State.

32           (g) Operate a brew pub in this State unless the person first secures a brew  
33       pub's license from this State.

34          **(h) Operate a craft distillery in this State unless the person first secures a**  
35          **craft distiller's license from this State.**

36           2. A person who holds a license for an instructional wine-making facility:

37           (a) May engage in any activity authorized by NRS 597.245.

38           (b) May not engage in any other activity for which a license is required  
39       pursuant to this chapter, unless the person holds the appropriate license for that  
40       activity.

41           3. **A person who holds a license for a craft distillery:**

42           (a) **May engage in any activity authorized by section 1 of this act.**

43           (b) **May not engage in any other activity for which a license is required**

**pursuant to this chapter, unless the person holds the appropriate license for that**

  
45       activity.

46           4. As used in this section:

47           (a) "Brew pub" has the meaning ascribed to it in NRS 597.200.

48           (b) "Brewery" means an establishment which manufactures malt beverages but  
49       does not sell those malt beverages at retail.

50           (c) **"Craft distillery" has the meaning ascribed to it in NRS 597.200.**

51           (d) "Malt beverage" has the meaning ascribed to it in NRS 597.200.

52           **Sec. 7.** NRS 369.300 is hereby amended to read as follows:

53       369.300 The following is a schedule of fees to be charged for licenses:

1	Importer's wine, beer and liquor license.....	\$500
2	Importer's beer license.....	150
3	Wholesale wine, beer and liquor license.....	250
4	Wholesale beer dealer's license .....	75
5	Wine-maker's license.....	75
6	License for an instructional wine-making facility.....	75

8	Brewer's license.....	75
9	<b>Craft distiller's license .....</b>	<b>75</b>

10 Sec. 8. NRS 369.382 is hereby amended to read as follows:

11 369.382 1. Except as otherwise provided in subsection 2, NRS 369.386 and  
12 369.415, ~~and section 1 of this act,~~ a supplier shall not engage in the business of  
13 importing, wholesaling or retailing alcoholic beverages in this State.

14 2. This section does not prohibit a person from operating a craft distillery  
15 pursuant to section 1 of this act.
