AN ACT relating to motorcycles; revising provisions pertaining to trimobiles; revising provisions relating to the equipment that is required on a motorcycle or moped operating on the highways of this State; revising provisions concerning the protective equipment that a person is required to wear when driving or riding on a motorcycle or moped; increasing the amount the Director of the Department of Public Safety is authorized to charge for a course of motorcycle safety; revising other provisions related to certain courses of motorcycle safety; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Under existing law, a person driving a trimobile is required to hold a driver’s license, but is not required to hold a motorcycle driver’s license or a driver’s license with a motorcycle endorsement. (NRS 486.061) Existing law also requires a person driving or riding on a trimobile to wear protective glasses, goggles or a face shield, but does not require such a person to wear protective headgear. (NRS 486.231) A trimobile is defined in existing law as a motor vehicle designed to travel with three wheels in contact with the ground, two of which are power driven. (NRS 482.129, 486.057) **Sections 1 and 2** of this bill revise the definition of trimobile by removing the requirement that two of the wheels be power driven, ~~and~~ **and by excluding from the definition a motorcycle with a sidecar.**

Existing law requires the Department of Motor Vehicles to adopt standards for protective headgear and protective glasses, goggles or face shields to be worn by drivers and passengers of motorcycles, and transparent windcreens for motorcycles. (NRS 486.231) **Section 3** of this bill removes the requirement for the Department to adopt standards for protective glasses, goggles, face shields and transparent windcreens.

Existing law requires a motorcycle or moped that is driven on the highways of this State to be equipped with certain equipment, including, for example, head lamps and rear reflectors, and provides for height restrictions for handlebars. (NRS 486.201, 486.281, 486.291) **Section 4** of this bill increases the maximum number of allowable head lamps on a motorcycle or moped, **section 5** of this bill removes the minimum height requirement for rear reflectors on a motorcycle or moped, and **section ~~4~~ 2.5** of this bill ~~repeals~~ **revises** the restriction on the height of the handlebars on a motorcycle or moped.

Existing law requires the Director of the Department of Public Safety to establish a Program for the Education of Motorcycle Riders and provides that money in the Account for the Program may be used to pay the expenses of the Program or for any other purpose

25 authorized by the Legislature. (NRS 486.372) **Section 6** of this bill removes the authorization  
 26 for money in the Account to be used for any other purpose authorized by the Legislature.  
 27 Existing law also authorizes certain residents of this State to enroll in the Program and  
 28 authorizes the Director to establish a fee of not more than \$100 for the Program. (NRS  
 29 486.373) **Section 7** of this bill raises the limit of the fee to ~~the fee to~~ \$150 and allows for the  
 30 enrollment in the Program of a person who is ~~an active duty~~ an active duty member of the Armed Forces of  
 31 the United States stationed at a military installation located in this State and who is  
 32 authorized by ~~the person's~~ any state ~~of residency~~ to drive a motorcycle ~~or who is~~  
 33 eligible to apply for such authorization from any state.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.129 is hereby amended to read as follows:

2 482.129 "Trimobile" means every motor vehicle designed to travel with three  
 3 wheels in contact with the ground. ~~two of which are power driven.~~ The term  
 4 does not include an electric bicycle, a farm tractor ~~or~~ a moped ~~or~~ a  
 5 motorcycle with a sidecar.

6 **Sec. 2.** NRS 486.057 is hereby amended to read as follows:

7 486.057 1. "Trimobile" means every motor vehicle designed to travel with  
 8 three wheels in contact with the ground. ~~two of which are power driven.~~

9 2. The term does not include:

10 (a) An electric bicycle, as that term is defined in NRS 482.0287;

11 (b) A farm tractor, as that term is defined in NRS 482.035; ~~or~~

12 (c) A moped ~~or~~;

13 (d) A motorcycle with a sidecar.

14 **Sec. 2.5.** NRS 486.201 is hereby amended to read as follows:

15 486.201 A person shall not drive a motorcycle or moped equipped with  
 16 handlebars which extend more than 6 inches above the uppermost portion of the  
 17 driver's shoulders when the driver sits on the seat and the seat is depressed by the  
 18 weight of the driver.

19 **Sec. 3.** NRS 486.231 is hereby amended to read as follows:

20 486.231 1. The Department shall adopt standards for protective headgear  
 21 ~~and protective glasses, goggles or face shields~~ to be worn by the drivers and  
 22 passengers of motorcycles. ~~and transparent windcreens for motorcycles.~~

23 2. Except as provided in this section, when any motorcycle, except a trimobile  
 24 or moped, is being driven on a highway, the driver and passenger shall wear  
 25 protective headgear which meets those standards, securely fastened on the head,  
 26 and protective glasses, goggles or face shields. ~~meeting those standards.~~ Drivers  
 27 and passengers of trimobiles shall wear protective glasses, goggles or face shields.  
 28 ~~which meet those standards.~~

29 3. When a motorcycle or a trimobile is equipped with a transparent  
 30 windscreen, ~~meeting those standards.~~ the driver and passenger are not required to  
 31 wear glasses, goggles or face shields.

32 4. When a motorcycle is being driven in a parade authorized by a local  
 33 authority, the driver and passenger are not required to wear the protective devices  
 34 provided for in this section.

35 5. When a three-wheel motorcycle on which the driver and passengers ride  
 36 within an enclosed cab is being driven on a highway, the driver and passengers are  
 37 not required to wear the protective devices required by this section.

1       **Sec. 4.** NRS 486.281 is hereby amended to read as follows:  
2       486.281 1. Every motorcycle or moped shall be equipped with at least one  
3 and not more than ~~two~~ **four** head lamps.

4       2. Every such head lamp on a motorcycle shall be located at a height of not  
5 more than 54 inches nor less than 24 inches from the ground as measured from the  
6 center of the lamp to the level ground upon which such motorcycle stands without a  
7 load.

8       **Sec. 5.** NRS 486.291 is hereby amended to read as follows:  
9       486.291 1. Every motorcycle or moped shall carry on the rear at least one  
10 reflector, which shall be mounted at a height not ~~less than 20 inches nor~~ more than  
11 60 inches from the ground as measured from the center of the reflector to the level  
12 ground upon which such motorcycle or moped stands without a load.

13       2. Each such reflector shall be of a size and character and so mounted as to be  
14 visible at night from all distances within 300 feet when directly in front of lawful  
15 lower beams of head lamps.

16       **Sec. 6.** NRS 486.372 is hereby amended to read as follows:

17       486.372 1. The Director shall:

- 18       (a) Establish the Program.  
19       (b) Appoint an Administrator to carry out the Program.  
20       (c) Consult regularly with the Advisory Committee for Motorcycle Safety  
21 concerning the content and implementation of the Program.  
22       (d) Approve courses of instruction provided by public or private organizations  
23 which comply with the requirements established for the Program.  
24       (e) Adopt rules and regulations which are necessary to carry out the Program.

25       2. The Director may contract for the provision of services necessary for the  
26 Program.

27       3. The money in the Account for the Program for the Education of  
28 Motorcycle Riders may be used ~~to~~

29 ~~—(a) ~~to~~ to~~ pay the expenses of the Program, including reimbursement to  
30 instructors licensed pursuant to NRS 486.375 for services provided for the Program  
31 ~~. ~~to~~ or~~

32 ~~—(b) For any other purpose authorized by the Legislature.~~

33       4. The interest and income earned on the money in the Account, after  
34 deducting any applicable charges, must be credited to the Account.

35       **Sec. 7.** NRS 486.373 is hereby amended to read as follows:

36       486.373 1. A **person who:**

37       **(a) Is a** resident of this State who holds a motorcycle driver's license or a  
38 motorcycle endorsement to a driver's license ~~for who is~~ ;

39       **(b) Is** eligible to apply for such a license or endorsement ; **or**

40       **(c) Is ~~not~~ an active duty member of the Armed Forces of the United States**  
41 **stationed at a military installation located in this State ~~and is authorized by the~~**  
42 **person's state of residency to drive a motorcycle, ~~who holds a motorcycle driver's~~**  
43 **license or motorcycle endorsement to a driver's license issued by any state or who**  
44 **is eligible to apply for such a license or endorsement issued by any state.**

45       **↳** may enroll in the Program.

46       2. The Director shall establish a fee of not more than ~~[\$100] [\$200] \$150~~ for  
47 the Program.
