AN ACT relating to children; expanding the rights of children placed in foster care with respect to their siblings; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law affords specific rights to children who are placed in a foster home by an
2 agency which provides child welfare services. (NRS 432.500-432.550) ~~This bill expands~~
3 ~~those rights with respect to relationships between siblings of children placed in foster care.~~
4 Existing law provides a right to a child placed in a foster home to contact and visit his or
5 her siblings, unless prohibited from doing so by court order. (NRS 432.525) Section 1 of
6 this bill provides ~~that this right to a child placed in a foster home,~~ does not apply if
7 such contact is contrary to the safety of the child or his or her siblings. Section 1 also
8 adds, to the extent practicable, the right for such a child to have contact with his or her
9 siblings arranged on a regular basis and on holidays, birthdays and other significant life
10 events. Section 1 further provides that such a child has the right not to have contact or
11 visitation with a sibling withheld as a form of punishment. Section 2 of this bill provides a
12 child who is placed in a foster home with the right, consistent with the age and
13 developmental experience of the child, to be informed of a plan to change, or a change in,
14 the placement of a sibling who is placed in a foster home, unless the sibling objects or
15 such notification is prohibited by court order.

1 WHEREAS, The importance of sibling relationships is widely recognized; and
2 WHEREAS, Siblings share similar history, heritage and culture which is
3 important to preserve; and
4 WHEREAS, Separation from siblings is a significant and distinct loss, and the
5 effect of that loss can be lessened by frequent contact between siblings; and

1 WHEREAS, Maintaining sibling relationships fosters a sense of continuity and
2 stability for children placed in foster care; and

3 WHEREAS, Every foster child deserves to know and be actively involved in the
4 lives of his or her siblings, absent extraordinary circumstances; now, therefore,
5

6 THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
7 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:
8

9 **Section 1.** NRS 432.525 is hereby amended to read as follows:

10 432.525 A child placed in a foster home by an agency which provides child
11 welfare services has the right:

12 1. To receive information concerning his or her rights set forth in this section
13 and NRS 432.530 and 432.535.

14 2. To be treated with dignity and respect.

15 3. To fair and equal access to services, placement, care, treatment and
16 benefits.

17 4. To receive adequate, healthy, appropriate and accessible food.

18 5. To receive adequate, appropriate and accessible clothing and shelter.

19 6. To receive appropriate medical care, including, without limitation:

20 (a) Dental, vision and mental health services;

21 (b) Medical and psychological screening, assessment and testing; and

22 (c) Referral to and receipt of medical, emotional, psychological or psychiatric
23 evaluation and treatment as soon as practicable after the need for such services has
24 been identified.

25 7. To be free from:

26 (a) Abuse or neglect, as defined in NRS 432B.020;

27 (b) Corporal punishment, as defined in NRS 388.5225;

28 (c) Unreasonable searches of his or her personal belongings or other
29 unreasonable invasions of privacy;

30 (d) The administration of psychotropic medication unless the administration is
31 consistent with NRS 432B.197 and the policies established pursuant thereto; and

32 (e) Discrimination or harassment on the basis of his or her actual or perceived
33 race, ethnicity, ancestry, national origin, color, religion, sex, sexual orientation,
34 gender identity, mental or physical disability or exposure to the human
35 immunodeficiency virus.

36 8. To attend religious services of his or her choice or to refuse to attend
37 religious services.

38 9. Except for placement in a facility, as defined in NRS 432B.6072, not to be
39 locked in any room, building or premise or to be subject to other physical restraint
40 or isolation.

41 10. Except as otherwise prohibited by the agency which provides child
42 welfare services:

43 (a) To send and receive unopened mail; and

44 (b) To maintain a bank account and manage personal income, consistent with
45 the age and developmental level of the child.

46 11. To complete an identification kit, including, without limitation,
47 photographing, and include the identification kit and his or her photograph in a file
48 maintained by the agency which provides child welfare services and any employee
49 thereof who provides child welfare services to the child.

50 12. To communicate with other persons, including, without limitation, the
51 right:

1 (a) To communicate regularly, but not less often than once each month, with an
2 employee of the agency which provides child welfare services who provides child
3 welfare services to the child;

4 (b) To communicate confidentially with the agency which provides child
5 welfare services to the child concerning his or her care;

6 (c) To report any alleged violation of his or her rights pursuant to NRS 432.550
7 without being threatened or punished;

8 (d) Except as otherwise prohibited by a court order, to contact a family
9 member, social worker, attorney, advocate for children receiving foster care
10 services or guardian ad litem appointed by a court or probation officer; and

11 (e) Except as otherwise prohibited by a court order ~~+~~ and to the extent
12 practicable, to contact and visit his or her siblings ~~+~~, including siblings who have
13 not been placed in foster homes and ~~+~~, to the extent practicable, to have such
14 contact arranged on a regular basis and on holidays, birthdays and other
15 significant life events ~~+~~, unless such contact is contrary to the safety of the child
16 or his or her siblings.

17 13. Not to have contact or visitation with a sibling withheld as a form of
18 punishment.

19 **Sec. 2.** NRS 432.530 is hereby amended to read as follows:

20 432.530 With respect to the placement of a child in a foster home by an
21 agency which provides child welfare services, the child has the right:

22 1. To live in a safe, healthy, stable and comfortable environment, including,
23 without limitation, the right:

24 (a) If safe and appropriate, to remain in his or her home, be placed in the home
25 of a relative or be placed in a home within his or her community;

26 (b) To be placed in an appropriate foster home best suited to meet the unique
27 needs of the child, including, without limitation, any disability of the child;

28 (c) To be placed in a foster home where the licensee, employees and residents
29 of the foster home who are 18 years of age or older have submitted to an
30 investigation of their background and personal history in compliance with NRS
31 424.031; and

32 (d) To be placed with his or her siblings, whenever possible, and as required by
33 law, if his or her siblings are also placed outside the home ~~+~~ for, to the extent
34 practicable, to be placed in close proximity to his or her siblings to facilitate
35 frequent contact.

36 2. To receive and review information concerning his or her placement,
37 including, without limitation, the right:

38 (a) To receive information concerning any plan for his or her permanent
39 placement adopted pursuant to NRS 432B.553;

40 (b) To receive information concerning any changes made to his or her plan for
41 permanent placement; and

42 (c) If the child is 12 years of age or older, to review the plan for his or her
43 permanent placement.

44 3. To attend and participate in a court hearing which affects the child, to the
45 extent authorized by law and appropriate given the age and experience of the child.

46 4. ~~+~~ Consistent with the age and developmental experience of the child,
47 except as otherwise prohibited by court order or unless the sibling objects, to be
48 informed of any plan to change, or change in, the placement of a sibling,
49 including, without limitation ~~+~~, a plan:

50 (a) A plan adopted pursuant to NRS 432B.553 for the permanent placement
51 of the sibling; and

1 (b) Any plan to change the placement of, or a change in the placement of, a
2 sibling resulting from adoption, reaching the age of 18 years or otherwise leaving
3 a foster home.
