SUMMARY—Authorizes the State Fire Marshal and the State Board of Fire Services to issue administrative citations. (BDR 42-1151)

AN ACT relating to the State Fire Marshal; authorizing the State Fire Marshal and the State Board of Fire Services to issue administrative citations; **requiring the Board to establish by regulation a schedule of administrative fines;** establishing provisions for the contest of such citations; providing a penalty; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law sets forth the membership and duties of the State Fire Marshal and the State Board of Fire Services. (NRS 477.030, 477.071-477.090) **Section 2** of this bill authorizes the State Fire Marshal and the Board to issue a written administrative citation if the State Fire Marshal or the Board, based upon a preponderance of the evidence, has reason to believe that a person has violated any statute or regulation relating to the State Fire Marshal. **Section 2 also requires the Board to establish by regulation a schedule of administrative fines based on the severity or frequency of the violation.** **Section 3** of this bill establishes the procedure by which a person may contest an administrative citation.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 477 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2. 1. If the State Fire Marshal or the Board, based upon a**
4 ***preponderance of the evidence, has reason to believe that a person has committed***
5 ***a violation of this chapter or the regulations of the State Fire Marshal, the State***

1 ***Fire Marshal or the Board may issue a written administrative citation to the***
2 ***person.***

3 ***2. A citation issued pursuant to this section includes, without limitation, an***
4 ***order to:***

5 ***(a) Take action to correct a condition resulting from an act that constitutes a***
6 ***violation of this chapter or the regulations of the State Fire Marshal, at the***
7 ***person's cost;***

8 ***(b) Pay an administrative fine ~~not to exceed \$50,000,~~ imposed in***
9 ***accordance with the schedule of administrative fines prescribed by the Board***
10 ***pursuant to subsection 4; and***

11 ***(c) Reimburse the State Fire Marshal or the Board for the amount of the***
12 ***expense incurred to investigate the complaint.***

13 ***3. If a written citation issued pursuant to subsection 1 includes an order to***
14 ***take action to correct a condition resulting from an act that constitutes a violation***
15 ***of this chapter or the regulations of the State Fire Marshal, the citation must***
16 ***state the time permitted for compliance, which must be not less than 15 business***
17 ***days after the date the person receives the citation, and must specifically describe***
18 ***the action required to be taken.***

19 **4. The Board shall by regulation establish a schedule of at least three**
20 **different levels of administrative fines not to exceed \$50,000, based on the**
21 **severity and frequency of the violation of any provision of this chapter or any**
22 **regulation of the State Fire Marshal.**

23 **5. The sanctions authorized by subsection 2 are separate from, and in**
24 **addition to, any other remedy, civil or criminal, authorized by this chapter.**

25 **5.6. The failure of an unlicensed person to comply with a citation or**
26 **order after it is final is a misdemeanor. If an unlicensed person does not pay an**
27 **administrative fine imposed pursuant to this section within 60 days after the order**
28 **of the State Fire Marshal or the Board becomes final, the order may be executed**
29 **upon in the same manner as a judgment issued by a court.**

30 ***Sec. 3. 1. A person who is issued a written citation pursuant to section 2***
31 ***of this act may contest the citation within 15 business days after the date on***
32 ***which the citation is served on the person.***

33 ***2. A person may contest, without limitation:***

34 ***(a) The facts forming the basis for the determination that the person has***
35 ***committed an act which constitutes a violation of this chapter or the regulations***
36 ***of the State Fire Marshal;***

37 ***(b) The time allowed to take any corrective action ordered;***

38 ***(c) The amount of any administrative fine ordered;***

39 ***(d) The amount of any order to reimburse the State Fire Marshal or the***
40 ***Board for the expenses incurred to investigate the person; and***

41 ***(e) Whether any corrective action described in the citation is reasonable.***

42 ***3. If a person does not contest a citation issued pursuant to section 2 of this***
43 ***act within 15 business days after the date on which the citation is served on the***
44 ***person, or on or before such later date as specified by the State Fire Marshal or***
45 ***the Board pursuant to subsection 4, the citation shall be deemed a final order of***
46 ***the State Fire Marshal or the Board and not subject to review by any court or***
47 ***agency.***

48 ***4. The State Fire Marshal or the Board may, for good cause shown, extend***
49 ***the time to contest a citation issued pursuant to section 2 of this act.***

50 ***5. For the purposes of this section, a citation shall be deemed to have been***
51 ***served on a person on:***

52 ***(a) The date on which the citation is personally delivered to the person; or***

1 **(b) If the citation is mailed, the date on which the citation is mailed by
2 certified mail to the last known business or residential address of the person.**

3 Sec. 4. NRS 477.071 is hereby amended to read as follows:

4 477.071 As used in NRS 477.071 to 477.090, inclusive, **and sections 2 and 3
5 of this act**, unless the context otherwise requires, "Board" means the State Board of
6 Fire Services created pursuant to NRS 477.073.

7 Sec. 5. This act becomes effective ~~on July 1, 2013.~~ :

8 1. Upon passage and approval for the purpose of adopting regulations;

10 2. On January 1, 2014, for all other purposes.
