AN ACT making appropriations to the Legislative Fund for dues and registration costs for national organizations, building maintenance projects and information technology purchases; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. There is hereby appropriated from the State General Fund to the Legislative Fund created by NRS 218A.150 the sum of ~~(\$755,000)~~ \$758,573 for dues and registration costs for national organizations to be allocated as follows:

For the Fiscal Year 2013-2014.....~~(\$377,500)~~ \$377,117
For the Fiscal Year 2014-2015.....~~(\$377,500)~~ \$381,456

Sec. 2. There is hereby appropriated from the State General Fund to the Legislative Fund created by NRS 218A.150 the sum of ~~(\$1,086,859)~~ \$1,082,800 for one-time building maintenance projects and information technology purchases for the Legislative Counsel Bureau.

Sec. 3. This act becomes effective upon passage and approval.
