AN ACT relating to public health; creating the Task Force on Alzheimer’s Disease within ~~the Health Division of~~ the Department of Health and Human Services; providing for its membership; setting forth the powers and duties of the Task Force; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Assembly Concurrent Resolution No. 10 of the 2011 Legislative Session directed the
2 Legislative Committee on Health Care to create a task force to develop a state plan to address
3 Alzheimer’s disease and to submit the state plan to the 77th Session of the Nevada
4 Legislature. (File No. 42, Statutes of Nevada 2011, p. 3868) **Section 5** of this bill creates the
5 Task Force on Alzheimer’s Disease within ~~the Health Division of~~ the Department of Health
6 and Human Services and sets forth the composition of the Task Force. **Section 7** of this bill
7 requires the Task Force to take certain actions to carry out the state plan that was developed
8 pursuant to Assembly Concurrent Resolution No. 10, including, without limitation, reviewing
9 and revising the state plan as necessary and researching and reviewing any other issues
10 relevant to Alzheimer’s disease.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 439 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 to 7, inclusive, of this act.

3 **Sec. 2.** *As used in sections 2 to 7, inclusive, of this act, unless the context
4 otherwise requires, the words and terms defined in sections 3 and 4 of this act
5 have the meanings ascribed to them in those sections.*

6 **Sec. 3.** *“State plan” means the state plan to address Alzheimer’s disease
7 developed pursuant to section 7 of this act.*

8 **Sec. 4.** *“Task Force” means the Task Force on Alzheimer’s Disease
9 created by section 5 of this act.*

1 Sec. 5. 1. *The Task Force on Alzheimer's Disease is hereby created
2 within the ~~Health Division~~, Department of Health and Human Services.*

3 2. *The Director shall appoint to the Task Force the following ~~seven~~ eight
4 voting members:*

5 (a) *A representative from an association that provides services to persons
6 with Alzheimer's disease;*

7 (b) *A medical professional with expertise in cognitive disorders;*

8 (c) *A representative of caregivers for persons with cognitive disorders;*

9 (d) *A representative of the Nevada System of Higher Education with
10 expertise in cognitive disorders;*

11 (e) *A representative of providers of service for persons with cognitive
12 disorders;*

13 (f) *A representative from a rural area of this State;*

14 ~~(g)~~ *A representative from the Department; and*

15 ~~(h)~~ *A member at large.*

16 3. *The Legislative Commission shall appoint to the Task Force the
17 following two voting members:*

18 (a) *One member of the Senate; and*

19 (b) *One member of the Assembly.*

20 4. *After the initial terms, the members of the Task Force serve terms of 2
21 years. A member may be reappointed to the Task Force and any vacancy must be
22 filled in the same manner as the original appointment.*

23 5. *The members of the Task Force serve without compensation, except that
24 each member is entitled, while engaged in the business of the Task Force and
25 within the limits of available money, to the per diem allowance and travel
26 expenses provided for state officers and employees generally.*

27 6. *Not later than 30 days after appointment, each member of the Task Force
28 appointed pursuant to subsection 2 shall nominate two persons to serve as his or
29 her alternate members and submit the names of the persons nominated to the
30 Director for appointment. An alternate member shall serve as a voting member of
31 the Task Force when the appointed member who nominated the alternate is
32 disqualified or unable to serve.*

33 Sec. 6. 1. *The members of the Task Force shall elect a Chair and a Vice
34 Chair by a majority vote. After the initial election, the Chair and Vice Chair serve
35 for a term of 1 year beginning on July 1 of each year. If the position of Chair or
36 Vice Chair becomes vacant, the members of the Task Force shall elect a Chair or
37 Vice Chair, as appropriate, from among its members for the remainder of the
38 unexpired term.*

39 2. *The members of the Task Force shall meet at least once each quarter at
40 the call of the Chair. The Task Force shall prescribe regulations for its own
41 management and government.*

42 3. *A majority of the members of the Task Force constitutes a quorum, and a
43 quorum may exercise all the powers conferred on the Task Force.*

44 4. *Each member of the Task Force who is appointed pursuant to subsection
45 2 of section 5 of this act serves at the pleasure of the Director.*

46 Sec. 7. 1. *The Task Force shall:*

47 (a) *Develop a state plan to address Alzheimer's disease;*

48 (b) *Monitor the progress in carrying out the state plan;*

49 (c) *Review and revise the state plan as necessary;*

50 (d) *Develop and prioritize the actions necessary to carry out the state plan;*

51 (e) *Research and review any other issues that are relevant to Alzheimer's
52 disease; and*

1 *(f) On or before February 1 of each year, prepare and submit a report to the
2 Governor and to the Director of the Legislative Counsel Bureau for transmittal to
3 the Legislature concerning its findings and recommendations.*

4 *2. For the purpose of carrying out the provisions of sections 2 to 7,
5 inclusive, of this act, the Department:*

6 *(a) Shall provide the personnel, facilities, equipment and supplies required
7 by the Task Force;*

8 *(b) May accept any gifts, grants and donations; and*

9 *(c) May enter into contracts and award grants.*

10 Sec. 8. As soon as practicable after July 1, 2013, the appointed members of
11 the Task Force on Alzheimer's Disease created by section 5 of this act must be
12 appointed to initial terms as follows:

13 1. The Director of the Department of Health and Human Services shall
14 appoint:

15 (a) ~~Three~~ Four members pursuant to subsection 2 of that section to initial
16 terms that expire on June 30, 2014; and

17 (b) Four members pursuant to subsection 2 of that section to initial terms that
18 expire on June 30, 2015; and

19 2. The Legislative Commission shall appoint:

20 (a) One member pursuant to subsection 3 of that section to an initial term that
21 expires on June 30, 2014; and

22 (b) One member pursuant to subsection 3 of that section to an initial term that
23 expires on June 30, 2015.

24 Sec. 9. For the purposes of this act, the state plan developed pursuant to
25 Assembly Concurrent Resolution No. 10, File No. 42, Statutes of Nevada 2011, p.
26 3868, shall be deemed to be the initial state plan to address Alzheimer's disease
27 required by section 7 of this act.

28 Sec. 10. This act becomes effective on July 1, 2013, and expires by limitation
29 on June 30, 2017.
