AN ACT relating to public schools; requiring consistency in zoning ordinances with respect to certain standards and specifications for the construction or alteration of public schools in certain counties; requiring ~~the approval of the board of trustees of~~ that such standards and specifications be developed in conjunction with the school district ~~of such standards and specifications; of that county;~~ and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law provides that in a county whose population is less than 700,000 (currently all  
2 counties other than Clark County), certain plans, designs and specifications for the erection of  
3 any new school building or for any addition to or alteration of an existing school building  
4 must be submitted by the board of trustees of the school district to the building department of  
5 the county or other appropriate local government for approval. (NRS 393.110) **Section 1.3** of  
6 this bill requires that in a county whose population is 100,000 or more but less than 700,000  
7 (currently Washoe County), the standards and specifications for the erection of any new  
8 school building or for any addition to or alteration of an existing school building in any  
9 ordinance relating to zoning adopted or amended by the governing body of the county and the  
10 governing body of any city in the county which address the height of the building, the setback  
11 of the building, the landscaping and the amount of parking space must be: (1) consistent in all  
12 such ordinances; and (2) ~~approved by the board of trustees of~~ developed in conjunction  
13 ~~with~~ the school district of that county. **Section 3** of this bill requires such ordinances to be  
14 adopted on or before February 28, 2014.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** (Deleted by amendment.)

2       **Sec. 1.3.** Chapter 278 of NRS is hereby amended by adding thereto a new  
3 section to read as follows:

4       *In a county whose population is 100,000 or more but less than 700,000, the  
5 standards and specifications for the erection of any new school building or for  
6 any addition to or alteration of an existing school building in any ordinance  
7 relating to zoning adopted or amended by the governing body of the county and  
8 the governing body of any city in the county which address the height of the  
9 building, the setback of the building, the landscaping and the amount of parking  
10 space must be:*

- 11       1. *Consistent in all such ordinances; and*  
12       2. *Approved by the board of trustees of Developed in conjunction with the  
13 school district of that county.*

14       **Sec. 1.7.** NRS 278.010 is hereby amended to read as follows:  
15       278.010 As used in NRS 278.010 to 278.630, inclusive, *and section 1.3 of  
16 this act*, unless the context otherwise requires, the words and terms defined in NRS  
17 278.0105 to 278.0195, inclusive, have the meanings ascribed to them in those  
18 sections.

19       **Sec. 2.** (Deleted by amendment.)

20       **Sec. 3.** 1. On or before February 28, 2014, in a county whose population is  
21 100,000 or more but less than 700,000, the governing body of the county and the  
22 governing body of each city in the county shall each adopt by ordinance standards  
23 and specifications for the erection of any new school building or for any addition to  
24 or alteration of any existing school building which address the height of the  
25 building, the setback of the building, the landscaping and the amount of parking  
26 space that:

- 27       (a) Are consistent in all such ordinances; and  
28       (b) Have been ~~Approved by the board of trustees of~~ developed in  
29 conjunction with the school district of the county.  
30       2. As used in this section, "governing body" has the meaning ascribed to it in  
31 NRS 278.015.

32       **Sec. 4.** This act becomes effective on July 1, 2013.
