ASSEMBLY JOINT RESOLUTION—Urging the Bureau of Land Management and the United States Forest Service to assist the State of Nevada with the prevention and suppression of wildfires **and repeat wildfires** in this State.

1 WHEREAS, The State of Nevada is one of the states that is greatly affected by
2 wildfires; and

3 WHEREAS, The wildfires in Nevada have burned vast areas of this State,
4 including numerous acres of rangeland and forest located on public lands managed
5 and controlled by the Bureau of Land Management and the United States Forest
6 Service; and

7 WHEREAS, The growth of an invasive, nonnative annual grass known as
8 cheatgrass has been a significant contributing factor to the increased extent and
9 frequency of wildfires in this State; and

10 WHEREAS, Frequent wildfires and the increased presence of cheatgrass have
11 degraded the ecosystem in this State by inhibiting the establishment of native plant
12 species **H** **and increasing the highly volatile fuel load of the nonnative**
13 **cheatgrass, which substantially increases the chance of a repeat wildfire in the**
14 **same area;** and

15 WHEREAS, **A repeat wildfire in the same area is often more devastating to**
16 **the ecosystem of the rangeland than the first wildfire; and**

17 WHEREAS, In addition to burning rangeland and forest which support **Livestock**
18 **grazing,** **multiple uses,** the frequent wildfires have damaged wildlife habitats,
19 including the habitat of the sage grouse, a bird whose populations have been
20 declining for years, and have caused a rise in the costs associated with wildfire

1 suppression and the rehabilitation of those public lands affected by the wildfires ~~H~~
2 ~~and repeat wildfires;~~ and

3 WHEREAS, In a 1,700-acre study conducted by researchers at the University of
4 Nevada, Reno, late-season livestock grazing was shown to reduce the amount of
5 cheatgrass, which could fuel a fire, from 500 pounds per acre to 25 pounds per acre;
6 and

7 WHEREAS, Among other options to decrease the extent and frequency of
8 wildfires occurring in Nevada, the Bureau of Land Management and the United
9 States Forest Service should partner with local agencies and other interested
10 parties and may consider partnering with the livestock industry to ~~increase~~
11 ~~determine whether the timing and intensity of increased~~ livestock grazing ~~to~~
12 ~~based on the actual condition of the rangeland and the cheatgrass fuel load~~
13 ~~would reduce the frequency of wildfires and repeat wildfires and enhance the~~
14 ~~overall condition of the~~ rangeland and forest located on public lands in this State;
15 now, therefore, be it

16 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY,
17 That the members of the 77th Session of the Nevada Legislature hereby urge the
18 Bureau of Land Management and the United States Forest Service to assist the
19 State of Nevada with the prevention and suppression of wildfires and repeat
20 wildfires in this State; and be it further

21 RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy
22 of this resolution to the Director of the Bureau of Land Management, the Chief of
23 the United States Forest Service and the President of the Nevada Cattlemen's
24 Association; and be it further

25 RESOLVED, That this resolution becomes effective upon passage.
