AN ACT relating to local governments; revising provisions governing contracting by school districts; revising provisions governing performance contracts for operating cost-savings measures; requiring the Office of Energy to provide local governments with information, educational resources and support relating to such performance contracts; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law authorizes local governments, including school districts, to enter into performance contracts for the purchase and installation of operating cost-savings measures to reduce costs related to energy, water and the disposal of waste, and related labor costs. (NRS 332.300-332.440) **Section 2** of this bill provides, ***with limited exceptions***, that before the board of trustees of a school district advertises for, requests or solicits bids or proposals for certain contracts ***for which the estimated cost exceeds \$100,000***, the board of trustees ***or its designee*** shall ***determine if evaluate whether*** the work to be performed pursuant to the contract will include ***certain*** operating cost-savings ***measure*** ***measures*** and qualifies to be performed pursuant to a performance contract. **Section 2** also requires the board of trustees to ***prepare a report setting forth its determinations and make the report available to the public***. Section 2 further requires the report to include, without limitation, the reasons why the work to be performed includes or does not include an operating cost savings measure and, if the board of trustees determines not to award a performance contract for the work, the reasons for that determination ***on the evaluation at its next regularly scheduled meeting***.

Section 3 of this bill requires the Office of Energy to: (1) provide local governments with information, educational resources and support relating to operating cost-savings measures and performance contracts; and (2) include on the Internet website maintained by the Office, if any, information and educational resources relating to operating cost-savings measures and performance contracts.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 332 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *1. Before Except as otherwise provided in subsection 3, before
4 the board of trustees of a school district advertises for, requests or solicits bids or
5 proposals for a contract relating to work to be performed on a building, for
6 which the estimated cost exceeds \$100,000, the board of trustees or its designee
7 shall:*

8 *(a) Determine if evaluate whether the work to be performed pursuant to the
9 contract:*

10 ~~(1) Will include an operating cost-savings measure; and
11 (2) Qualifies to be performed pursuant to a performance contract.~~

12 ~~(b) Prepare a report setting forth the determinations required pursuant to
13 paragraph (a); and~~

14 ~~(c) Make the report available to the public, including, without limitation, by
15 posting the report on the Internet website, if any, maintained by the school
16 district.~~

17 *2. The report prepared pursuant to paragraph (b) off If the evaluation
18 performed pursuant to subsection 1 must include, without limitation:*

19 *(a) The indicates that the work to be performed will include an operating
20 cost-savings measure and qualifies to be performed pursuant to a performance
21 contract, the board of trustees shall report on the evaluation at the next regularly
22 scheduled meeting of the board of trustees. If the board of trustees determines not
23 to award a performance contract for the work, the board of trustees shall state the
24 reasons why the work to be performed pursuant to the contract includes or does
25 not include an operating cost savings measure; and*

26 *(b) If the board of trustees determines not to award a performance contract
27 for the work, the reasons for that determination, on the record at the meeting
28 and those reasons must be included in the minutes of the meeting.*

29 *3. The provisions of this section do not apply if the board of trustees has
30 performed a comprehensive audit and assessment of all potential operating cost-
31 savings measures that might be implemented within the buildings of the school
32 district within the immediately preceding 7 years and a report of the audit and
33 assessment is available on the Internet website, if any, of the school district.*

34 *4. As used in this section, "operating cost-savings measure" means an
35 investment in equipment, products and materials, and strategies for building
36 operation, or any combination thereof, designed to reduce energy and other
37 utility expenses, including, without limitation:*

38 *(a) Costs for materials and labor required to replace old equipment with new,
39 more efficient equipment.*

40 *(b) Storm windows or doors, caulking or weather stripping, multiglazed
41 windows or doors, heat-absorbing or heat-reflective glazed or coated windows or
42 doors, reductions in glass area, and other modifications to windows and doors
43 that will reduce energy consumption.*

44 *(c) Automated or computerized energy control systems.*

45 *(d) Replacement of, or modifications to, heating, ventilation or air-
46 conditioning systems.*

47 *(e) Replacement of, or modifications to, lighting fixtures.*

1 (f) Improvements to the indoor air quality of a building that conform to all
2 requirements of an applicable building code.

3 (g) Energy recovery systems.

4 (h) Systems for combined cooling, heating and power that produce steam or
5 other forms of energy, for use primarily within the building or a complex of
6 buildings.

7 (i) Installation of, or modifications to, existing systems for daylighting,
8 including lighting control systems.

9 (j) Installation of, or modification to, technologies that use renewable or
10 alternative energy sources.

11 (k) Programs relating to building operation that reduce operating costs,
12 including, without limitation, computerized programs, training and other similar
13 activities.

14 (l) Programs for improvement of steam traps to reduce operating costs.

15 (m) Devices that reduce water consumption in buildings, for lawns and for
16 other irrigation applications.

17 (n) Trash compaction and waste minimization.

18 (o) Ground source systems for heating and cooling.

19 Sec. 3. *The Office of Energy shall:*

20 1. *Provide to local governments information, educational resources and*
21 *support relating to operating cost-savings measures and performance contracts.*

22 2. *Include on the Internet website maintained by the Office, if any,*
23 *information and educational resources relating to operating cost-savings*
24 *measures and performance contracts.*

25 Sec. 4. NRS 332.300 is hereby amended to read as follows:

26 332.300 As used in NRS 332.300 to 332.440, inclusive, ***and sections 2 and 3***
27 ***of this act,*** unless the context otherwise requires, the words and terms defined in
28 NRS 332.310 to 332.350, inclusive, have the meanings ascribed to them in those
29 sections.

30 Sec. 5. This act becomes effective on July 1, 2013.
